### Course Description:

This **Non-Language Specific**, six (6) credit hour, Instructor led course\*, will outline and familiarize the Student with Professional Interpreter protocol and terminology used in conjunction with courtroom testimony and investigations specific to Vice and Gang Investigation Units. Students will gain a broad understanding of a variety of criminal investigations, investigation specific terminology, Gang / VICE Crime lifestyles, associated terminology and the type of crime that demands presentation of specialized testimony during courtroom procedures.

This Course will be broken in to two sections with the first topic covered being gang investigation units. This topic will cover current gang terminology/phrases, lifestyle, prison organization, gang proliferation and the seemingly unending variants to gang initiation, participation and cultural diversity in today's gang environment.

The second portion of this class will cover the wide variety of "Vice" related crimes in today's society. This class will outline specific crimes involved in Vice Unit investigations and the associated terminology/phrases specific to these crimes. The class will outline in detail the specific correlation between today's street gangs and the ever present "vice crime" activity that involves prostitution, sex/labor trafficking, gambling and a myriad of other "social" crimes that affect our communities and court system. **\*Course may also be presented via webinar with "live" interactive instructor facilitated participation.**
