DuPont™ LANNATE® LV can be applied at 1.5 pt/acre when slug populations reach locally determined economic thresholds. Consult the cooperative extension service, professional consultants or other qualified authorities to determine appropriate threshold levels for treatment in your area.

#### APPLICATION

Start applications to corn when the corn reaches the 2 leaf stage. Start applications to soybean when the soybeans reach the first trifoliolate stage. Use of an adjuvant will improve coverage and performance.

Slugs primarily feed in the early evening, at night or in cool, early morning hours. Slugs are most active when weather conditions are moist and cool. It is recommended to make applications in the late afternoon through early morning or whenever slugs are actively feeding.

LANNATE® LV should be applied at 5 to 7 day intervals to maintain control. Use sufficient water to obtain thorough, uniform coverage. Since LANNATE® LV is a fast acting contact insecticide, best results follow direct spraying of the target insect.

**NOTE:**

**For Field Corn:**

Do not apply LANNATE® LV within 21 days of harvest in field corn.

Do not apply more than 2.25 pounds of methomyl (7.5 pints of LANNATE® LV) per acre per growing season.

Do not make more than a total of 5 applications of LANNATE®LV per crop.

Do not make more than two applications to corn prior to tassel push. Make one application when corn is at 1-2 leaf stage for control of early season pests; make a second application, if needed, 5-7 days later.

**For Soybeans:**

Do not apply LANNATE® LV within 14 days of harvest in soybeans.

Do not apply more than 1.35 pounds of methomyl (4.5 pints of LANNATE® LV) per acre per growing season.

Do not make more than a total of 3 applications of LANNATE®LV per crop.
