## July 16, 2018

The Town Council met July 16, 2018 at 6:00 p.m. in the Thorsby Municipal Annex Building.

## Department Heads

Chief Barnett reported they have taken all the equipment off the Dodge Chargers and will be putting them up for sale at the Town Hall.

Josh Parker with the Fire department reported that they had to people in training and that the Drill Field will be inspected to see what needed to be done for the Fire department to start having training classes there.

Josh Parker gave his concerns to the Council about the new hire for the Fire Chief and him not leaving in Thorsby.

Terry Jackson was out of Town.

Crystal Smith Town Clerk reminded the Council for the Swedish Fest tree planting at Richard Wood Park on July 26<sup>th</sup> at 6:30 p.m.

Mayor Hight recognized Mark Hamm.

Mark Hamm asked if the Town could contact someone with the Dollar General about cutting the grass.

Randolph Montoya stated he would be leaving the Fire department.

Mayor Hight reported they had the final walk through with the storm shelter on July 9<sup>th</sup> and it is ready for use if needed.

Mark Hamm asked where the storm shelter was. Mayor Hight stated it's at Sam Bentley Park, Hamm also asked would there be signs put up for the storm shelter.

Mayor Hight stated that would be a good idea and the Town could do that.
