Schedule

These will be CONCURRENT tests using a BLOCK SCHEDULE

NO RUN ORDER will be mailed out – a time block will be assigned and a run order will be created within the time block. All entries with a valid, legible email address will be sent an entry confirmation with time block. Dogs not checked it within 15 minutes of the start of their block time may be moved to a later time block.

Grounds will be available one hour prior to test hours. Test hours are 9:00AM until 4:00PM or until all runs are completed. It is also the responsibility of each entrant to be ready with catcher and releaser when their dog is called to the line. We have a limited number of volunteers; please consider asking fellow entrants to catch/release if you are coming alone.

Roll Call

Roll call is the time when participants are expected to check in. Check-in is followed by inspection for fitness, lameness, or "in season" females. Every dog must be inspected prior to EACH run. Handler will wipe female dogs. Roll call will open 15 minutes before your block is scheduled to run. If you do not check in within one hour of the event closing, we will assume you are absent. There are no refunds for absent dogs. Bitches known to be in season are not to be brought to events and entry fees will be refunded.

A flat blue ribbon for a passing qualifying run. Rosettes to dogs completing titles BCAT, DCAT or FCAT

Fast CAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program on the day of the test. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

Dogs may only run once per test. All entries must be accompanied with a check to be valid. A returned check is not a valid entry. There will be a minimum charge of \$25 for returned checks.

What is FastCAT?

1. Fast CAT is a timed straight 100-yard dash for dogs.

2. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually.

3. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).

4. Based on the dog's size at the withers a handicap is applied and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Under 12" = Handicap is 2.0.

5. FORMULA: MPH X HANDICAP = POINTS

6. Titles are earned at specific point levels BCAT = 150 points, DCAT = 500 points, FCAT = 1,000 points FCAT# = Each additional 500 points

*ACCORDING TO AKC RULES; Handlers are not permitted to run with a dog during an official run but must remain either at the start or finish area of the course. Handlers are not to allow dogs to be enticed through the course with anything other than the lure during its official run. NO mechanically devices including whistles, horns, bull horns, etc. or toys including the waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name only.

Test Information

- Dogs should be warmed up before and cooled down after running.
- ALL DOGS RUN AT OWNER'S SOLE RISK
- All entries must be 12 months of age or older on the day of the test.
- This is a rain-or-shine outdoor event. Please plan accordingly. Please bring your own shade, chairs and water. Shade tents, crates, etc. may be left over night at owner's risk.
- Kiddie pools will be available for use during the event
- An electronic timing system will be used.
- The show grounds are not completely fenced. The FAST CAT course will marked off with snow fencing.
- On-site porta-pottys with hand washing stations are available.
- Dogs must be on lead or crated unless running.
- A fine will be assessed for any loose dog on the field not competing, or an exhibitor caught not picking up after their dog.
- You are responsible for controlling your dog(s) and children.
- Any dog that eliminates on course will receive a nonqualifying (NQ) score.
- Muzzles are allowed. No pinch collars, and no electronic training collars or devices are allowed. The club recommends using a plain buckle collar and lead. No flexi leads will be allowed for safety
- Bitches in season and lame dogs will be excused and entry fees refunded.
- The Hunt master is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. He/She has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Persons exhibiting conduct detrimental to the AKC/CCDAC/DDOM/ dog(s) or person(s) will be asked to leave the test site by the Field Committee, maybe disciplined by the AKC, and **entry fees will not be refunded**.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club.
- The event-hosting club, Canine Combustion Club of SE Michigan, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

I wish to use the dog pool, training course, obstacle course, lure course, agility course, frisbee fields, and other recreational facilities and land at the Disc Dogs of Michigan facility (the "Facilities"), for and during training, private use sessions, competitions, club-related competitions and activities, lessons, leagues, and other events and times (collectively the "Events"). In using any, some or all of the Facilities for any one of more of the Events, I recognize and fully understand certain things, including:

- (a) there will be no lifeguard or other safety monitor, guard, rescue personnel, or protector on duty for any of the Facilities;
- (b) my use and my pet's use of the Facilities during Events involves certain risks, including but not limited to: the risk of injury resulting from possible malfunction of the equipment and structures at the Facilities; the risk of injuries resulting from tripping or falling over obstacles at the Facilities; the risk of injuries resulting from unsupervised pool users colliding; the risk of other injuries resulting from participating in the Events and using the Facilities.

I recognize and fully understand that the above list is not a complete or exhaustive list of all possible risks; the list only provides examples of types of risks that I am assuming for my pets and me.

In exchange for Disc Dogs of Michigan LLC allowing my pets and me to participate in Events and use the Facilities, I hereby agree to the conditions below. I fully intend and choose to give up the legal rights, as stated below:

- I. TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against Disc Dogs of Michigan LLC, its directors, officers, members, employees, agents, or representatives (hereinafter referred to as the "Releases") relating to my participation in the Events and use of the Facilities; and I will not sue any or all of the Releases for any injury or damage to person or property (including pets) arising from or in connection with participation in Events or use of the Facilities;
- 2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury, expense, or other cost that I may suffer or that my next of kin may suffer or that my pets or other property may suffer in connection with my participation in the Events and use of the Facilities due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;
- 3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability to property, or personal injury to, any third party, resulting from my participation in the adult swim sessions;
- 4. That I am over the age of 18;
- 5. That I further agree to abide by the dates and times for the Events provided by Disc Dogs of Michigan LLC.
- 6. That the only persons and pets permitted to participate in the Events and use the Facilities are over the age of 18, and are identified below.
- 7. That this Waiver, Release, and Agreement is fully effective and shall be effective and binding upon me, and my heirs, next of kin, executors, administrators, and assigns, or anyone else authorized to act on my behalf or on behalf of my estate.

I have read and understood this document. I am aware that by signing this document, I am waiving certain legal rights that I may have against the Releases, and I fully agree to do.
