Tournament Info:

Aloha Table Tennis Association (ATTA) presents its 2018 Summer Table Tennis Tournament. The first day, July 20th, ATTA will feature Junior & Senior singles events. On July 21st and 22nd, team handicap events will take place. Each team consist of three players. All events are singles.

Although this is a **non-sanctioned tournament**, USATT and ITTF rules and regulations will be followed.

Equipment:

Eight Butterfly Centrefold tables and net sets will be used with ATTA 3-star white poly 40+ balls.

No competitor shall wear white shirts or shorts/skirts during play.

Entry Deadline:

Entries must be emailed, postmarked, faxed or hand delivered by **Saturday June 30, 2018**. Late entries will be put on a wait list.

Space is limited to 48 participants in the team event so register early. Entries after 48 players will be placed on a wait list.

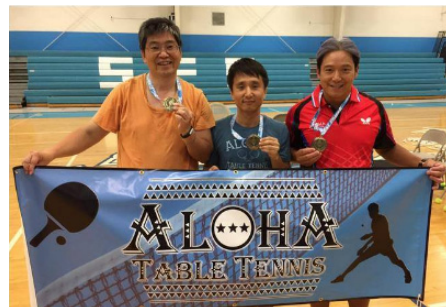

Junior (18 and under) and Senior (60 and above) Singles Event (Friday July 20, 2018):

- This is a **non-USATT** sanctioned event. Ratings for each participant must be approved by the tournament committee.
- This is an amateur Table Tennis event.
- All matches are singles and best of 5 games. Each game is to 11 points, win by two points.
- Depending on turnout, events and formats are subject to change. Participants will be notified asap of any changes.

Team Event:

- This is a **non-USATT** sanctioned event. Ratings for each participant must be approved by the tournament committee.
- This is an amateur Table Tennis event.
- All matches are singles and best of 3 games. Each game is to 11 points, win by two points.
- Maximum of 48 participants (16 maximum total teams). Entries after 48 will be placed on a wait list.
- All players will be placed in separate groupings to determine their team. All team selections will be made randomly on the first day of play.
- Each team will consist of 3 players: one player from the top third of all players entered, one player from the next third and one player from the bottom third of all players entered.
- Handicap points are given for each match depending on level of players involved.
- Each team will play in a four team group Round Robin.
- Each team match will be a best of 9 individual singles matches.

Team matches (A,B,C) vs (X,Y,Z)

Team 1

Player A is in the bottom third of roster

Player B is in the top third of roster

Player C is in the middle third of the roster

Team 2

Player X is in the middle third of the roster

Player Y is in the bottom third of roster

Player Z is in the top third of roster

Example Match play order:

#1 A (+3) vs X (-3) handicap is 3

#2 B (-5) vs Y (+5) handicap is 5

#3 C (+3) vs Z (-3) handicap is 3

#4 B (-3) vs X (+3) handicap is 3

#5 A (+5) vs Z (-5) handicap is 5

Play is continued only if necessary:

#6 C (-3) vs Y (+3) handicap is 3

#7 B vs Z handicap is 0

#8 C vs X handicap is 0

#9 A vs Y handicap is 0

Group Team Round Robin play order:

Group A Teams #1, 8, 9 and 16

Group B Teams #2, 7, 10 and 15

Group C Teams #3, 6, 11 and 14

Group D Teams #4, 5, 12 and 13

A Team # is designated by the top 16 players based on ratings used for this tournament.

Top 2 finishing teams advance to single elimination round until final team match.

All players are encouraged to support your team members. Coach each other and help each other win!

Please help keep score when your team is playing so the games can move smoothly.

Umpires are limited, so have some positive **ATTITUDE** and play fair!

Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement ("Agreement")

- 1. IN CONSIDERATION of being permitted to participate in any way at Aloha Table Tennis Association and any of their events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:
- 2. ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
- 3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
- 4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;
- 5. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE ALOHA TABLE TENNIS ASSOCIATION, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
- 6. ANY AND ALL CLAIMS, controversies or disputes arising out of or relating to this AGREEMENT, or the breach thereof, which remain unresolved after direct negotiations between the parties, SHALL FIRST BE SUBMITTED TO CONFIDENTIAL MEDIATION in accordance with the RULES, PROCEDURES, AND PROTOCOLS FOR MEDIATION OF DISPUTES OF Dispute Prevention & Resolution, Inc., then in effect. IF ANY ISSUES, CLAIMS OR DISPUTES REMAIN UNRESOLVED AFTER MEDIATION CONCLUDES, the parties AGREE TO SUBMIT ANY SUCH ISSUES TO BINDING ARBITRATION before one arbitrator in accordance with the Rules, Procedures, and Protocols for Arbitration of Disputes of Dispute Prevention & Resolution, Inc., then in effect. THE PARTIES FURTHER AGREE THAT THE AWARD OF THE ARBITRATOR(S) IS BINDING UPON THE PARTIES AND THAT JUDGEMENT UPON THE AWARD RENDERED MAY BE ENTERED IN ANY COURT OF COMPETENT JURISDICTION.
- 7. I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
- 8. I CONSENT TO HAVE MY PHOTOGRAPH (still or motion) USED FOR ANY ALOHA TABLE TENNIS ASSOCIATION MEDIA PURPOSES (including but not limited to: website, fliers, banners, new media, internet).
- 9. I UNDERSTAND THAT Aloha Table Tennis Association, owners and lessors of premises are NOT RESPONSIBLE for theft, damage, or any valuables left in vehicles on or around premises.
