Youth Participant agrees to submit an estimated budget with this Agreement to the YEAH Committee via email to amaziavet@yahoo.com and yeah@yeahofclarkcounty.org and to stay within the parameters of the submitted budget to raise the YEAH animal.

If expected costs are going to exceed the estimated budget or if the Youth Participant is having difficulty finding donations to help subsidize the project the YEAH Committee will be notified immediately by email at the addresses listed above.

Outside donations to help fund the cost of raising the YEAH animal are encouraged. If Youth Participant receives a monetary donation, Youth Participant will immediately notify the YEAH Committee via email. Youth Participant should provide the name, address and amount of the monetary donation to YEAH so that YEAH can issue a tax receipt to the donor. YEAH will also provide instructions to the Youth Participant for delivery of the funds to YEAH for accounting.

The YEAH Committee will then disburse the funds to the youth. Donor(s) and value of donated feed or supplies should also be submitted to the YEAH Committee via email. For feed expenses incurred during the project all feed receipts are required to be submitted with the feed expense sheet to receive reimbursement at the end of the project.

Youth Participant will either be a member of a 4-H club, FFA chapter, or local Grange that supports the species being raised.

Amazia Veterinary Service is the designated veterinary clinic by the YEAH Committee. Phone number for Amazia Veterinary Service is 360-892-7524. Youth Participant should call Amazia immediately if the animal requires veterinary care beyond normal needs to determine what action is to be taken. Youth Participant shall then follow up with an email to the YEAH Committee with an explanation of the care needed and resolution.

Youth Participant is encouraged to be a member of and attend at least one meeting of the YEAH Youth Council to present their project. The YEAH Youth Council meeting schedule can be obtained from Debbie O’Dell at dndodell@gmail.com.

Youth Participant agrees to notify the YEAH Committee on the progress of and any YEAH promotion of the animal at the YEAH Youth Council meetings or by note/email every thirty (30) days. Pictures are encouraged.

The YEAH Committee agrees to provide a letter of support for the Youth Participant project to support Youth Participant’s fundraising efforts.
