RESOLUTION NO: SL – 13 - 2022

TITLE: Release of \$20,000.00 from Fund 157 American Rescue Plan Act (ARPA) to continue implementation of Rental and Utility Assistance for Tribal Members

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statute 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

WHEREAS, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and

WHEREAS, On March 11, 2021, the President signed the American Rescue Plan Act of 2021 (ARP) (Public Law 117-2), which invests \$1.75 billion in American Indian and Alaska Native government programs administered under the oversight of the Department of the Interior's Assistant Secretary – Indian Affairs (AS-IA); and,

WHEREAS, Summit Lake Paiute Tribe was awarded \$3,436,199.68 to aid tribal government services, public safety and justice, social services, child welfare assistance, and other related expenses; and,

WHEREAS, Summit Lake Paiute Tribal council releases \$20,000.00 under Fund 157 US Department of the Treasury's American Rescue Plan Act (ARPA) to continue the implementation of Emergency Rental and Utility Assistance administer by the Housing Department for eligible households impacted by COVID-19; and,

WHEREAS, the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe and Tribal Members to continue Rental and Utility Assistance in response to the fight of COVID-19; and

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, approves the release of \$20,000 under Fund 157 to continue the implementation of Emergency Rental and Utility Assistance.
