AFFIDAVIT OF BEVERLY OWENS BRACE

My name is Beverly Owens Brace. I am making this affidavit in support of Defendants Robert Brace and Robert Brace Farms, Inc. in the above referenced matter.

I am seventy-nine (79) years of age, currently retired, and reside at 1131 Route 97, Post Office Box 338, Waterford, Pennsylvania, 16441.

I previously worked for the Brace family farming business in Waterford, Pennsylvania in the packing shed packing potatoes and cabbage for several years when I was young, but without compensation. My role in this family business during the past fifty years has mostly been a role of providing support to the farmers in my family. Foremost, I have been a wife, a mother, a grandmother, and a great grandmother. (Ex. 1 Beverly Brace Depo 1-11-18 at pp. 18-25).

In this role, I have supported my husband, Robert Brace, in part, by accompanying him to each of the 2017 and 2018 depositions convened during the pre-trial discovery period of this case.

I particularly recall accompanying my husband to the deposition of former United States

Department of Agriculture Soil Conservation Service representative Lewis Steckler on November

30, 2017, which had been convened at the downtown offices of our local Erie, Pennsylvania law firm, Knox, McGlaughlin Gornall & Sennett, P.C.

Prior to the start of the deposition scheduled for approximately 1:00 p.m., I recall observing Mr. Steckler enter the conference room wearing a hat (baseball cap) bearing the name and logo of Ducks Unlimited. Although I do not recall what specific logo appeared on that hat since there are many different logos of that organization (Ex. 2 Ducks Unlimited Hats on EBay), I also recall Mr. Steckler leaving the conference at the completion of the deposition wearing the same hat bearing the name and logo of Ducks Unlimited.

I also particularly recall accompanying my husband to the deposition of former U.S. Fish and Wildlife Service representative David Putnam on January 26, 2018, which had been convened at the Hampton Inn Harrisburg East in Harrisburg Pennsylvania commencing at approximately 9:00 a.m. I recall during the deposition that Mr. Putnam stated he had been a member of Ducks Unlimited for a period of probably ten (10) years during his employment with the agency, including during the time that he and other United States officials at the Fish and Wildlife Service and other federal agencies had accused my husband of violating the Clean Water Act wetlands rules. (Ex. 3 David Putnam Depo 1-26-18 at 156). I also recall that Mr. Putnam stated that he had a hat that said Ducks Unlimited that he wore to work sometimes. (Ex. 3 David Putnam Depo 1-26-18 at 159). Furthermore, I recall that Mr. Putnam showed us one of his Ducks Unlimited hats at his truck in the parking lot after the completion of his deposition and during our lunch break.

I did not realize at the time of these depositions the significance of both federal government witness' affiliation with or partiality towards the Ducks Unlimited organization. However, since these depositions, I have come to learn of the significant financial and law enforcement

relationship Ducks Unlimited has had with these two federal government agencies since the 1980's, and how such relationship has negatively affected our family farming business.

I declare that, to the best of my knowledge and belief, the information herein is true, correct and complete.
