# 40 YEAR! AGO

The idea for establishing YAS began in 1975, as a movement among several foster parents who felt that youth in Franklin County were not receiving the best possible care through facilities that were available at the time. Their concerns, along with those of the Women's Resource and Policy Development Center, led to a demonstration project in 1976. The focus of the project was to attract highly-qualified foster parents, equip them to deal with teens and their individual challenges by providing ongoing education and support, and build strong relationships among families.

The first network of 10 foster homes was selected from the Clintonville area in 1977 and the first youth was placed in February, 1978. In addition to full-time care, the foster parents - called "advocates" - offered counseling, tutoring, behavior management, job placement, community education, social activities, life enrichment groups, and family reunification support to youth in their care.

**Developed Early Start and** Help Me Grow programs.

On October 10th of 1978, YAS was officially recognized as a foster care agency. Due to the effective and innovative services provided, YAS continued to grow and add programs in the years that followed: Early Start and Help Me Grow (now known as Ohio Early Intervention and Ohio Healthy Families America under the Early Childhood umbrella) in the late 1990s and Respite Care in the mid-2000s.

In 2007, YAS was successfully accredited by the Council on Accreditation (COA), a national body that accredits human services organizations that can meet its high standards. Because of this accreditation, the agency was able to provide foster care and counseling services, case management, and psychiatric care.

YAS was certified by the Ohio Department of Mental Health (now the Ohio Department of Mental Health and Addiction Services) in 2008 and began offering home-based and school-based Mental Health Services (now Community-based Behavioral Health) funded by Medicaid. Most recently in December of 2018, YAS became a Healthy Families America accredited site which has allowed YAS to serve our Early Childhood clients in the best way possible.

EARLY CHILDHOOD

The Early Childhood (EC) program, previously referred to as Help Me Grow, is designed to ensure Ohio's children receive a healthy birth and the resources to warrant a healthy and productive start in life. An integral part of Ohio's prenatal to age three system of supports, the services offered by EC equip parents with the means to help their child acquire the early building blocks necessary for long term success. These initial achievements last a lifetime, as scientific evidence strongly suggests that a child's success is significantly determined by the quality of nurturing in the first three years of life. EC encompasses two components: Ohio Early Intervention and Ohio Healthy Families America.

### **OHIO EARLY INTERVENTION**

Provides access/coordination of evaluation and developmental services for children ages 0-3 with a developmental delay or disability.


#### **OHIO HEALTHY FAMILIES AMERICA**



YAS provides both Traditional and Therapeutic Foster Care services in and around the central Ohio region, with over 50 highly qualified Foster Homes in our network. As the oldest Therapeutic Foster Care program in Ohio, YAS has provided high-quality treatment foster care since 1978. Our team works collaboratively with other child serving agencies to develop and implement a strong community support system for families. Currently, YAS serves and supports foster children in 10 Ohio counties: Butler, Fairfield, Franklin, Greene, Hamilton, Knox, Licking,

Morrow, Mahoning, and Union. CARE



### ADOPTION SUPPORT SERVICES

Pre- and Post-Adoption Support Services offer individual and family therapy and clinical case management designed to meet the needs of children and youth who will be adopted, or have been adopted from the foster care system. A contract-for-services is available for children and youth adopted privately.

YAS also supports those who are interested in adopting through the Foster Care System by providing the necessary parent training to prepare them for adoption as well as providing a thorough adoption home study.

#### **COMMUNITY RESPITE**

YAS provides respite to at-risk families in the community through our Family Foster Homes as well as our Therapeutic/Treatment Homes.

Community Respite Services are designed to provide families/caregivers a safe place in the community that offers relief during difficult times, including emergency situations. The goal of our Respite Program is to prevent children from being placed in foster care or another higher level of care.

# BEHAVIO HEALTH

Through our team of licensed professionals, YAS provides the highest quality of Community Based Behavioral Health Services. These services, offered in Franklin County, are delivered in outpatient settings, including children's and their family's natural environments such as their home, substitute care setting, school, and community.

YAS currently collaborates with, and has a presence in, over 61 Franklin County Schools. Referrals to our Behavioral Health Services often arise out of behavior management issues in the classroom as well as other needs that present when children acclimate to school and other life stressors.

The overarching philosophy of YAS' Community Based Behavioral Health Program is to promote the recovery and resiliency of persons with behavioral challenges or mental health issues through prevention, education, and support services. The goal is to assist the client in developing skills that promote socially appropriate functioning in family, community, and academic settings, following the recovery model of healing.

We provide easy access to faster, simpler, effective and more comprehensive behavioral health care by having in-agency psychiatric services, including medication management.
