### WELCOME BY MAYOR

At 6:00 P.M., Mayor Taylor led the gathering in the Pledge of Allegiance to open the meeting.

Mayor Taylor recognized the Newark Reds Varsity Softball Team for being Section V, Class B1, champions.

Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to approve the following minutes:

#### CONSENT AGENDA

Motion Trustee Blodgett, seconded Trustee Burgess and carried unanimously to approve the July vouchers and invoices Trustee Howard reviewed for reasonableness and which were submitted for payment approval. Payments totaling \$1,127,773.63 were authorized for all funds.

The Board thanked the department heads for their monthly reports.

### PUBLIC HEAR-ING

At 6:11P.M. the meeting went into a public hearing to discuss the New York Main Street Grant. Chris and Toni Avery from 116 Church Street expressed their concern over the Village of Newark's choice to have Terry DeVries as the LPA for the project. The Village Board assured them that there were multiple people working on the project and every person and business submitting a project would be treated fair and equitable. #### CHIEF CHUCK WITT

Motion Trustee Howard, seconded Trustee Bendix and carried unanimously to approve Lu Engineers proposal for the Village of Newark's Pretreatment Program. Engineering services will be charged on an hourly basis not to exceed \$13,300.00.

Tabled any action on accepting dedication of Garfield St. and Adams Street. Attorney Williams will send a letter to the owners requesting that the road be brought up to Village standard before accepting dedication.

Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to approve the following resolution of support & authorization for the Village of Newark 2021 New York State Consolidated Funding Application, Local Waterfront Revitalization Program – Planning Preparation.

WHEREAS, Village of Newark, Wayne County, supports the submission of a 2021 Consolidated Funding Application (CFA) on behalf of the Village, for the Local Waterfront Revitalization Program (LWRP) for the preparation of a plan to develop public and private development along the Erie canal; and

**WHEREAS**, the New York State Department of State (DOS), is soliciting applications through the CFA from eligible Villages along New York's designated inland waterways to advance the preparation of strategies for community and waterfront revitalization; and

**WHEREAS**, the Village of Newark is home to approximately 10,000 residents who live within 5.4 square miles, with The Erie Canal flowing through its center, providing a unique avenue for travel as well as recreation events; and

**WHEREAS**, if funding is received it will allow the Village of Newark to prepare a Local Waterfront Revitalization plan for the Village's Erie Canal development district to for public and private development along the Erie Canal waterfront in downtown Newark with sound revitalization strategies;

**NOW THEREFORE BE IT RESOLVED,** the Village Board, on behalf of the Village, identifies the Village Mayor as the authorized representative for the project, able to execute necessary documents relative to and as required for this application; and

**BE IT FURTHER RESOLVED,** the Village Board does hereby authorize and obligates local matching funds of the minimum 25% of the total of any grant funding awarded in the form of in-kind services or cash contribution hereby appropriated from the general fund; and

**BE IT FURTHER RESOLVED,** that the Village of Newark, recognizes and fully supports the submission of the 2021 CFA for the preparation of a Local Waterfront Revitalization Program for its Erie Canal development district.

Motion Trustee Blodgett, seconded Trustee Burgess and carried unanimously to approve the following SEQR Resolution – Type II Action for the 2021 CFA: Local Waterfront Revitalization Program.

WHEREAS, the Village of Newark Village Board, (hereinafter referred to as Village Board) is completing an application through the New York State Consolidated Funding Application (CFA) under New York State Department of State (DOS), for the preparation of a Local Waterfront Revitalization Plan; and

**NOW, THEREFORE, BE IT RESOLVED THAT**, the Village Board does hereby classify the above referenced Action to be a Type II Action under 6 N.Y.C.R.R. Section 617.5 [c] [27] of the State Environmental Quality Review (SEQR) Regulations; and

**BE IT FURTHER RESOLVED THAT,** Type II Actions are not subject to further review under Part 617 of the SEQR Regulations; and

**BE IT FINALLY RESOLVED THAT**, the Village Board in making this classification has satisfied the procedural requirements under SEQR and directs this Resolution to be placed in the file on this Action.

Motion Trustee Bendix, seconded Trustee Howard and carried unanimously to approve the following resolution of support from the Village of Newark for the 2021 New York State Consolidated Funding Application, Water Quality Improvement Project Wastewater Treatment Disinfection Improvements.

**WHEREAS**, the Board of Trustees for the Village of Newark, located in Wayne County, supports the submission of a 2021 Consolidated Funding Application (CFA) on behalf of the Village, for the Water Quality Improvement Project (WQIP) program for disinfection upgrades to the wastewater treatment facility; and

**WHEREAS**, the New York State Department of Environmental Conservation (DEC) provides a competitive statewide reimbursement grant program for local governments, administered to directly address documented water quality impairments; and

WHEREAS, recent modifications to the Village's State Pollutant Discharge Elimination System (SDPES) Discharge Permit added an effluent disinfection requirement and included a schedule of compliance for

implementing an effluent disinfection process at the Village's Waste Water Treatment Plant (WWTP) located along 321 Murray Street; and

WHEREAS, findings in the Preliminary Engineering Report found ultraviolet disinfection to be the most cost effective means to implement effluent disinfection at the WWTP and recommended a capital improvements project which included the installation of ultraviolet disinfection tanks and equipment;

**NOW THEREFORE BE IT RESOLVED,** it is anticipated that the Village Board, on behalf of the Village, will complete the necessary actions to authorize expenditures for the proposed project, as well as authorizes Village Mayor to execute necessary documents relative to and as required for the application; and

**BE IT FURTHER RESOLVED**, the Village Board does hereby accept that they shall provide at least 25% match of the total of any grant funding awarded, as a local match are hereby appropriated in the form of in-kind services, cash contributions and obligated from secured EFC Financing; and

**BE IT FURTHER RESOLVED,** that the Board of Trustees for the Village of Newark, located in Wayne County, recognizes and fully supports the submission of the 2021 CFA for WQIP on behalf of the Village for improvements to the wastewater treatment plant.

Motion Trustee Howard, seconded Trustee Burgess and carried unanimously to approve the following resolution of support from the Village of Newark for the 2021 New York State Consolidated Funding Application, Community Development Block Grant Application – Public Infrastructure.

WHEREAS, Village of Newark, Wayne County, supports the submission of a 2021 Consolidated Funding Application (CFA) on behalf of the Village, for a Community Development Block Grant program under the Public Infrastructure category to address a public works stormwater culvert replacement project in jeopardy of collapse, serving a significant portion of the community that without near term intervention, the section of concrete culvert may fail, creating additional hazards to the transportation network, as well as reducing the effectiveness of stormwater management in the affected area; and

WHEREAS, in accordance with New York State's 2016-2020 Consolidated Plan and its 2020 Annual Action Plan as proposed, the Office of Community Renewal (OCR) invites eligible applicants to apply for Community Development Block Grant (NYS CDBG) funding to undertake activities that focus on community development needs; and

**WHEREAS**, The Village of Newark is familiar with all NYS CDBG applicable guidelines and requirements, proposing a project that meets active compliance of both the Primary and National Objectives, the need for the activity, as well as overall impact on the community; and

WHEREAS, if funding is received it will allow the Village of Newark to prepare a preliminary engineering report to address public works projects in areas previously unserved that are in compliance with the NYS Smart Growth Public Infrastructure Act benefiting a low to moderate income neighborhood;

**NOW THEREFORE BE IT RESOLVED,** the Village Board, on behalf of the Village, identifies Mayor Jonathan Taylor as the authorized representative for the project, able to execute necessary documents relative to and as required; and

**BE IT FURTHER RESOLVED,** the Village Board does hereby authorize and obligates local matching funds of the minimum 5% of the total of any grant funding awarded in the form of in-kind services or cash contribution hereby appropriated from the Village's General Fund budget line; and

**BE IT FURTHER RESOLVED,** that the Village of Newark, recognizes and fully supports the submission of the 2021 CDBG application for Public Infrastructure pertaining to the Village's effective storm water management.

Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to approve the following SEQR Resolution – Type II Action for the 2021 Community Block Grant.

WHEREAS, the Village of Newark plans to replace a deteriorated culvert carrying Blue Cut Road over an unnamed tributary using a precast concrete box culvert along the same alignments as the deteriorated culvert; and

**WHEREAS,** the new culvert will carry two existing travel lanes and new sidewalk across the tributary, and the existing water main will be horizontally drilled under the stream; and

WHEREAS, this action constitutes "maintenance or repair involving no substantial changes in an existing structure or facility;" and "replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building, energy, or fire codes unless such action meets or exceeds any of the thresholds in section 617.4 of this Part" which under the New York State Environmental Quality Review (SEQR) Act are listed as Type II actions for which it has been determined there are no significant ad-

verse effects on the environment;

**NOW, THEREFORE, BE IT RESOLVED THAT**, the Village Board does hereby classify the above-referenced action to be a Type II Action under 6 N.Y.C.R.R. Section 617.5 [c] [1] [2] of the State Environmental Quality Review (SEQR) Regulations; and

**BE IT FURTHER RESOLVED THAT,** Type II Actions are not subject to further review under Part 617 of the SEQR Regulations; and

**BE IT FINALLY RESOLVED THAT**, the Village Board in making this classification has satisfied the procedural requirements under SEQR and directs this Resolution to be placed in the file on this Action.

Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to approve the Petition Relief request from John Murphy at 123 Grant Street after a pipe burst.

Motion Trustee Bendix, seconded Trustee Howard and carried unanimously to approve the Village staff and Board members to attend 15<sup>th</sup> Annual Police & Fire Seminar held on August 26, 2021 held in Endicott, N.Y. at no cost to the Village. Staff will be reimbursed for mileage, no overtime will be incurred. Staff is welcome to golf at their own expense.

Discussion occurred regarding the Erie Canalway IMPACT grant. The grant will buy Anti-graffiti coating and lighting, not to exceed \$1,500.00.

Proposal for MRB tabled until the Village receives requested information.
