Grant Terms and Conditions

- Completed applications must be *received* by the Coeur d'Alene Garden Club no later than the day of the Garden Tour (**June 29, 2025**) to be considered. There is *NO GUARANTEE* that funds will be available for the grant process and no guarantee that any applicant will receive a grant. Applicants receiving an award will be notified in September 2025.
- Grants are awarded after the Garden Tour. Disbursements of grant awards are typically made during a regular meeting of the Coeur d'Alene Garden Club and grantees are encouraged to attend.
- Grantee must notify the Coeur d'Alene Garden Club of any change in status or ability to use the grant's funds for the purpose stated in the grant application.
- Grantee certifies that there is no conflict of interest with this application and the Coeur d'Alene Garden Club.
- Any unused portion of the grant funding must be returned to the Coeur d'Alene Garden Club upon completion of the grant term. (Unless otherwise stated, the grant term is one (1) year following the date of receipt of the grant funds.)
- Grantees are expected to acknowledge support from the Coeur d'Alene Garden Club in all publicity, exhibitions, or publications regarding the project for which the grant is received.
- The grantee will promptly provide such additional information, reports, or documents as Coeur d'Alene Garden Club may request in connection with this grant. Coeur d'Alene Garden Club reserves the right to inspect all projects at any time during the grant cycle.
- Coeur d'Alene Garden Club reserves the right to terminate this grant should, in the sole discretion of the Coeur d'Alene Garden Club, the Grantee fail to comply with the terms and conditions of this agreement. Upon termination, all unused funds will be returned by the grantee to the Coeur d'Alene Garden Club.
