

CURRICULUM VITAE (CV)

LIM JIT KIONG graduated with a Bachelor of Laws degree with honours (second class upper division) from the University of Malaya in 1998 on a Skrine & Co. scholarship. Upon obtaining his law degree, Jit Kiong read in chambers at Skrine & Co. and was admitted as an Advocate & Solicitor of the High Court of Malaya in March 1999. Thereafter, Jit Kiong pursued his postgraduate studies at the prestigious National University of Singapore in which he graduated with a Master of Laws degree in August 2000. He is also a Registered Trade Mark Agent in Malaysia.

He has more than 25 years of experience as an Advocate & Solicitor and has represented clients including international and local banks, multi-national corporations, public-listed companies, private limited companies and prominent individuals in arbitration and at all levels of the courts including the apex court, the Federal Court. Many of the cases which he won were reported in the law journals.

Jit Kiong has worked together with a renowned retired Federal Court Judge the late Dato' Seri Gopal Sri Ram in several complicated disputes involving claims exceeding hundreds of million ringgit, one of which involved the Federal and State Governments.

He recently made history for handling the first cyberlaw case at the Kuala Lumpur High Court in which he successfully obtained an interim injunction to restrain the defendants from further publishing defamatory statements against the plaintiff on Instagram. He is currently handling several cyberlaw cases relating to online publications on Facebook, WhatsApp and Instagram.

In one of Jit Kiong's recent cases which was reported in the Malayan Law Journal as [2019] 6 MLJ 439, he successfully argued at the Court of Appeal in which the appellate court reversed the judgment of the High Court in a claim for negligence involving by a customer against a well-known slimming centre. This case was subsequently upheld by the apex court, the Federal Court.

His name was also widely reported in the media (Malaysiakini, Malay Mail Online) in the trial of a public interest suit in which he successfully defended a committee member of a well-known NGO at the High Court, Court of Appeal and the apex court, the Federal Court. The Court of Appeal decision was reported in the Current Law Journal as [2016] 8 CLJ 330.

Jit Kiong had successfully argued and won a complicated land dispute involving a lienholder's caveat at the Court of Appeal reported as [2010] 3 CLJ 45 which decision was subsequently upheld by the Federal Court.

He is well-sought after as lead counsel for firms of solicitors for complex and complicated disputes. He has served as a member of the Bar Council Court Liaison Committee. He used to speak regularly on the topic of litigation at a major bank's national training centre. He has also spoken on the areas of contract and commercial laws at Institut Tadbiran Awam Negara (INTAN).
