Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to authorize the Mayor to sign EC-C0 #05 for the WWTP Capital Project for the amended amount of \$2,103.58. The proposal for the Carbon Monoxide Detectors for \$7,292.66 was removed.

Motion Trustee Blodgett, seconded Trustee Werts and carried unanimously to authorize the Mayor to sign GC-CO #11 for \$946.19 for the WWTP Capital Project.

Motion Trustee Bendix, seconded Trustee Werts and carried unanimously to authorize the Mayor to sign HVAC-CO #02 for \$1,107.66 for the WWTP Capital Project.

Motion Trustee Schober, seconded Trustee Werts and carried unanimously to a change in our SOP for billing for Water Shut Off and Water Turn On fees for work done after regularly scheduled work hours in non-emergency situations. If someone calls in advance and wants to schedule their water to be shut off and turned on outside of our regular working hours, they will be charged two hours of the overtime rate for the DPW worker utilized to do the work. This means before 6:30 AM and after 3:00 PM on regularly scheduled work days and all day Saturday, Sunday, and DPW holidays where they are not scheduled to work. The fee will remain \$20.00 for call in situations for legitimate emergencies.

The proposal to consider the disposition of Village property that consists of the paper street Cozzens St. was tabled. Mr. Peake and Mr. Murawski are to investigate if the proposed addition by the owner of 200 Fair St. is even a possibility when considering easements and other issues.

The Board tabled any decision on the Nixle Emergency Notification System proposal until the Newark Central School District completes their survey of its notification systems' users. The survey will ask what types of notifications they are looking to receive to see if the results warrant further action on the Village implementing their own system.

Motion Trustee Bendix, seconded Trustee Werts and carried unanimously to submit a grant application to the NYS DOT Bridge NY program for culvert repairs on W. Union St. and Blue Cut Rd.

The Board scheduled a Workshop Board meeting for 4:30 P.M. on August 16, 2016 to meet with the RealTerm Energy street light replacement project representative on their proposal.

Motion Trustee Blodgett, seconded Trustee Bendix and carried unani-

mously to approve Mike Gonzalez and Mike Bouwens to attend the FLWWC Summer meeting on August 11, 2016 at Dewey's Party House at a total cost of \$75.00.

Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to declare surplus the 2011 Crown Victoria, VIN 131624, and to dispose of at FMV.

Motion Trustee Bendix, seconded Trustee Schober and carried unanimously to accept the bid of \$26,811.69 from Van Bortle Ford, Inc. to purchase a new 2016 Ford Taurus Sedan.

Motion Trustee Blodgett, seconded Trustee Werts and carried unanimously to accept the bond offer from Lyons National Bank to borrow \$500,000.00 for ten years at an interest rate of 3.50% to fund the prioritized list of additional paving during the summer 2016.

Motion Trustee Blodgett, seconded Trustee Schober and carried unanimously to authorize the rental of Colburn Park on July 24, 2016 at a cost of \$250.00 by the "14 and under Rochester Rough Riders" Baseball team for a baseball double header. The team will pay for the necessary umpires, announcer and scorekeeper.

Motion Trustee Blodgett, seconded Trustee Bendix and carried unanimously to accept the proposal by Green Renewable, Inc. to grind brush at the Vienna St. site for two days at a cost of \$2,500.00

Motion Trustee Bendix, seconded Trustee Werts and carried unanimously to authorize Doug Townsend and one other person to attend the NYS DOT Region 4 GIS-Local Highway Inventory (LHI) informational presentation on July 28, 2016.

Motion Trustee Blodgett, seconded Trustee Bendix and carried unanimously to approve the template Sludge Hauling agreement, along with the pricing schedule, to be used by the Village with all users of our WWTP system, with the term of agreement time being changed from five (5) to three (3) years.
