TOWN OF GREENWOOD MINUTES OF THE WORK SESSION OF THE MAYOR AND BOARD OF ALDERMEN

Thursday, August 11, 2022 -6:00 PM

Present: Mayor Pro Temp Brad Edwardes, Alderman Davis, Robinson, Larson, Town Attorney Jennifer McKay, Town Clerk Veronica Brown, and members of the public.

Absent:, Alderman Doughty, Police Chief Shayne Gibson and Mayor Frank

There was a quorum

Mayor Pro Temp Edwardes called the meeting to order at 6:00 p m, he then led the invocation and Pledge of Allegiance.

Staff Reports:

Town Clerk, Veronica Brown- 1) Advised the town received a State Appropriation for \$200,000 for venue enhancements 2) updated Census report was received however, the official population of the town for 2022 remained the same at 3,261 residents 3) advised the town won a grant award for \$3,000 from the Shreveport Bossier Convention and Tourist Bureau for entertainment at the GLOW and festival in September 4) advised that the town was awarded \$13,710 for marketing purposes for the GLOW and festival in September

Chief of Police Department, Shayne Gibson was not present but, Mayor Pro Temp Brad Edwardes advised 1) that there were no use of force incidents in the month of July 2) New Officer Robert Hopkins started in the Police Dept on August 6th 3)National Night Out will be held on October 4th and any one wishing to participate should contact the police dept

Town Attorney Jennifer McKay gave a legal update on the two Resolutions that were being considered on the Agenda and gave an update on Property Standards

Mayor Pro Temp, Brad Edwardes gave update/information on the following issues: 1) Veteran's Memorial Wall Dedication to be held on September 10th 2) Code Enforcement has cleaned up several properties and a majority of the properties that are not maintained are vacant 3) Mayor's Court was cancelled due to COVID outbreak at townhall 4) GLOW and Pioneer Festival to be held on September 16th & 17th, the Pancake Breakfast on the 17th will be held at the Pioneer Building in the park but the other festivities will be held at the new venue (see official Minutes Book for more detail)

Public Comments on Agenda Items: the Mayor Pro Temp invited David Yeates, Water Consultant to give an update on the water issues and allowed Public Comments at this time. Prudy Coleman, Eric Aple & Debbie Edwards had questions for the consultant on the brown water issues and for the town administration on the Notice of Violation which was recently received from LDH
