March Meeting Notes (just a few)

This is a new section for the newsletter, each month the Newsletter will be published after the regular monthly meeting. This will allow us to share information that came up during the meeting with all of the association members. Information brought to the floor from our member agencies and associations will be in their respective newsletter sections.

NJMVC Driver Examination and/or Medical Evaluation Request

A member inquired about the possibility of receiving feedback from MVC on a driver's status once a request form has been submitted to them. They have not received anything back from MVC after sending in Evaluation Requests.

DHTS Director Heitmann reached out to MVC the day after our meeting. MVC advised him that their normal practice is to provide the reporting officer with follow-up results. However, due to vacancies on their Medical Review Board, the average turnaround time is lengthy. In some complex cases, it may take a year or longer to reach an outcome.

Low-Speed Motorcycles

Officer O'Halloran from Nutley PD raised an issue about Low-Speed Motorcycles and the restrictions of operating them on roadways with speed limits of 35 mph, but no supporting Title 39 statutes to enforce it.

He passed along that the NJ Driver's Manual states they are less than 50 cubic centimeters (cc) or have a 1.5 brake horsepower motor or less with a maximum speed no more than 35 miles per hour on a flat surface. Low-speed motorcycles may not be driven on any state toll road, limited-access highway, or any public road with a posted speed limit greater than 35 miles per hour. Low-speed motorcycles must be titled, registered, and insured. Basic auto license holders can operate a low-speed motorcycle without any endorsement or separate motorcycle license.

A discussion commenced after he presented the question of what Title 39 Statute should be used to enforce the restrictions? He has searched the Title and could not find anything, nor is it described in the definitions chapter. The board will be researching this question. If anyone can provide input on this matter, please contact us directly or use traffic@njptoa.org to send information.

RADAR Unit & Tuning Fork Certification

A question was asked if a company offered remote service to calibrate and certify RADAR units on-site at a police station.

Two companies can provide RADAR unit calibration and certifications here in New Jersey. They are R & R Radar & Video in Atco NJ and TMDE Calibration Labs out of Richmond ME. TMDE has mobile service vans that will come to your agency to provide their services on-site; they are regularly in NJ. R&R provides the services at their facility in Atco, but they do not offer remote service. Both companies also offer tuning fork testing and certification. Below are the websites for each company:

Continuation - Registering Honda Talons in NJ in Violation of Title 39

Mark Wilson, Operations Sectary, raised a question during the February meeting about NJ residents registering Honda Talons in Montana and driving them on the public roads and highways here in Jersey.

The discussion continued this month. Mark had sent a request to NJ MVC for clarification on this issue.

The problem

The Montana ATV crowd is hanging their hat on the NJ reciprocity statute and the Title 39 definition of an ATV (600cc or less). Their stance is that since their engines are over 600cc, the NJ ATV restrictions do not apply, thereby making them a vehicle.

NJSA 39:3-6.21. Reciprocity reads as follows:

After July 1, 1995, if no agreement, arrangement, or declaration is in effect with respect to another jurisdiction as authorized by this act, any vehicle properly registered or licensed in such other jurisdiction, and for which evidence of compliance is supplied, shall receive, when operated in this State, the same exemptions, benefits, and privileges granted by such other jurisdiction to vehicles properly registered in this State. Reciprocity extended under this section shall apply to commercial vehicles only when engaged exclusively in interstate commerce, except as to a foreign registered trailer or semi-trailer in intrastate commerce when hauled by a truck, road tractor, or truck tractor registered with the director in conformity with R.S.39:3-20. L.1995,c.157,s.31.

Before taking any enforcement actions, the association recommends addressing this issue with your local and/or county prosecutor.

Response from NJ MVC

Emily Armstrong from MVC's Legal and Regulatory Affairs unit responded to the association's request for clarification. Please note, however, that the MVC does not and cannot provide legal advice for enforcement purposes.

Below is her reply.

Your question concerns the proper registration and operation of Honda Talons in New Jersey. Apparently, there are individuals operating Honda Talons in New Jersey with Montana registrations; Montana has registered the Honda Talons as "automobiles." There is also an individual promoting the idea online that if brake lights and turn signals are added to the vehicle, the vehicle can be legally operated on the public roadways. Based upon the information you provided, we can offer the following guidance. Please note, however, that the MVC does not and cannot provide legal advice with respect to requests 2 and 3.

Your request is as follows:

"We are looking for a written determination from NJMVC that we can distribute to our membership that will confirm:

- 1. These vehicles are not registerable under state and federal laws as "automobiles."
- 2. Any vehicle displaying Montana registrations on these vehicles are in violation of N.J.S. 39:3-15 and N.J.S. 39:3C-3.
- 3. These vehicles cannot be operated except under the authority of N.J.S. 39:3C-1 to 39:3C-34"

MVC response:

NJ PTOA request no. 1: "These vehicles are not registerable under state and federal laws as 'automobiles."

MVC response: The Honda Talon must be registered in New Jersey as an ATV. An ATV is defined in New Jersey as:

"a motor vehicle, designed and manufactured for off-road use only, of a type possessing between three and six nonhighway tires, but shall not include golf carts or an all-terrain vehicle operated by an employee or agent of the State, a county, a municipality, or a fire district, or a member of an emergency service organization or an emergency medical technician which is used while in the performance of the employee's, agent's, member's or technician's official duties." (N.J.S.A. 39:3C-1)

While there are federal laws on the manufacture and distribution of ATVs, we could not locate any federal law mandating how these vehicles are to be registered by the individual states.

<u>NJ PTOA request no.'s 2 and 3</u>: "Any vehicle displaying Montana registrations on these vehicles are in violation of N.J.S. 39:3-15 and N.J.S. 39:3C-3," and "These vehicles cannot be operated except under the authority of N.J.S. 39:3C-1 to 39:3C-34."

<u>MVC response</u> (guidance only; the MVC cannot provide direction on the issuance of summonses or how a court will determine if a violation has occurred):

An ATV displaying a Montana registration may be operated in New Jersey by a nonresident but only as permitted by New Jersey law and only as an ATV.

When New Jersey registration is required: New Jersey <u>residents</u> are required to register vehicles owned by them in New Jersey: "Except as hereinafter provided, every resident of this State and every nonresident whose automobile or motorcycle shall be driven in this State shall, before using the vehicle on the public highways, register the same, and an automobile or motorcycle shall not be driven unless so registered." N.J.S.A. 39:3-4.

Operation of a vehicle registered in another state, by a nonresident: A <u>nonresident</u> is permitted to operate a vehicle properly registered in another state. However, no one, resident or nonresident, is authorized to operate an ATV in New Jersey contrary to New Jersey law. N.J.S.A. 39:3C-7 states:

"The registration provisions of P.L.1973, c.307 (C.39:3C-1et seq.) shall not apply to nonresident owners who have complied with the registration and licensing laws of the state or country of residence, provided that the snowmobile, all-terrain vehicle, or dirt bike is appropriately identified in accordance with the laws of the state or country of residence and conspicuously displays the number issued by the state or country of residence. Nothing in this section shall be construed to authorize the operation of any snowmobile, all-terrain vehicle, or dirt bike contrary to the provisions of P.L.1973, c.307 (C.39:3C-1et seq.)."

Operation of ATVs in New Jersey is limited to the crossing of public highways or gaining access to permissible areas of operation. N.J.S.A. 39:3C-17 provides:

- "a. No person shall operate a snowmobile, all-terrain vehicle, or dirt bike upon limited access highways or within the right-of-way limits thereof.
- b. No person shall operate a snowmobile, all-terrain vehicle, or dirt bike upon the main traveled portion or the plowed snowbanks of any public street or highway or within the right-of-way limits thereof except as follows:
- (1) Properly registered snowmobiles, all-terrain vehicles, and dirt bikes may cross, as directly as possible, public streets or highways, except limited access highways, provided that such crossing can be made in safety and that it does not interfere with the free movement of vehicular traffic approaching from either direction on the public street or highway. Prior to making any such crossing, the operator shall bring the snowmobile, all-terrain vehicle, or dirt bike to a complete stop. It shall be the responsibility of the operator of a snowmobile, all-terrain vehicle, or dirt bike to yield the right-of-way to all vehicular traffic upon any public street or highway before crossing the public street or highway.
- (2) Whenever it is impracticable to gain immediate access to an area adjacent to a public highway where a snowmobile, all-terrain vehicle, or dirt bike is to be operated, the snowmobile, all-terrain vehicle, or dirt bike may be operated adjacent and parallel to the public highway for the purpose of gaining access to the area of operation. This subsection shall apply to the operation of a snowmobile, all-terrain vehicle, or dirt bike from the point where the snowmobile, all-terrain vehicle, or dirt bike is unloaded from a motorized conveyance to the area where it is to be operated, or from the area where operated to a motorized conveyance, when the loading or unloading cannot be effected in the immediate vicinity of the area of operation without causing a hazard to vehicular traffic approaching from either direction on the public highway. The loading or unloading must be accomplished with due regard to safety, at the nearest possible point to the area of operation."

Governor Murphy Signs the Marijuana Bill into Law

We are sure everyone is aware, but in case you missed it - Governor Murphy signed the new law decriminalizing marijuana on February 22. 2021.

The adult-use cannabis reform bills are now law, legalizing and regulating cannabis use and possession for adults 21 years and older A21 – "The New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" and decriminalizing marijuana and hashish possession A1897. The Governor also signed S3454 / A5342, clarifying marijuana and cannabis use and possession penalties for individuals younger than 21 years old.

Under A21, the Cannabis Regulatory Commission (CRC) will promulgate regulations to govern the medical and adult-use industries and oversee the applications for licensing of cannabis businesses. The legislation further provides for the Legislature to reinvest cannabis revenues in designated "impact zones"; directs the CRC to promote diversity and inclusion in business ownership; and contains critical employment protections for people who engage in lawful behavior with respect to cannabis.

A1897 reforms criminal and civil penalties for marijuana and hashish offenses, as well as provide remedies for people currently facing certain marijuana charges. The bill prevents unlawful low-level distribution and possession offenses from being used in pretrial release, probation, and parole decisions and provides certain protections against discrimination in employment, housing, and places of public accommodation. The bill also creates a pathway to vacate active sentences for certain offenses committed before enactment of the enabling legislation.

NJ Attorney General Launches Marijuana Decriminalization & Cannabis Legalization Resource Page

Just after Governor Murphy signed legislation changing the legal status of marijuana, Attorney General Gurbir Grewal announced the launch of a Marijuana Decriminalization & Cannabis Legalization Resource Page. The webpage is intended to provide resources and information for police and prosecutors to help them navigate the new laws and policy.

Shortly after enactment, Attorney General Grewal also issued two documents to law enforcement describing the new requirements and providing enforcement guidance:

AG Directive 2021-1: Directive Governing Dismissals of Certain Pending Marijuana Charges (Feb. 22, 2021). This directive instructs state, county, and municipal prosecutors to dismiss charges pending as of February 22, 2021, for any marijuana offense that is no longer illegal under state law.

Interim Guidance Regarding Marijuana Decriminalization (Feb. 22, 2021). This document provides guidance to law enforcement officers regarding new enforcement requirements pursuant to the marijuana decriminalization law.

Some Words from the Director – Eric Heitmann March 2021 Vehicle Safety Recalls Week

You may have heard the saying "safe cars save lives" before, and it's true! Safety defects in vehicles can cause crashes and deaths on our roadways. In fact, in 2019, there were 966 safety recalls affecting more than 53 million vehicles and other equipment in the United States. Unfortunately, about 25% of vehicle recalls are not addressed, which puts drivers, passengers, and others on the road at risk. March 8th through March 12th is "Vehicle Safety Recalls Week," and it's the perfect time to ensure that your car is operating safely as you get ready for spring.

A recall is issued when a manufacturer or the National Highway Traffic Safety Administration (NHTSA) determines that a vehicle, equipment, car seat, or tire creates an unreasonable safety risk or fails to meet minimum safety standards.

It's best to check if your car has a recall twice a year and promptly fix the problem if so. Every recall is fixed FOR FREE! To check the recall status of your car, simply visit www.NHTSA.gov/recalls and search your vehicle's VIN number to see if it needs to be repaired as part of a recall. On this site, you can check on the recall status for specific vehicle models, car seats, tires, and other equipment and sign up to receive email alerts about new vehicle, tire and car seat recalls, so you know that you are keeping safety top of mind.

This year, it's especially important to know that there is an urgent air bag recall currently in progress –the largest vehicle recall in U.S. history. You can learn more about this recall and find out if your vehicle is involved here: https://www.nhtsa.gov/equipment/takata-recall-spotlight.

Here at New Jersey's Division of Highway Traffic Safety, we know that safe cars save lives. By checking your car's recall status, you will have peace of mind that your vehicle is operating as it should or gain priceless knowledge that could end up saving your life or the life of a loved one.

AG Grewal: Division of Highway Traffic Safety to Focus on Promoting Safe Driving Habits Following Uptick in Fatal Crashes Last Year

2020 Data Shows NJ Fatalities Increased Despite Reduced Traffic Amid Pandemic

As preliminary data shows fatal crashes and collisions in New Jersey increased by more than five percent in 2020 despite fewer cars on the road amid COVID-19 restrictions, Attorney General Gurbir S. Grewal is focusing on new initiatives led by the Division of Highway Traffic Safety ("HTS") to address what are the leading causes of crashes nationwide – distracted driving and other risky behaviors.

In response to the 2020 crash statistics, HTS will launch a #SafeDriversSaveLives social media campaign to raise public awareness of the integral role each driver plays in preventing the loss of lives on New Jersey's roadways. HTS will also use new web-based crash analysis technology to implement data-driven strategies targeting communities most in need of education, enforcement, and public outreach programs, and will also launch a statewide multimedia campaign to raise awareness of the dangers of distracted driving.

"We're working on some very exciting initiatives and programs aimed at improving driver behaviors through education and public awareness," said Eric Heitmann, Director of the Division of Highway Traffic Safety. "The 2020 crash data indicates that now, more than ever, we need every driver working with us to keep New Jersey's roadways safe."

Preliminary data from the New Jersey State Police ("NJSP") shows that there were 552 fatal crashes on New Jersey roads in 2020, up from 524 the prior year. The uptick came at a time when traffic volumes were down in the State as a result COVID-19-related stay-at-home orders, curfews, and widespread transition to work-from-home. It's a scenario that mirrors a nationwide trend.

Data released by NHTSA in October 2020 showed a 30% rise in fatality rates nationwide from January through June of 2020 even though there was a decrease in the number of cars on the road for at least three of those months.

While NJSP and HTS are still compiling and analyzing underlying 2020 fatal crash data to better understand the reason for the rise in traffic fatalities in this state, NHTSA has suggested that driver behavior is to blame for the increase nationwide.

Reviewing nationwide fatal crashes in the first half of 2020, NHTSA found that driving patterns and behaviors changed significantly; drivers who remained on the roads engaged in more risky behavior, including speeding, failing to wear seat belts, and driving under the influence of drugs or alcohol.

According to NHTSA:

- One report showed a median 22% increase in speeds in select metropolitan areas.
- Sixty-five percent of drivers in trauma centers after a serious crash tested positive for drugs or alcohol.
- In April, double the average number of people were thrown from vehicles during crashes, indicating no seat belts.

In a campaign to be launched this spring, HTS will address the issue of distracted driving, which is the number one cause of traffic fatalities in the State.

Last year, HTS focused on promoting safety among its youngest drivers through a "Stick to It" public awareness campaign to educate parents and young drivers about New Jersey's nationally acclaimed teen driver laws. The campaign commemorated milestone anniversaries "Kyleigh's Law", which requires teens to affix stickers to their vehicles to identify them as novice drivers, and the 20-year anniversary of New Jersey's Graduated Driver License ("GDL") program, a three-tiered licensing process considered one of the most progressive and stringent teen driver measures in the United States.

The laws are widely credited with helping to reduce fatal crashes among teen drivers. According to data from NJSP, crash fatalities involving a teen driver (age 16 to 20) decreased by more than 47 percent between 2008 and 2018, dropping from 101 to 53. During that same period, the number of passengers under the age of 20 killed while riding in a car driven by a teen plummeted nearly 60 percent from 19 to 8.

MVC Online

Many customers can skip the trip to the MVC by going online. Nearly 30 different Motor Vehicle Commission services and transactions are available for customers online at NJMVC.gov. This includes most standard license and registration renewals and replacements.

Scheduling an Appointment for an In-Person Visit

Nearly all in-person transactions at MVC Vehicle and Licensing Centers require an appointment that is scheduled at MJMVC.gov.

Appointments are scheduled up to 60 days in advance and are widely available for nearly all transactions. The MVC has added more appointments over the past month, and more than doubled daily appointments for license and registration renewals.

Appointment Cancellations

Any appointments canceled due to an MVC location closure must be rescheduled on the website. Customers will get an email when their appointment has been canceled.

If a customer can't make their appointment, it should be canceled using the guidance in the confirmation email sent by the MVC upon booking, in order to open the appointment for others.

Renewals

License/ID and registration renewals that can't be completed online require an appointment. Renewals are not available on a walk-in basis.

Customers can complete many transactions online, schedule appointments, and find out more about MVC operations on the website. Customers can also identify whether a license or vehicle transaction is available online, by appointment, or by walk-in using the MVC "Cheat Sheet" on the home page of the website.

The New Jersey Motor Vehicle Commission (NJ MVC) today announced it's adding more transactions by appointment to improve service at its 39 agencies across the state.

"With these additions, almost all in-person transactions will be handled using appointments now," said MVC Chief Administrator Sue Fulton.

Customers can schedule appointments starting Monday, March 1, for the following in-person transactions:

- New driver permits.
- Non-driver IDs.
- Commercial Learner Permits (CLPs) and endorsements, under a separate appointment category.

Two additional changes also take effect on Monday, March 1.

- Name changes and/or gender marker changes may be completed in conjunction with a REAL ID or License Renewal appointment. Otherwise, name changes and/or gender marker changes remain available on a walk-in basis.
- Probationary licenses will be available via an open appointment: following a successful road test, applicants have 60 days to get their license at any Licensing Center.

All MVC appointments are scheduled up to two months in advance at NJMVC.gov.

Transactions available by appointment already include out-of-state transfers; license or non-driver ID renewals ineligible for online renewal; CDL renewals; REAL ID; new titles or registrations (for individuals only); duplicate or replacement titles; and registration renewals ineligible for online renewal.

"Appointments are now widely available for nearly all in-person transactions, and the MVC has added to the total number of appointments in recent weeks," said Chief Fulton. "Since October, the MVC has steadily added these appointments."

Before scheduling, every customer should first check to see if their transaction can be completed online at NJMVC.gov, as many customers mistakenly make appointments for transactions that can be completed without a visit to an MVC agency.

Many MVC transactions can be conducted online now, including most standard license and registration renewals and replacements. In fact, more than 80% of standard licenses and nearly all vehicle registrations are currently renewed without an in-person visit.

In total, there are about 30 different online services and transactions available at the MVC website.

"Due to our aggressive push online, we've reduced the number of transactions conducted in agencies from more than half to nearly a quarter over the course of the pandemic," Chief Fulton said. "That's a tremendous change, accounting for millions of reduced visits – and we're not done yet. We have more innovations and improvements to announce in the coming weeks."

Customers are encouraged to log on to <u>NJMVC.gov</u> before visiting an agency to catch up on the many changes to MVC operations, conduct transactions online, and schedule appointments for those few license or vehicle transactions that require an in-person visit.

911-gov National Database of 2020 Key Enacted 911 Legislation Now Available



NCSL's database of state 911 legislation, enacted in 2020, is now available

Each year, states consider or enact legislation aimed at supporting and improving the efficiency of 911 emergency communication services. The National 911 Program and the National Conference of State <u>Legislatures (NCSL)</u> are pleased to make a summary of <u>2020 key enacted legislation</u> available.

Since 2012, the 911 Legislation Tracking Database has served as a resource for states looking to improve their emergency communications operations or gather insight into neighboring legislative efforts. It allows states to easily compare recently enacted – or modifications to existing – laws involving 911.

A few legislative highlights from 2020 include:

- Four states California, Connecticut, New Jersey, and Washington enacted legislation establishing or enhancing penalties for false 911 calls, in particular, when the purpose of the call was harassing another person because of that person's characteristics, including their race, gender, nationality, religion, disability or sexual orientation.
- Five states Alabama, Colorado, Indiana, Tennessee and West Virginia established or increased statewide or local 911 fees.
- Maryland, Virginia, and West Virginia enacted legislation to authorize and foster cooperation between Public Safety Answering Points (PSAPs), ensure resilience and redundancy, and offer reliable service.
- South Dakota and Wyoming enacted legislation authorizing phone companies to provide real-time cell phone location information to PSAPs in emergent situations.

The database is easy to use and provides searchable filters to quickly find a bill. Users can search by state, topic, keyword, status, bill number, year and author. Topics include:

Examination of the Traffic Safety Environment During the Second Quarter of 2020: Special Report

The National Highway Traffic Safety Administration reviewed national changes in roadway travel and changes in drivers' behavior that have occurred since the start of the COVID -19 public health emergency. with an emphasis on the second quarter (Q2) of 2020. Most important, we are learning about the impact on motor vehicle crashes and fatalities. This report draws from an array of sources to bring together as much information as possible to provide an understanding of our current traffic safety environment, and to better address our changing traffic safety needs. As this report documents, there are many differences in impact on speeding and other dangerous driving behaviors, such as reduced seat belt use.

The report explores changes in countermeasure use including traffic enforcement and public communications and outreach. Also examined is the question of whether some people who continued driving even when many communities had stay a -home guidelines may be inherently higher risk drivers.

Update to Special Reports on Traffic Safety During the COVID-19 Public Health Emergency: Third Quarter Data

During the early months of the national public health emergency, driving patterns and behaviors changed significantly. Of the drivers who remained on the roads, some engaged in riskier behavior, including speeding, failing to wear seat belts, and driving under the influence of alcohol or other drugs. Traffic data indicated average speeds increased during the second quarter, and extreme speeds became more common.

Other data suggested fewer people involved in crashes used their seat belts. The study of seriously or fatally injured road users at five participating trauma centers found that, between mid-March and mid-July, almost two-thirds of drivers tested positive for at least one active drug, including alcohol, marijuana, or opioids. The proportion of such drivers testing positive for opioids nearly doubled after mid-March, as compared to the previous six months, while marijuana prevalence increased by about 50%.

FBI Law Enforcement Bulletin 2/11/21

Police officers should operate their vehicles carefully and prudently. They must obey all laws and policies so they can conduct their patrol operations effectively, respond to incidents expediently, and, most important, complete their duties safely. When an officer becomes involved in a traffic crash, all other police business halts for that officer and others who respond to the scene.

More important, the outcome can be tragic. Injuries can and often do occur. Although less frequently, these injuries can prove serious and even fatal. Additionally, officer-involved traffic crashes take resources (e.g., money and manpower) away from the main mission and can result in liability issues for the officer, department, and city.

FBI Newark Provides Tips for Avoiding Romance Scams

Romance scams occur when a criminal uses a fake online identity to gain a victim's affection and trust.

These scammers are present on most dating and social media sites. They look to establish a relationship as quickly as possible and endear themselves to the victim. Many may propose marriage and make plans to meet in person. Eventually, they will ask for money.

To avoid becoming a victim, FBI Newark recommends the following:

Tips for Avoiding Romance Scams:

- Be careful what you post and make public online. Scammers can use details shared on social media and dating sites to better understand and target you.
- Research the person's photo and profile using online searches to see if the image, name, or details have been used elsewhere.
- Go slowly and ask lots of questions.
- Beware if the individual seems too perfect or quickly asks you to leave a dating service or social media site to communicate directly.
- Beware if the individual attempts to isolate you from friends and family or requests inappropriate photos or financial information that could later be used to extort you.
- Beware if the individual promises to meet in person, but then always comes up with an excuse why
 he or she can't. If you haven't met the person after a few months, for whatever reason, you have good
 reason to be suspicious.
- Never send money to anyone you have only communicated with online or by phone.

Victims may be hesitant to report being taken advantage of due to embarrassment, shame, or humiliation. It's important to remember, romance scams can happen to anyone at any time.

If you suspect your online relationship is a scam, cease all contact immediately. If you are a victim who has already sent money, immediately report the incident to your financial institution, file a complaint with the Internet Crimes Complaint Center (www.ic3.gov) (http://www.ic3.gov), and to contact law enforcement.

DEA Announces 20th Take Back Day - April 24th

On the heels of largest collection to-date, federal, state and local partners prepare for April event

With opioid overdose deaths increasing during the pandemic, the Drug Enforcement Administration announced its 20th Take Back Day scheduled for April 24th. At its last Take Back Day in October, DEA collected a record-high amount of expired, unused prescription medications, with the public turning in close to 500 tons of unwanted drugs. Over the 10-year span of Take Back Day, DEA has brought in more than 6,800 tons of prescription drugs. With studies indicating a majority of abused prescription drugs come from family and friends, including from home medicine cabinets, clearing out unused medicine is essential.

According to the Centers for Disease Control and Prevention, the U.S. has seen an increase in overdose deaths during the COVID-19 pandemic, with 83,544 Americans overdosing during the 12-month period ending July 1, 2020, the most ever recorded in a 12-month period. The increase in drug overdose deaths appeared to begin prior to the COVID-19 health emergency, but accelerated significantly during the first months of the pandemic.

The public can drop off potentially dangerous prescription medications at collection sites which will adhere to local COVID-19 guidelines and regulations in order to maintain the safety of all participants and local law enforcement.

DEA and its partners will collect tablets, capsules, patches, and other solid forms of prescription drugs. Liquids (including intravenous solutions), syringes and other sharps, and illegal drugs will not be accepted. DEA will continue to accept vaping devices and cartridges at its drop off locations provided lithium batteries are removed.

Helping people dispose of potentially harmful prescription drugs is just one way DEA is working to reduce addiction and stem overdose deaths.

Murphy Administration announces \$29 million in FY2021 Rail Freight Assistance Program grants

The Murphy Administration announced on February 10th that 10 grants totaling more than \$29 million have been released through the New Jersey Department of Transportation's FY2021 Rail Freight Assistance Program. The grants help support economic activity by preserving and improving the existing freight transportation system and by making freight rail service more widely available for businesses throughout the state. Rail freight improvements support the state's clean energy, congestion mitigation, and sustainable development goals.

There are 10 projects receiving funding which are located in 11 counties and include upgrading and repairing existing railroad tracks with environmentally-friendly steel ties, installing new or upgraded switches, constructing a new drawbridge, and repairing or upgrading existing bridges and crossings. The \$29 million in state grants will leverage an additional \$23 million from railroad owners and operators, bringing the total investment of these 10 projects to more than \$52 million.

Governor Murphy Announces \$250 Million Overhaul of the Walter Rand Transportation Center in Camden

Governor Murphy announced a \$250 million investment in Camden's Walter Rand Transportation Center (WRTC) that will be multimodal, improve accessibility, and connect NJ Transit buses, private buses, PATCO, River Line light rail and the eventual expansion of light rail, to Glassboro.

The WRTC Improvement Project, seeks to upgrade and enlarge the existing facility to accommodate the development renaissance currently underway in the City of Camden. NJ TRANSIT plans to issue an RFP to obtain proposals from qualified professional firms to conduct Conceptual Design, Preliminary Engineering, Final Design Engineering, and Construction Assistance for the WRTC Improvement Project.

NJ TRANSIT recently completed nearly \$2.8 million dollars in repairs to the five-story parking deck attached to the WRTC. The improvements made include new electrical, lighting, and concrete patching needed to help facilitate future construction at the WRTC.



Glassboro-Camden Line Achieves Important Milestone

Environmental Impact Study Completed in February


The proposed Glassboro-Camden Line (GCL) will advance to preliminary engineering design with the completion of a comprehensive Environmental Impact Study. The study was a critical phase that carefully reviewed the project's environmental impacts. Nationally recognized transportation experts conducted the study with feedback from hundreds of members of the community.

The project for the 18-mile passenger light rail line started in 2003 and will restore service on an existing rail line that traverses Gloucester and Camden counties, including the communities of Glassboro, Pitman, Sewell, Mantua Township, Deptford Township, Wenonah, Woodbury Heights, Woodbury, Westville, Brooklawn, Gloucester City, and Camden.

This new light rail line is sponsored by the Delaware River Port Authority, Port Authority Transit Corp., NJ Transit, and the South Jersey Transportation Authority who has committed \$200 million towards the next phase of the project- preliminary engineering design and project management.

School Safety Patrol Celebrates 100 Years of Service

Were you a AAA Safety Patroller?

AAA is proud to celebrate its School Safety Patrol program's centennial anniversary. For 100 years, Patrollers around the world have provided school-aged children an extra sense of safety and security when going to and from school. The program and its more than 440 Lifesaving Award recipients have contributed to the steady decline of U.S. student pedestrian (ages 5–14) deaths—a 24% decrease since 2010.

"AAA's School Safety Patrol program is the world's largest school-based safety program. We could not be prouder of the thousands of young men and women annually who dedicate their time before and after school each day to ensure the safety of their classmates," said AAA President and CEO, and former Patroller, Marshall Doney. "This



community program teaches safety and leadership skills to ensure our youngest generations are making smart decisions. I can attest firsthand. The important pedestrian and traffic safety measures I learned as a Patroller had a profound and lasting impact on my career."

Started when horses and buggies were the mode of transportation it was created to make schoolchildren safer while walking to school, the program has grown-up and matured with the times while remaining steadfast to its mission to provide a safer environment and leadership opportunities for millions of schoolchildren. The training that Patrollers receive instills safety sense beyond street crossings, including bus and car drop-offs, monitoring hallway congestion, and teaching Patrollers invaluable leadership skills. The famous Patroller belt has seen change, too, going from white to neon orange to today's fluorescent green called 'Lectric Lime.

"Patrollers direct children, not traffic. Their focus is on helping students be safe where traffic is concerned," said AAA Traffic Safety Advocacy and Community Impact Manager Rhonda Shah. "Their actions save lives. Patrollers serve as role models in schools across the country."

The belt may come off after fifth grade, but the leadership values and safety awareness have inspired many to pursue admirable careers, including the sitting president.

Other notable Patrollers include Jimmy Carter and Bill Clinton, astronauts, governors, members of Congress, Supreme Court justices, Olympic medalists, and authors, like *Diary of a Wimpy Kid* Jeff Kinney. Many Patrollers now serve as educators, executives, and community leaders. Some, like Karen Guilbeault, enter law enforcement. Guilbeault rose to become the first female captain in the Cranston, R.I., police department and their first to graduate from the FBI's National Academy in Virginia.

"Being a patroller helped me get involved in community service and gave me a sense of belonging and instilled self-confidence," said Guilbeault. "It opened so many doors for me and formed my interest in going into law enforcement."

The 2020–21 school year, different as it may be, boasts 679,000 Patrollers in 35,000 schools in the United States. The legacy doesn't stop here, however. Over the last 100 years, interest in and excitement for the program have spread around the world. The AAA model has been adopted in at least 30 other countries, including England, France, Germany, the Netherlands, and New Zealand.

Why have pedestrian fatalities increased?

Examining the Increase in Pedestrian Fatalities in the United States, 2009–2018, released by the AAA Foundation for Traffic Safety

Over the period from 2009 to 2018, pedestrian fatalities in the United States increased 53%, from 4,109 to 6,283, after decreasing for three. The proportion of all traffic fatalities that were pedestrians increased from 12% to 17% over the same time period.

Between 2010 and 2017, the U.S. experienced the largest percentage increase in pedestrian fatalities among 30 countries in the Organization for Economic Cooperation & Development, 24 of which saw decreases in pedestrian fatalities.





Next-Generation Traffic Incident Management – NextGen TIM

<u>NextGen TIM</u> focus is to improve traffic incident management on all roadways and poised to take TIM to the next level by using innovative approaches that will continue to improve safety and travel reliability and save lives, time, and money. Training for first responders promotes a shared understanding of the requirements for safe, quick clearance at traffic incident scenes; prompt, reliable and open communications; and motorist and responder safeguards.

NextGen TIM continues to promote innovative approaches to training such as online and virtual delivery, allowing remote participation and continued access to updated content. In addition, NextGen TIM strives to institutionalize training by recommending requiring the training for new employees and continuing education credits towards certifications.

The National Highway Institute (NHI) provides a free online version of the FHWA coordinated National TIM Responder Training course. The course includes an overview and nine lessons—taking approximately four hours to complete. Participants can begin by <u>registering for an account</u> and searching for course number 133126A.

The Emergency Responder Safety Institute (ERSI) has identified 10 training modules available through the Responder Safety Learning Network (RSLN) that is equivalent to and covers all the training objectives of FHWA's National Responder Training course. Once individuals complete these ten modules, they can download a certificate equivalent to completing the National TIM Responder Training course. Rhode Island Man Sentenced for Conspiracy to Falsify Federal Records

On January 25, 2021, the U.S. District Court for the District of Rhode Island sentenced Damir Sisic to 3 years of probation, which includes 6 months of home incarceration, 50 hours of community service, a \$1,000 fine, and a \$100 special assessment. On October 14, 2020, Sisic, owner of the now defunct Sisic Transport Service LLC (STS), pleaded guilty to conspiracy to falsify Federal records.

According to the information, from approximately January 2018 through May 2019, Sisic allegedly conspired to falsify the hours of service listed in STS drivers' electronic logs. STS truck drivers were routinely exceeding the maximum number of driving hours and "on duty" hours, without spending the required hours off duty. Sisic concealed this information from the Federal Motor Carrier Safety Administration (FMCSA).

DOT-OIG conducted this investigation with FMCSA's assistance.

Al-Ibrahim accepted responsibility for her role in a conspiracy to obtain money from customers of various moving companies through false and fraudulent pretenses.

The Federal Rail Administration Highway-Rail Grade Crossing Inventory database from 2019 states that there are approximately 127,000 public, at-grade highway-rail grade crossings in the U.S.

Despite this large number of intersections between the highway and rail systems, little current intelligent transport systems automated/connected vehicle (AV/CV) work is focused on how to incorporate these crossings into AV/CV system planning.

The project explored the following:

- Information/data requirements for roadway vehicles to operate effectively near rail crossings.
- Impediments to collecting and exchanging rail operations data between public roadway agencies, public commuter/transit rail systems, and the largely private freight rail operators.

Drivers may not use ADS as intended due to misunderstandings about system capabilities and limitations. This report examined existing naturalistic driving data collected from 50 participants who drove personally owned vehicles with partial ADS for 12 months.

A post-study survey showed:

- Drivers found ADS useful and usable.
- Drivers felt more comfortable engaging in secondary tasks when ADS were in use.
- Some scenarios where the ADS did not meet driver expectations.

Autonomous Vehicles: Timeline

The timelines for deployment of fully autonomous vehicles (AVs) to be pushed back over the next few years. Companies that have made big bets on the technology will continue to push towards commercialization, but it could be closer to 2035 before we begin to see any meaningful deployments of fully self-driving vehicles.

1995 – A team of CMU roboticists drove a 1990 Pontiac from Pittsburgh to LA with a 70-mile stretch completed without human help.

2016 – Uber test autonomous taxis with human co-pilot in Pittsburgh.

2040 – More than 50% chance that level 5 vehicles will be available in the mass market.

Vehicle choice, crash differences help explain greater injury risks for women

New research from the Insurance Institute for Highway Safety shows that women are much more likely than men to suffer a serious injury when they are involved in a crash, but much of the heightened risk is related to the types of vehicles women drive and the circumstances of their crashes, rather than physical differences.

Though men are involved in more fatal crashes than women, on a per-crash basis women are 20-28 percent more likely than men to be killed and 37-73 percent more likely to be seriously injured after adjusting for speed and other factors. However, when IIHS researchers limited the comparison to similar crashes, they found those discrepancies mostly disappeared and that crashworthiness improvements have benefited men and women more or less equally.

Analysis of an Incentive-Based Smartphone Application for Young Drivers

Traffic crashes remain the leading cause of unintentional youth deaths and injuries across the United States. Development of new and innovative interventions with the aim of addressing this issue continues.

This report shares results associated with an incentive-based smartphone application (app) developed by the Texas A&M Transportation Institute as part of the peer-to-peer safe driving program, Teens in the Driver Seat[®].

One of the core features of the app is a reward system, in which drivers earn points for miles driven without any phone interaction. Points earned can be redeemed for rewards and are used as a basis for competitions and achievement of safe driving levels. This project examines data collected from two smartphone app deployments, in 2017 and 2018, each over a timespan of several months. Illinois Appellate Court Approves Intersection Lane Changing

The second-highest court in Illinois says police may not stop drivers for changing lanes in the middle of an intersection.

How Does This Compare to NJ Laws?

There is nothing illegal about changing lanes in the middle of an intersection, the Illinois Appellate Court ruled last month. Marjory Higgens, an officer with the Bolingbrook Police Department, shared the widely held opinion that the opposite was true -- that such maneuvers were prohibited. The court said this was a clear error.

On March 13, 2018, Officer Higgens was patrolling Route 53 when she saw three cars ahead of her stopped at the intersection. A maroon Ford Focus hesitated momentarily as the light turned green, so she decided to follow. The Focus turned on its signal in the middle of the intersection so that the driver could move toward the lane that turned onto the Interstate 55 on-ramp. Officer Higgens decided to pull him over.

As a result of being pulled over, the driver was charged with driving under the influence, but the appellate court was only examining whether the initial stop was justified under state law. At trial, Officer Higgens noted that the lane change maneuver was safely executed and did not interfere with anyone else on the road, but she still wrote him up for "improper lane change." The statute in question contains no prohibition on changing lanes in an intersection.

"A vehicle shall be driven as nearly as practicable entirely within a single lane and shall not be moved from such lane until the driver has first ascertained that such movement can be made with safety," Illinois Vehicle Code section 11-709 states. "A vehicle shall not be driven in the center lane except when overtaking and passing another vehicle traveling in the same direction when such center lane is clear of traffic within a safe distance, or in preparation for making a left turn..."

"There is also no language that would cause confusion regarding the prohibition of lane changes within an intersection," Judge Daniel L. Schmidt wrote for the court. "The state concedes that after scouring the compiled statutes of this state, none criminalize such a maneuver. In light of the plain language of the statute, we cannot say the officer's belief that the statute prohibited lane changes within an intersection was objectively reasonable." The court noted that the officer in question was up front about what happened in her testimony.

"As an aside, Officer Higgens is to be commended for her honesty on the stand during the hearing on the motion to suppress," Judge Schmidt wrote. "She was upfront regarding her mistake of law and did not waiver or attempt to provide an alternative ground for the stop when one did not exist. Her testimony makes clear that the mistake was subjectively honest and made in good faith."

As a result, the court suppressed the evidence gathered from the illegal traffic stop and vacated Rice's DWI conviction. Source: Illinois v. Rice (Illinois Appellate Court, 2/8/2021)

NJ Court rejects protective sweep where defendant handcuffed

State v Radel 465 N.J.Super. 65 (App. Div. 2020)

njlaws - Police did not have proof they had a reasonable and articulable suspicion that there were other persons inside the home or that they posed a risk to the police or others State v Radel

Defendant moved in the trial court for the suppression of evidence – guns, ammunition, drugs, and drug paraphernalia – seized pursuant to a search warrant based on information police obtained during a warrantless entry into defendant's home. The trial judge denied the suppression motion, finding the police conducted a permissible protective sweep of the home.

The court concluded that the police lacked both a reasonable and articulable suspicion of danger and a legitimate purpose for remaining on the premises, since defendant was arrested outside the home and handcuffed before police conducted the sweep. A-2503-18T3

Even if the second DWI test was administered within two minutes of the first test, court finds this test reliable

State v. Meyer Appellate Division, unpublished

njlaws - An appeal of the Law Division conviction after a trial de novo of driving while intoxicated, per N.J.S.A. 39:4-50. On June 13, 2016, defendant gave two breath samples, two minutes apart and was charged with DWI. On June 20, 2017, defendant entered a conditional plea of guilty in the municipal court to the DWI charge.

Defendant appealed to the Law Division where the judge affirmed the conviction based upon State v. Mukherjee, an unpublished appellate decision. On appeal, the court affirmed the lower court's decision. The lower court erred in basing its decision on an unpublished appellate decision, per Rule 1:36-3. But the court affirmed the decision because the Alcotest evidence was admissible under State v. Chun, 194 N.J. 54 (2008). The record showed the machine's lockout feature was functioning properly, so even if the second test was administered within two minutes of the first test, the test results were reliable pursuant to Chun.

Lange v. California

California First District Court of Appeal

Issues – this case deals with Fourth Amendment rights and has had oral arguments with not decision from the court yet.

May police officers always enter a home without a warrant when they are pursuing a suspect whom they believe committed a misdemeanor?

This case asks the Supreme Court to weigh the privacy interests of individuals under the Fourth Amendment against the government's interest in enforcing the law. Petitioner Arthur Lange ("Lange") was arrested in his garage by a police officer who pursued him for violating traffic laws. Though a police officer with probable cause may generally only enter a home after obtaining a warrant, certain exigent circumstances may justify warrantless home entry, including the pursuit of a felony suspect. The United States, in support of affirmance, argues that this warrantless exception should extend to the pursuit of misdemeanor suspects as a category. Lange and Respondent California, both in support of vacatur, counter that a case-by-case exception is more appropriate given the wide variety of misdemeanor offenses. This case has broad implications for individual privacy interests, public safety, and policing.

Celebrating 100 Years of Student Safety

The AAA School Safety Patrol program is celebrating its centennial in 2021! The program was created 100 years ago to make school children safer while walking to and from school. The belt color may have changed quite dramatically over the years—from white to neon orange to today's fluorescent green called 'Lectric Lime—but the mission remains the same: To provide a safer environment and leadership opportunities for millions of schoolchildren.

Today, the AAA School Safety Patrol program continues to build on its legacy of safety and leadership with 679,000 Patrollers in 35,000 schools in the United States. The legacy doesn't stop here, however. Over the last 100 years, interest and excitement for the program have spread to at least 30 other countries, including England, France, Germany, the Netherlands, and New Zealand.

During its long and distinguished history, the AAA School Safety Patrol program has provided a safer pedestrian environment and a broad spectrum of educational opportunities for millions of children.

AAA has successfully helped Patrols to thrive and expand, ensuring safer streets for all school children.

History

- The idea of school boy patrols began in 1920 with Charles M. Hayes, then president of the Chicago Motor Club, who is credited for building the infrastructure and providing the resources so other AAA clubs across the U.S. could protect school-aged children walking to and from school.
- Hayes witnessed several children at a school crossing get killed by a speeding car. After the horrific incident, Hayes pledged to help prevent such a tragedy from happening again.
- In the 1930s, three national organizations—the American Automobile
 Association (AAA), the National Congress of Parents and Teachers, and
 the National Safety Council—collaborated on Standard Rules for the
 Operation of School Boy Patrols. These guidelines have been revised
 to become the operating standards for AAA School Safety Patrols.
 The program has evolved over the years to instill safety sense beyond
 street crossing, to include bus and car drop-offs, monitoring hallway
 congestion, and teaching Patrollers invaluable leadership skills.



- Patrollers direct children, not traffic. The role of the AAA School Safety
 Patrol is to teach students to direct their peers in safely interacting with
 school traffic. This includes street crossing, bus and car drop-offs, and
 safety monitoring.
- Patrollers are issued a belt or vest and badge to wear while on duty.
 The badge indicates the level of office: Patroller, captain, lieutenant or sergeant.
- The highest recognition bestowed on Patrollers is the Lifesaving Award Medal, which was established in 1949. More than 440 Patrollers have received this award for saving the life of a person who was in imminent danger while on duty.





A Century of Service

- The School Safety Patrol Program has contributed to the steady decline of student pedestrian (ages 5–14) U.S. deaths—a 24% decrease since 2010.
- The 2020–21 school year boasts 679,000 Patrollers in 35,000 schools in the United States.

AAA School Safety Patrol members have grown up to be U.S. presidents, including President Joe Biden, astronauts, governors, members of Congress, Supreme Court justices (William Brennan, Stephen Breyer, Warren Burger, Anthony Kennedy and Clarence Thomas) and Olympic medalists (Eric Heiden, Caitlyn Jenner and Edwin Moses).

Hosted by the New Jersey Local Technical Assistance Program (NJ LTAP) at Rutgers Center for Advanced Infrastructure and Transportation (CAIT), this half-day course covers New Jersey's Highway Incident Traffic Safety Guidelines for Emergency

Responders. The course is supported and approved by the FHWA.

Three vehicle crashes involving injuries occur every minute in the United States putting nearly 39,000 incident responders in harm's way daily. Disruption and congestion from these incidents can increase the likelihood of secondary crashes causing delays and increasing driver frustration. The longer responders remain on the scene, the greater the risk they, and the traveling public, face. Correct traffic incident management (TIM) focuses on responding in a way that protects motorists and emergency personnel while minimizing negative effects on traffic. TIM practices include detecting, verifying, and responding to incidents; clearing the incident scene; and restoring traffic flow.

Using a multi-discipline approach, first responders in New Jersey will learn how to operate more efficiently and act collectively. The training covers topics including TIM guidelines; fundamentals and terminology; notifications and scene size up; scene safety and risk management; traffic management; special circumstances; clearance; and termination.

This course is open to all traffic-incident first responders including personnel in law enforcement, firefighting, emergency medical services (EMS), public safety, public works, towing and recovery, and hazardous materials (HAZMAT).

Hosted by Rutgers' CAIT, this free half-day course provides refresher training for law enforcement officers familiar with the NJTR-1 crash form.


Successful, proactive road safety improvement plans depend on the accuracy of data collected at crash scenes. Each year, the New Jersey Department of Transportation (NJDOT) collects approximately 300,000 crash reports from law enforcement agencies that can be uploaded into crash analysis systems like the Crash Analysis Tool. However, many of these reports are submitted with incomplete or incorrect information, which can negatively impact the effectiveness of data-driven crash reduction efforts.

The course reviews common NJTR-1 errors for both passenger and commercial motor vehicle crashes and offers methods to improve the quality of data that safety colleagues rely on.

Crash Analysis Tool software functions and the process of moving data from crash report to computer also will be discussed. All changes to the updated NJTR-1 will be addressed.

For individual police departments submitting police radar tuning forks and laser units, the representative of the police department will;

- Report to the State of New Jersey, Office of Weights and Measures (OWM) at a designated date and time with the tuning forks and/or laser unit, and contact us by phone 10 minutes before arrival.
- Upon arrival, report to the truck bay and locate the box placed by a Metrologist in the designated dropoff area.
- Obeying all Covid-19 protocols regarding PPE and social distancing, will place all tuning forks and lasers to be calibrated in the box and wipe each artifact down thoroughly with alcohol or antibacterial wipes. For individual tuning forks, this can be done in advance if they are placed in sealed packaging.
- Upon completion of the above steps, will immediately leave the truck bay and the State OWM. A receipt of submission of the artifacts will be provided by email only to the police department representative.

For multiple police departments submitting police radar tuning forks and laser units, a request can be made to have the equipment picked up in one location by a representative of the NJ OWM. If the request is approved, an appointment will be set for a date, time, and location for the pick-up of equipment. A single representative of the participating police departments will;

- Share with all participating police departments this protocol and inform all participants that the tuning forks and lasers must be wiped down with alcohol or antibacterial wipes.
- Gather all equipment to be calibrated, including paperwork, and contact the State OWM when it is ready
 to be picked up. NOTE: If there is not an approval to have a representative of the NJ OWM pick up
 the equipment at a designated location, please follow the steps for individual police departments
 listed above.
- Upon arrival at the agreed location of pick-up, the representative of the State OWM will pick up all equipment to be calibrated, obeying all Covid-19 protocols regarding PPE and social distancing.
- During the pick-up of the equipment, the representative of the OWM will sign documentation if asked, but
 the reconciliation of all equipment and paperwork will be conducted at the State OWM, and a receipt of
 submission of the artifacts will be provided by email only to the single representative of the participating
 police departments. Any discrepancies between the documented submissions and the actual artifacts
 submitted will be addressed with the police department representative at this stage.

After a minimum holding period of 72 hours, the Metrologists will calibrate the police radar tuning forks and lasers, obeying all Covid-19 protocols regarding PPE and social distancing. Upon completion of the calibrations, the Metrologists will contact the representative of the police department(s) to arrange for either the pick-up or drop-off of equipment.

For individual or multiple police departments picking up equipment, the representative of the police department will;

- Report to the State OWM at a designated date and time and contact us 10 minutes before arrival. This will allow the Metrologist adequate time to place the police radar tuning forks and/or lasers in the designated pick-up area.
- Upon arrival, report to the truck bay and locate the box placed by a Metrologist in the designated pickup area.
- Obeying all Covid-19 protocols regarding PPE and social distancing, the police department representative will pick up all equipment and accompanying paperwork, such as invoices, purchase orders, or Calibration Certificates.
- Upon completion of the above steps, will immediately leave the truck bay and the State OWM.

For multiple police departments receiving equipment, a single representative of the participating police departments will;

- Be contacted by the Metrologists of the State OWM to arrange for a location, date, and time of the drop-off of all equipment.
- On that arranged date and time, will receive all equipment and accompanying paperwork, such as invoices, purchase orders, or Calibration Certificates. Acknowledgement of this drop-off will be emailed to the representative of all police departments.
