The spillway repairs that were originally planned for fall of 2025 were delayed to the fall of 2026 due to high bids. Grant monies awarded for this project will be held by Sauk County and will still be awarded when the project is completed. There are no signs of beavers returning below the dam.

Metcalf Prairie – No prairie update. We will look into mowing a path along the shoreline and removing scrub brush and trees.
