**FEMA** - The GHC Insurance **FEMA Adjuster** continues the process of checking each of the 256 condos affected by flood waters. Starting **Monday October 14**, our CAM Billie will accompany him to help things move along. This step is an important one for the Flood Insurance Policy. We thank you in advance for your cooperation!

**FEMA** - Application for personal belongings for Florida Residents not insured for Flood.

During one of the daily flood update sessions, a year-round resident shared with the group that FL residents can apply for assistance through FEMA. This is provided you do not have coverage for personal belongings. **Important:** ONLY applicable if this is your primary residence, hence you live in Florida more than 6 months of the year, you may qualify for help.

Go to [disasterassistance.gov](https://disasterassistance.gov) - and complete the online application form.

This takes approximately 30 minutes to fill out. This owner received \$750. Directly into her bank account within 2 days. This process will slow down as more hurricane affected people complete the form. **Note** this does not apply for snowbirds when your primary home is in another state or country.

**GARBAGE** - As everyone hopefully can appreciate and residents on GHC property currently can attest to, the garbage is now the major concern.

**HELP** by putting your kitchen/ restroom waste in garbage bags in the garbage bins. If the bins are gone, please locate ones at another building and email Billie with the **Subject:** Garbage Bins! Include your building/ unit number to advise canisters are gone or blocked.

Personal items ruined from the hurricane, please continue to put them outside in 2 piles and not under the carports. Appliances in one section and furniture in a separate pile to assist in the removal. Grapple trucks (large claw) need to be able to reach appliances for removal.
