Section 4 First Aid

EMERGENCY OVERVIEW

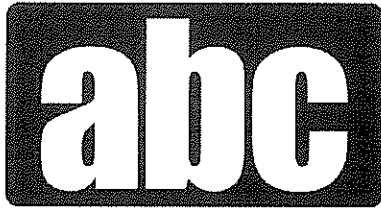

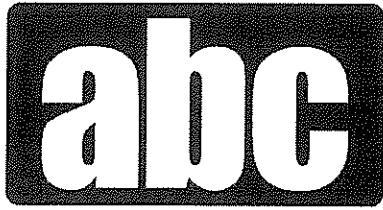
