## **NEW MEMBER REQUIREMENTS**

The Blue Ridge Shooters club accepts applications for membership as outlined in Article 3 of the club's bylaws as shown below. If you do not know anyone in the club to obtain a sponsor, there are club members willing to meet you at the range and observe your firearms handling and shooting. If you exhibit safe firearms handling practices, they will in turn sponsor your application.

The Blue Ridge Shooters Club is affiliated with the National Rifle Association and the Civilian Marksmanship Program. All members **MUST** be NRA members. If you are not currently an NRA member you will be required to join the NRA.

## **ARTICLE 3 - MEMBERSHIP AND PAYMENT OF ANNUAL CLUB DUES**

Any individual eighteen (18) years of age or older may become a member of the BRSC, provided a vacancy exists, on vote of those Club members in good standing and officers present at any Regular or Special meeting of the Club (so long as such Special Meeting has been properly noticed for such action). Membership in the BRSC shall not be restricted in any way by an applicant's race, religion, sex, or country of origin. Membership is contingent on completion of the following actions by the applicant:

- Completing and providing the Club Secretary a membership application.
- Presenting NRA membership card or application to the NRA
- Have one current member in good standing sponsor your application either in person or by letter of recommendation prior to submitting an application.
- Attending a safety and range orientation prior to receiving access to range facilities
- Agreeing to be bound by all applicable Club Rules and Regulations.
- The Payment of Annual Club Dues necessary to maintain Club Membership.

## **ARTICLE 4 – NRA MEMBERSHIP**

All members, directors and officers of the Club shall be members of the National Rifle Association of America ("NRA"). Any such member, director or officer who is not an NRA member shall not be a member in good standing.

## **INSTRUCTIONS FOR NEW MEMBERS:**

- 1) Mail this application (its postmark determines your application date).
- 2) If a Club opening exists you will be notified by the Clubs Secretary either via mail, email or phone.
- 3) Signature and NRA number/expiration date are required on the application, unless you are currently applying for NRA Membership or will apply at your introductory Membership Meeting.
- 4) A current BRSC member in good standing must sponsor your application either in person at a club meeting or by providing the club secretary with a letter of recommendation.
- 5) At your introductory Membership Meeting you must give a brief summary of your shooting experiences to the Members in attendance. If you have extenuating circumstances that prevent you from attending, such as work, your sponsor must be to speak on your behalf.
- 6) All new members are required to attend a safety and range orientation which is held immediately after a club meeting. If your sponsor presents your application, you must make arrangements to take the safety and range orientation. Access to the club **WILL NOT** be granted before completion of the safety and range orientation.
- 7) All members must agree to be bound by the applicable Club Rules and Regulations.
- 8) Payment of membership dues is due upon approval of the membership application.
