## Lily Lake Levels Rising Here's Who to Thank

Rain delayed the installation of new inlet tubes and gates connecting the Lily Lake with the Mill Race last week, but work began last week and should be concluded by the time you read this article and yes, the Lily Lake's water level is rising.

The Amana Colonies Historical Sites Foundation which manages and maintains the Mill Race canal levees and control structures replaced the inlet tube connecting the Mill Race to the Lily Lake with 2 new tubes/ control gates and a third "overflow" tube/ control gate.

Lily Lake is fed by two water sources: the canal and drainage from fields to its north. Most of the water in the lake comes from the Mill Race. Field drainage is not enough to keep the lake full even during the wettest years. The Mill Race's foliage is what keeps our lake full of water.

However, the intake tube which feeds the lake became silted over time. Then when the bottom of the metal tube rusted through the control gate was stuck and water no longer reached the lake. This became painfully clear this summer as the drought worsened. Even with midsummer rain the lake did not reach its fill.

Kayleigh Myers, executive director of the Amana Colonies Historical Sites Foundation, told us that the foundation board worked to come up with a good solution. Dredging the lake it is not an option as that is much too expensive. However, creating two inlet tubes each with plastic pipe and new gates, grading and placing these so that water can flow from the canal into the lake was a practical solution.

The board worked with Superior Grading and Land Management of Oxford Iowa to complete the project. The project includes the installation of two, plastic inlet tubes with water control gates. They also installed an "overflow" with a gate at a higher point, so that if lake levels become too high, water can be released from the lake into the canal.

About ten years ago, the Mill Race received a new control structure at its source on the Iowa River below West Amana. That structure has been working well. Myers told us, "We feel confident that with the control structure at the Iowa River, the repairs to the canal which allow us to keep water in the canal, and the new inlet tubes at the lake, now placed at a proper level, we can keep water in the lake."

The project was paid for by money donated by R.C. Eichacker of Amana. Several years ago, Eichacker made a \$100,000 donation to the Amana Colonies Historical Sites Foundation for the purpose of repairing/ refurbishing the hydro electric plant in Amana and maintaining the Mill Race canal. When contacted to ask if \$15,000 of his donation could be used for this Lily Lake project, Eichacker was very happy to agree.

Now waterfowl, trumpeter swans and eagles are back on the lake and we think we'll see lilies on the lake next summer. When you see RC Eichacker please thank him for his help in maintaining this im-
