Cllr D Pinder stated that MTC107 Street Naming at Former Wasps nest should be amended to 'known centre for Luddites at the beginning of 19th century' and **Proposed** that following this amendment the minutes were a true and correct record Cllr M Bolt

Cllr Bolt mentions the 'Santa Dash' MTC 112 and states that MTC were only advising safe practice and risk assessment. Cllr Bolt also states that MTC102 regarding street cleaning has resulted in other residents complaining. He states he has contacted cleansing who informed him that they carry out 'Gully' cleaning on a cyclical basis.

To receive an update/discuss/note:

1. Mirfield Toilets Cleaning Contract – Cllr Pinder updates Cllrs on the Cleaning contract and informs them that unbeknown to MTC Well Polished is a franchise and that Tracy Martin to whom MTC are contracted has left this franchise due to an internal dispute. Cllr Pinder confirms a telephone conversation with the head office in which he was told that they had no way of continuing with the service as they didn't know who the local cleaner was. Tracy agreed to continue with the service she had been providing. He confirmed that the administrator had cancelled the standing order with Well Polished. Cllr Pinder **Proposed** to continue with Tracy under the new name of Extra Mile Cleaning Company and sign a new contract and new standing order in this name Cllr Nottingham

MTC123/2014 Internal Matters

- 2. Eastthorpe Gardens Cllr Hirst advises MTC of an email from WYPW regarding flagging the central bed and that they are objecting on the basis of anti-social behaviour in the gardens. Cllr Hirst states that when this was first mentioned in Summer WYPW were in favour of this seating arrangement and states that he is not aware of any anti-social behaviour nor has MTC received any notification of this or vandalism to existing seating. Cllr Pinder agrees that the existing seating has not been vandalised and that there is no way of locking the gardens. Cllr Armitage states that the gardens are for residents use not just WYPW. Cllrs discuss the quotation from Just Gardens to clear the bed and lay the flags @ £610.00 Cllr Pinder **Proposed** that MTC accept this estimate from Just Gardens as they have the tender for the maintenance Cllr Hamilton **Seconded Vote: All in favour**
- 3. Defibrillator Presentation Jill from St John Ambulance gives a presentation to MTC. She shows the Defibrillator to MTC stating that it is easy and designed for children to use. It records the entire incident for the Emergency services and guides the user through verbally and with written instructions on the unit. She confirms battery life and gives a brief demonstration of how to use one. Cllr Bolt asks if there are external fittings available and the cost of the unit. Jill confirms that there are fittings available and that the unit costs £1600 including battery pads and training. She recommends that anyone buying a unit advertise that they have one locally by signage or local press and inform the ambulance service. She confirms they have 7 year warranty and that they can be part exchanged or returned. Cllr Hamilton asks for a price on an outside cabinet Jill confirms that she will ask her head office to supply this. Cllrs agree that a local central point would be beneficial as the public cannot easily access schools and that MTC need to seriously look into the best place for one. Cllr Bolt **Proposed** that Cllr T Hirst heads a working party to look into possible grants available and involve local community groups, 1

per ward for starters Cllr Pinder **Seconded Vote: All in favour** Cllrs Pinder & Armitage volunteer for the working party. Cllr T Hirst thanks Jill for her presentation and concluded by saying that MTC do not want to get left behind with this initiative. Cllr Pinder thanks Cllr Hirst for his initiative with this and arranging the presentation.
