
Remark On Asymptomatic Spread

The World Health Organization's (WHO) remark that transmission of the Coronavirus by people who never developed symptoms was rare, "was not correct," White House health advisor Dr. Anthony Fauci said Wednesday. "In fact, the evidence we have given the percentage of people, which is about 25% [to] 45%, of the totality of infected people likely are without symptoms," he said. "And we know from epidemiological studies that they can transmit to someone who is uninfected even when they are without symptoms." An asymptomatic person is someone infected with Covid-19 but never develops symptoms. It's not the same as a pre-symptomatic patient, who later goes on to develop symptoms. Studies have shown that people who are infected can spread the virus in the pre-symptomatic stage as well, generally one to a few days before symptoms start.

Dr. Maria Van Kerkhove, head of the WHO's emerging diseases and zoonosis unit, walked back those comments Tuesday, saying, it was a "misunderstanding" and "we don't actually have that answer yet." Studies show that about 16% of the population may be asymptomatic, she said. Some models developed by other scientists suggest as much as 40% of global transmission may be due to asymptomatic individuals, she said, clarifying her comments.

Earlier this week, Fauci said Covid-19 turned out to be his "worst nightmare" come to life as it continues to rapidly spread across the globe. Fauci stated that the virus is "very different" from other outbreaks such as Ebola and HIV. It is historically one of the worst pandemics the world has ever experienced, he said, adding people have compared it with the 1918 flu.
