



## **SAFETY BOAT INFORMATION DESERT STORM 2020**

### **Phantom Productions, LLC will be providing:**

- 1– Volunteer Swag Bag
- 2– Box lunches per day Fri / Sat
- 2– Wrist bands for attendance to all parties
- 2- Meal tickets for all meals provided
- 2- Orange volunteer safety shirts
- 2- DS Event shirts

A predetermined fuel payment (50\$ Friday and 50\$ Saturday) This will be paid 60-90 days after the event, for returning safety boats. If this is your **first year** as a safety boat the fuel reimbursement will be determined based on your availability and dedication to your volunteer job.

For anyone wanting to get a **photo** from the helicopter you are all welcome to do so. That station will be open **from 1:00 to 2:30** over by Havasu Landing Casino. **At 1:30 you can head over there and get your picture taken.** Stay around 35-60 mph for the helicopter to get a good shot.

### **Safety boat team agrees to:**

- **Bring your own water and snacks**
- **Move within your safety zone** Please remember, during the poker run to stay towards the shore and not out in the middle of the lake. If a boat stalls or breaks down, you can assist and tow them off to the shoreline where they can arrange a tow with Sea Tow, US Tow or a friend. Our main purpose during the poker run is to keep the middle of the lake clear of boaters and let them know there is an event in progress, and to stay along the shoreline for their safety and/or entertainment 😊
- **NEVER ANCHOR – stay mobile**
- **Use flags and horn to gain attention**
- **Mandatory to wear shirts when being the safety boat**
- **Mandatory to use the banners provided**
- **No alcohol consumed during on the water activities – zero tolerance**
- **Radio Use:**
  - **Channel 16** = Emergency and Distress (call on this station only for incident or accident)
  - **Channel 69** = General Marine station = Main Safety Boat communication
  - DO NOT chatter on radio you need to go to another station to chat with each other. If there is an EMERGENCY announce it on the radio and or call **Jimmy- 602-739-4739 or Christina- 623-238-1330 or Dan Herron-928-855-0038. But first and foremost, secure the area.** Make initial contact and then switch to another frequency to further discussion. Do not block the radio with chatter- this is for SAFETY PURPOSES and COURSE CONTROL ONLY. Remember to use the map in order to contact other safety teams around you for assistance if needed.
- **Main contact via radio**
  - FRIDAY (POKER RUN) – DAN HERRON / JIMMY NICHOLS
  - SATURDAY (SHOOTOUT) – TBD
- **Additional box lunches** can be purchased @ \$15.00 each per day you must request additional by April 1, 2020
- **Additional Wrist Bands** can be purchased @ \$100.00 each you must request additional by April 1, 2020

## Safety Boat Rules and Guidelines – 2020

1. **DESERT STORM / Phantom Productions, LLC.** will be providing:
  - a. Orange safety shirts for 2 people (2ea) per boat (additional can be purchased at \$10.00 each)
  - b. Lunch for 2 people (more can be purchased for \$15.00 ea. person, please arrange by April 1, 2020)
    - i. FRIDAY Box Lunch
    - ii. SATURDAY Box Lunch
  - c. Wrist bands/ Meal tickets for 2 people (More can be purchased at \$50.00 each)
    - i. Wednesday – Buffet OPEN HOUSE
    - ii. Thursday – Buffet Street Party
    - iii. Friday – Buffet at Card Turn in
    - iv. Saturday – Buffet at Awards dinner
    - v. Sunday- Buffet at appreciation breakfast
  - d. Gas Reimbursement: (returning safety boats / 1<sup>st</sup> time volunteers TBD)
    - i. FRIDAY Poker Run \$50.00
    - ii. SATURDAY Shootout \$50.00
  - e. Banners for display on boat naming you a safety boat and supplies to hang them.
  - f. Strobe lights if necessary, based on your position.
  - g. Megaphones.
  - h. Orange caution flags if necessary, based on position.
  - i. VHF radios if you have said you need to borrow one.
2. **There is ABSOLUTLY NO DRINKING while being a SAFETY boat volunteer for the event. If you want to drink and boat, please don't volunteer. It looks bad for everyone involved and we don't want to see anyone get hurt or arrested. The Police and Sherriff will be there in force.**
3. You must have the minimum required USCG equipment for your vessel:
  - a. Correct amount of USCG approved PFD's per person
  - b. USCG approved throwable device
  - c. Fire extinguisher
  - d. Visual Distress Signal (day-orange flag)
  - e. Sound producing device (whistle or horn)

**Recommended items:**

  - a. Anchor, Tow rope, Binoculars, VHF radio, Water 😊, Snacks 😊, Sunscreen 😊
4. Your boat must have **current REGISTRATION AND INSURANCE** and must always be on board. Please include a copy with your application. These get shredded after the event, so I do not have any copies from 2019. 😊
5. You agree to attend ALL the meetings REGARDING the safety boat teams – SEE SCHEDULE.
6. You agree to return all borrowed items at the Sunday 9:00 AM Appreciation Breakfast. If you cannot make the Breakfast arrange with Dan, Jimmy or ChristinA for return of supplies.

You understand that you **are not required by Desert Storm/ Phantom Productions, LLC. to TOW anyone...** We do ask that if necessary, you tow a boat to the side of the lake or a safe distance out of a high traffic zone.

DESERT STORM SAFETY BOAT TEAM INFORMATION / APPLICATION

**Desert Storm 2020 Event Liability Waiver**

IN CONSIDERATION of being permitted to be a/on a SAFETY TEAM in Desert Storm 2020 Event, the undersigned agrees:

1. To completely and fully assume the risk of property damage, series injury, and death. Organized boating activities carry significant risk that boats will be damaged by collision, docking, submerged items, and shallow water. Organized boating activities carry significant risks that participants and their passengers, crew, associates, and guests may become seriously injured, or even killed, by a boating collision or other type of accident. These risks are increased by the inclusion of large boats with high horsepower engines. The undersigned is aware of these significant risks and assumes these risks as part of the undersigned’s desire to participate in this event.
  2. That the event herein is defined as including but not limited to and all activities on the London Bridge Resort properties, Lake Havasu event areas, concessions, and other appurtenant areas where any activity related to the Event, or to officiate, observe, work for, or any purpose participate in The Event. The Undersigned, for himself and personal representatives assigns, heirs, and next of kin, agrees, and on the direct representation that the Undersigned has, or will immediately inspect such areas, and upon such inspection declares, by then entering such areas, an acknowledgement that the inspected areas are safe and reasonably suited for the purposes of The Event for which this waiver, release, and assumption of risk applies and further agrees and warrants that if, at any time the Undersigned is in or about The Event areas and feels anything to be unsafe, the Undersigned will immediately advise the OFFICIALS of such and will leave such areas.
  3. The Undersigned HEREBY RELEASES, WAIVES, DISCHARGES, AND CONVENANTS NOT TO SUE Phantom Productions, L.L.C., their officers, officials, drivers, volunteers, exhibitors, sponsors, promoters, advertisers, owners, and lessees of PREMISES used to conduct the event. Agencies of government which control essential land and water sites, financiers and firms which render essential service gratis, and each of them, their officers and employees, all for purposes herein referred to as RELEASEES, from all liability to the Undersigned, and the Undersigned’s personal representatives, assigns, heirs, and next of kin for all loss of damage, and any claim or demands therefore, on account of injury to the person or property or resulting in death of the Undersigned, whether caused by the negligence of RELEASEES or otherwise while the Undersigned is in or upon the EVENT AREAS, and or officiating in, observing, working for, or for any purpose participating in The Event.
  4. That The Undersigned HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES from any loss, to person, vehicle or machine, liability, damage, or cost they may incur due to the presence of the Undersigned in or upon the Event areas, or in any way or officiating in, observing, working for, or for any purpose participating in the Event, and whether caused by the negligence of RELEASEES or otherwise: and HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of RELEASEES or otherwise while in or upon the Event Areas, and/or officiating in, observing, working for, or for any purpose participating in the Event. This assumption of risk of negligent RELEASEES is separate and additional to the assumption of risk and property damage inherent in organized boating activities. **Boat owner/insurance liability is the primary over event insurance in case of bodily or property damage. If boat owner’s insurance does not cover loss, owner will be liable. The Event offers no supplemental insurance of any kind.**
  5. The Undersigned is the legal agent and has power of attorney and/or is THE PARENTS AND/OR GUARDIAN OF MINOR CHILDREN participating in the event and/or engaged in activities around, during or near the event agrees to indemnify and save and hold harmless, the releases and each of them from any loss, liability, damage, cost and attorney’s fees they may incur due to the presence of the parent and/or guardian or the minor in any part of the event. While participating in the event and where to cause by negligence of the releases or otherwise. The parent and/or guardian further recognize and agree they are executing this Waiver, Assumption of Risk, and Release of Liability and Indemnity Agreement on behalf of themselves and on behalf of the minor.
  6. That the Undersigned will not have taken any illegal substances nor consumed alcohol 8 (eight) hours before an on the water activity and will not consume either while operating a boat and will not allow any passenger or guest on the boat to under the influence of any illegal substances or legal substances, including but not limited to alcohol or medical marijuana, that could impair the judgment and/or interfere with the safe operation or occupation of a boat.
  7. The Undersigned acknowledges that numerous docks, and docking extensions used in The Event are temporary and are not engineered. They exist for the benefit of temporarily accommodating larger boats in docks designed for much smaller boats. The stability of these docks may be less than an engineered dock and The Undersigned shall make the most minimal use of these docks and assumes the risk that any of them could increase the likelihood of injury and property damage.
  8. That the weather in Lake Havasu City is erratic and unpredictable. The changing weather conditions can increase the likelihood of property damage and personal injury. The docks may be more unstable during some weather conditions and changes and The Undersigned assume the risk of any loss, whether property or bodily, for any participation in the event, including usage of the temporary docks, during any type of weather.
  9. That EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the Event are possibly dangerous and involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that this Waiver and Release of Liability and Indemnity Agreement extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS, and is intended to be as broad and inclusive as permitted by the law of the state in which the Event is conducted, and that if any portion thereof is held invalid, it is agreed that the balance notwithstanding, shall continue in full legal force and effect.
- THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representation, statements, or inducements apart from the foregoing written agreement have been made.
