## "ORDER IN THE COURT!!!"



The LCE's "**Order in the Court**" program is a new initiative designed to educate high school students about the judicial process. The program enhances efforts to increase the public's understanding of Louisiana's judicial system through classroom and courtroom visits.

A major component of the "**Order in the Court**" program is the **Teacher Justice Institute** where Louisiana teachers will be provided with the "hands on" training in interactive lesson plans that will help students understand the history and role of Louisiana Courts and connecting that learning to the function of the Courts. The success of the "**Teacher Justice Institute**" will rely upon Louisiana judges to teach educators about local, state and federal courts and the judicial process. In turn, the educators will teach this information to their students. The Justice Institute will be held in Summer 2007. Further information, will be provided in January.

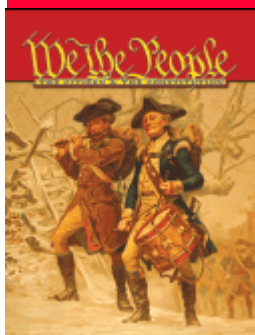

The Louisiana "We the People: The Citizen and the Constitution" program needs to fill **one part time** position for district coordinators in **Congressional Districts 5** includes: Alexandria, Pineville, Ruston, Monroe and Bastrop.

"**We the People**" District Coordinators are responsible for conducting an awareness workshop on the "We the People" program for educators within their purview, as well as assisting schools with organizing mock congressional hearing competitions. Further, each district coordinator is responsible for inviting the participation of legal, civic and elected leaders from their respective Congressional districts to serve as judges during the competitions. This is an excellent opportunity to engage more youth in civic participation and for the community to become involved in the civic education of youth.

## LOUISIANA SCHOOLS PARTICIPATE IN E-CONGRESS ELECTION



768 students from 175 Louisiana schools cast a total of 758 votes as part of the **LCE's Y-Vote** (Youth-Vote) program during the November congressional elections. Students registered on-line and exercised their "electronic right to vote" for Louisiana's leaders. **Y-Vote** is an LCE program in partnership with the **University of Virginia Center for Politics Youth Leadership Initiative**.
