Supervisor May called the meeting to order at 7:00 p.m. at the town hall located at 3529 Rt. 20A, Warsaw, New York.

Supervisor May opened with the Pledge of Allegiance; all were thanked for attending the meeting.

Audience Member Mr. William Schurr wanted to complain about his neighbors dogs barking constantly.

Audience Member Mr. Lance Pearl explained that the dogs bark at the garbage truck, the school bus and when kids walk by and antagonize the dogs. Will be moving back to Snyder Road when house is rebuilt after the fire.

Audience Member Mr. William Schurr is requesting a dog barking ordinance. [utilizing inappropriate verbiage in his discussion with the Board.]

The Town Board discussed options; 1) invite Justa Goodell to attend the June Board meeting for information, 2) Send this information to the Planning Board for their review and to ascertain what other towns have as an ordinance or law on this issue.

William Webb. Town Clerk will check with the County to ascertain if they have an address to send information regarding property.

Supervisor May requested a motion to approve the minutes from April 13, 2023. On a motion by Mr. Flint, seconded by Herman to approve the April's minutes with the corrections on Page 2, with plow. Ayes [5 May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisors May requested a motion to approve the following transfer:

Zoning Officer Report: Rory Bathrick has demolished the house and is building new. The West would like to put up (Tiny Houses – Container Homes) for their venue. There is a requirement of 1250 feet with our zoning. Explained to them to get the information, a plan together that they are seeking to complete and we will review it and send it to the Planning Board. It could be a SUP through the planning board.

The Board reviewed the letter that Mr. DiMatteo developed to send to the employee. On a motion by Mr. Flint, seconded by Mr. Herman to have Mr. DiMatteo send the letter. [5 May Boxler Flint Herman Ahl. Noes [0] Carried

Highway Superintendent Report: Cleaning up from winter, culverts on Syler south of Gulf road. Clearing brush, going to do some brine on the dirt roads. 205 has some electrical issues, code issues, may need new wiring, sent the truck to Fleet. Good news with the CHIPS monies. Mr. Roggow requested a motion to increase DA5112.2 from Fund Balance, the CHIPS monies by \$43,340.46. On a motion by Mr. Herman, seconded by Mr. Flint to raise the budget line as per above. The truck numbers are in from 2022 approved purchase; \$293,254.00. On a motion by Mr. Herman, seconded by Mr. Boxler, Jr, to continue with purchase. [5 May Boxler Flint Herman Ahl. Noes [0] Carried

Mr. Roggow will do some research and formulate a plan with numbers for electric, heat etc for the back building.

Supervisor May requested a motion to sign the Inter-Municipal agreement with the county regarding address assignment services. On a motion by Mr. Ahl, seconded by Mr. Herman to have Supervisor May sign this agreement. [5 May Boxler Flint Herman Ahl. Noes [0] Carried

Town Clerk Report: The Towns total revenue for the month of April 2023 was \$462.00, 300.00 for Zoning, \$135.00 for dog licenses, \$5.00 DEC, \$160.00 for Registrar and \$5.00 for late fee. We had 15 renewal licenses. To the general fund, \$380.28, \$335.00 Zoning,

\$117.00 Dogs, and \$10.00 Registrar. We disbursed \$65.00 to Wyoming County, \$17.00 to Ag and Markets for dogs. No correspondence was noted this month.

Supervisor May requested a motion to approve the 2023 Highway Fund Bills: Abstract #5 Vouchers #72 through #110 totaling \$32,532.88. A motion was made by Mr. Herman, seconded by Mr. Flint to approve the payment of the Highway Fund bills. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisor May requested a motion to approve the 2023. General Funds bills: Abstract #5 Vouchers #90 through 110, totaling \$20,119.23. A motion was made by Mr. Ahl, seconded by Mr. Herman to approve the payment of the General Fund bills. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried
