- TITLE: APPROVAL OF NEW VEHICLE PURCHASE TOYOTA TUNDRA
- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council (see Article II, Section 1); and
- WHEREAS, the Summit Lake Paiute Council has the power and duty to represent the Summit Lake Paiute Tribe in negotiations with Federal Governments in matters to benefit the general welfare of its tribal membership; and
- WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute reservation; and
- WHEREAS, the Council considered the needs of the tribal members and reviewed the U.S. Department of the Treasury's publication "Coronavirus State & Local Fiscal Recovery Funds: Overview of the Final Rule" received in January 2022 with final rule effective April 1, 2022; and
- WHEREAS, Summit Lake Paiute Tribe has heard the need from the Tribal Membership. Several members have experienced hardship in obtaining transportation to and from medical appointments, transportation for children's learning activities, as well as transportation to and from the reservation during tribal elections, tribal cultural activities, and tribal camping events; and,
- WHEREAS, Summit Lake Paiute Council discussed the need and has agreed the purchase of a vehicle would greatly benefit the membership who have experienced hardships in participating in the tribal voting rights, cultural activities, education programs and medically necessary appointments; and,
- WHEREAS, the Summit Lake Paiute Tribal Council has discussed the need and approves the purchase a 2025 Toyota Tundra 4WD for the total price \$55,969.00, which includes license and fees, delivery fee, and documentary fee; and,
- NOW THEREFORE, BE IT RESOLVED, that the Summit Lake Paiute Tribal Council hereby authorizes the purchase of a 2025 Toyota Tundra AWD vehicle from <u>Dolan Toyota Scion</u> of Reno to better service our Tribal Membership with transportation hardships.
