Members present at the last Association meeting voted to provide a one-time 30-yard roll-off Dumpster for community use. This project was a huge success last year.

<u>Where</u>: Corner of Gold Cup and Saint Leger
<u>When</u>: From Friday, 26 May until Monday, 5 June (or until it is full)
<u>Who</u> may use it: <u>ALL</u> NRE property owners

**Brush** can be burned so it doesn't need to take space and weight in the dumpster.

- <u>Rocks</u> can be taken to Kurt Newman's property so they do not need to take space and weight in the dumpster.
- <u>Metals</u> of any kind (even old lawn mowers) may be placed <u>next to the dumpster</u> and the HOA will recycle them.

# Things that may <u>NOT</u> go into or be left at the dumpster:

tires of any kind hazardous, toxic or radioactive wastes vehicle batteries liquid paint (dry paint cans are okay) motor oil freon kitchen appliances heavy metals (not inside – put next to) animal carcasses

The dumpster will be checked daily to ensure prohibited items are not found inside.
