



## Wayne County Council for the Arts Presents: “Threads - Regional Fiber Arts Show” PROSPECTUS 2018

**Regional Fiber Arts Show is an new exhibition** presenting an artistic approach to the fiber arts, using traditional and unusual fiber-based materials and techniques that express the vision on the artist. Works created using fiber techniques are encouraged to enter. Accepting two or three-dimensional work and heirloom pieces. Quilts, weaving, floor and wall art, felting, vessels and baskets, sculptures, tapestries, needlework, handmade paper and wearable items including accessories are just some of the possibilities.

### IMPORTANT DATES:

- Delivery of Art - Sunday October 28 2:00-5:00 pm\*\*
  - Installation of Exhibit Sunday 10/28 OR Monday 10/29 4:00-6:00 pm
  - Show Dates - Thursday November 1 - Saturday November 24
  - Reception - Saturday, November 10 - 4:00 and 6:00 pm
  - Removal of Art - Monday November 26, 4:00-7:00 pm\*\*
- \*\*Special accommodations *may be possible* by contacting Wayne Arts at least 10 days ahead by email

### ELIGIBILITY:

- This is a judged show and is open to all fiber artists in the region.
- Works that have previously been exhibited at Wayne Arts are not eligible.
- Work must be of original design by the artist. Pieces made from kits must be labeled as such and will not be included in judging.

### ENTRY FEES for up to 3 pieces (*see size restrictions below*):

- \$20 for Wayne Arts members / \$35 for non-members (includes FREE one year membership)
- Cash, credit cards or checks payable to Wayne County Council for the Arts are accepted.
- *All fees are non-refundable.*

### PRESENTATION SPECIFICATIONS:

- *Due to space considerations only one piece may be large with a maximum size of 40 (W) x70 (L) inches*
- Pedestals will be available for sculptural/3D work.
- 2-D pieces must be ready to hang (see next page)
- Artist must provide dress form, quilt hanger, hat or torso forms or other special display if needed.
- If you have questions or need assistance please email us as soon as possible.

**COMMISSION:** A commission of 25% will be charged for the sale of work. Work does not have to be for sale. It will be marked NFS. Monies will be paid to the artist at the end of the show. All sales are handled through Wayne Arts Gift Shop. Wayne Arts will assume responsibility for paying the sales tax.

- *It is understood that heirloom pieces will not be for sale. Contributor is encouraged to provide historical information about the piece for the viewers' information.*
- *All work including work sold during the show must remain in the gallery until the end of the show.*

- **AWARDS:** Cash prizes will be awarded.
- Only original designs will be judged.
- Only one award may be given to an individual.
- Heirloom pieces are not eligible for judging. Award recipients will be notified by the Show Chair.
- Award winners must be present or represented at the opening.
- *The decision of the juror is final.*

**LIABILITY:**

While all reasonable care will be taken in handling work WCCA Does not carry insurance for submitted works and will not assume responsibility for any damage to the artwork during delivery, installation, exhibit and de-installation including, but not limited to normal wear and tear, such as minor nicks to frames or scratches to Plexiglas. It is suggested that an artist wanting more protection insure his or her own art (some homeowner's policies may include protection and should be checked).

**USE OF IMAGES:**

All entrants agree that any work they submit to the Wayne Arts' "Regional Fiber" Show may be photographed and used for marketing and promotional purposes directly related to the Show. This use may include publication in any Wayne Arts' publications, printed materials, advertisements, or electronic media, including but not limited to the Wayne Arts' website, newsletter, and gallery shows. *Any image used by the Wayne Arts shall carry a credit line of the artist. Copyright and all other rights remain that of the artist.*

## **Hanging/Presentation Specifications**

*Due to space considerations only one piece may be large with a maximum size of 40 (W) x70 (L) inches*

- A **sturdy slat**, 1/2" shorter than the width of the quilt, should be inserted into the sleeve. It should have holes drilled about 1/2" from each end, just above the center of the slat, 1/8 to 1/4" diameter. Larger pieces need a thicker slat.



- A label should be secured to the back of the work, or anywhere on wearables. It should have the artist's name, title of the piece and any other information you want to include.

- Check for (and remove) any stray threads, pet hair, etc. Make sure embellishments are very secure.

- Large quilts may be folded any way you like. Bias folding is felt by some to produce less pronounced fold lines which hang out nicely. Rolling is a great method for art quilts if not too big. The quilt should be rolled with the right side out, using a pool noodle, cardboard tube (from carpet store works well), or anything that provides some bulk to roll the quilt around. If there is a lot of embellishment use a piece of muslin or old bath towel to protect the right side before rolling the whole thing up. The rolled quilt can then be placed in a long bag or wrapped in a large towel or piece of fabric. The roll can be secured with ties made from fabric (selvages + 1/2") or old nylons, etc. Do this before the outer bag, or after, or both.

- Label all packaging materials with your name and title of the piece. This is so they can be re-used to wrap your piece after the show comes down. Unlabeled packing materials can't be matched with the correct quilt. Optionally, a photo of the piece may also be securely attached to the outer wrapping for identification.
- Anything larger than 18"x20" needs to be folded or rolled. Smaller pieces that you want to remain flat should be *secured* to a firm surface and placed in a bag. It is not always possible to keep works horizontal in transporting and storage.
- Plastic outer wrappings can make transporting and storing multiple quilts difficult, especially for larger pieces. Cloth outer wrappings are preferred.

### **Other Entries**

- Pedestals will be available for sculptural/3D work.
