TOWN COUNCIL MEETING January 19, 2021

The Town Council met January 19, 2021 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Department Heads

Mayor Hight asked the Council if officer Silas could keep his car for his security job until he retired. The Council agreed for Officer Silas to keep his car until his retirement date.

Fire Chief Parker had no business at this time.

Mayor Hight asked about the Storm Shelter. Fire Chief Parker stated that the fire department is going to clean it up and they will have a monthly schedule to keep it cleaned and up to date.

Daniel Avery had no business at this time.

Mayor Hight reported of 2 drains one on Jones St. and Franklin St., the one on Franklin St. has a sewer line running in the middle of it. Mayor Hight is going to have County Engineer to come out and to see what need to be done to repair them.

Mayor Hight recognized Mrs. Nunnally from West Medical Center Dr. Mrs. Nunnally asked the Council and gave pictures to them about 2 properties that have lots of junk on them. Mayor Hight explained he is working on this with the new Town attorney.
