## Behavioral Health Services with Wraparound Housing

**Program Services**

- Monitoring of tenants
- Maintain close relationships with community agencies who serve this population.
- Develop a service / treatment plan, assessment and other important documentation for participants.
- Refer for treatment as needed.

The Behavioral Health Services with Wraparound Housing program is a short-term 45 bed program for persons that are experiencing homelessness and have a disabling condition. Referrals come through CoC Coordinated Intake priority list. In addition to the 45 beds, there are 8 scattered site apartments for families.

The program offers complete behavioral health services with care coordination. Residents in the Wraparound Housing Program can stay up to 90 days. The goal is for a successful transition to permanent supportive housing, linkage to primary and behavioral health care, and income to sustain housing.

The Wraparound Housing program is open 24 hours a day, 7 days a week with staff at the facility at all times.

# Admission Criteria

All applicants are screened to ensure that they are appropriate for placement for admission into Wraparound Housing. Persons who are eligible for the program must meet the following criteria:

- must be 18 years and older
- must be homeless (in Hillsborough County)
- have a mental health or substance abuse diagnosis
- must be able to self-care and manage their behavior appropriately

The following individuals would be ineligible for admission:

- Individuals who are 17 years of age and younger
- Individuals determined to be beyond the safe management capabilities of the program
- Individuals who are drug dependent and present with acute withdrawal symptoms
- Individuals actively using sedative/hypnotics, tranquilizers, GHB, and/or other substances
- Individuals who have sex related charges will be reviewed on a case-by-case basis

## Funding Provided by:



All services provided include the Housing First philosophy. Assessments/service planning completed while at the program, include but are not limited to:

**Case Management Assessment** is completed as part of the admission process and completed within 24 hours of admission. This assessment is intended to inform the person served of service expectations while at the Wraparound Housing program.

**Individual Service Plan** is completed within 15 days of admission date. This plan establishes individual goals and measurable objectives, as well as time frames for completing these goals and objectives. The plan also includes types of interventions and the frequency of services to be provided. Your Person-Centered Plan is your personal plan on identifying what you want to accomplish while at the Wraparound Housing program and your personal plan on how you will go about achieving these goals. Your plan will also include your goals for permanent housing and establishing a firm foundation for your recovery.

### **Economic Linkage**

Upon admission into the Wraparound Housing program, persons served will be linked to financial resources that the person served does not have at the time of intake (i.e., Food Stamps, Hillsborough County Health Care, SOAR, etc.). This linkage will start within 72 hours of admission.

### **Person Responsible for Coordination of Care**

The primary person that is directly involved with service outcomes is the Case Manager, who will be responsible for keeping the person served updated on the housing process. The Case Manager completes the required assessments on the person served as well as assist the person served in completing their goal objectives.
