As a comprehensive, community-based behavioral health organization,

ACTS MISSION is to apply the best of contemporary physical and behavioral health interventions and social support services available to assist individuals and families to engage and succeed in recovery.

During Fiscal Year 2021 - 2022, the COVID-19 Pandemic continued to impact the organization. As with the previous year, we stayed the course and forged forward, resulting in another successful year. We adapted our service delivery models and remained fully operational all year long. We remained on Pandemic Alert Status and kept all COVID-19 safety measures and protocols in place. We were challenged by increased inflation rates and supply chain shortages, and we continued to struggle to recruit

and retain members of the workforce. In spite of these obstacles, we managed to expand services, reaching more people in the communities we serve.

One of my proudest accomplishments this year was opening a much-needed COVID-19 shelter for homeless Hillsborough County residents who needed to quarantine after being released from local hospital emergency departments. These patients had nowhere to go for COVID-19 recovery. ACTS created a safe place for them on our Drew Park Campus, and our team members, in addition to working their assigned programs, covered shifts to provide care. These are the kind of actions the community has come to expect from us. Our dedicated staff pulled together to make this shelter a reality in less than a week, and we even expanded it from 10 beds to 20 beds to serve more individuals in need. The COVID-19 Shelter opened during the Delta variant surge in late August 2021 and stayed open until October 2021.

Additionally, we were proud to partner with the Tampa Police Department to implement the first Mental Health Co-Responder Program in Tampa. Our clinicians team up with officers in response to crisis calls. Case managers from ACTS and other behavioral health organizations help complete the model. Finally, we expanded capacity from 6 beds to 20 in our AHCA licensed Intermediate Care Program located at 131st Avenue. This program serves Hillsborough County residents with mental health disorders and co-occurring substance use disorders and gives us the opportunity to grow in that area.

This was a year to focus on employee salaries and facility improvements. Adjustments to salaries were made within the last 12 months after a Market Rate Analysis was completed. Each job group was brought to or above current market rate ensuring that ACTS offers competitive salaries for all job groups. Several programs received extensive renovations and new furniture, and agency "colors" were established as the first step to rebranding. All facilities are now associated with ACTS colors, strengthening the identifiability of our service locations by improving brand awareness in the community.

As we close this fiscal year and head into the next, we know that we may continue to be impacted by the challenges of this past year, but we remain optimistic about our future. We are committed to our mission of healing individuals and families affected by substance use disorders and related mental health conditions. The dedication of ACTS leadership team, front-line staff, and our board of directors is incomparable. I look forward to continuing to partner together to provide the best treatment to our community for many years to come.

## **Array of Services**

### Crisis Care

Detoxification is the first step on the road to recovery. Our Detox Program for both adults and juveniles is the place to start the recovery process in a compassionate and supportive environment. Programs associated with Crisis Care include Adult Addictions Receiving Facility and the Juvenile Addictions Receiving Facility.

# Outpatient Services

Outpatient Services is to accommodate individuals by allowing them to remain in their homes and be able to work or attend school while in treatment. Programs associated with Outpatient Services include Outpatient Detox, Outpatient Assessment, Aftercare, Medication Management, Medication Assisted Therapies, Intensive Outpatient Program and Traditional Outpatient Program.

# Residential Treatment

ACTS Residential Treatment Programs are healthcare facilities providing evidence-based treatment for substance use and co-occurring disorders for both youth and adults. Programs include Keystone Residential Treatment Program in Tarpon Springs, two Intermediate Care Programs in Tampa, a program for veterans at Drew Park, the Amethyst Respite Center in Tampa and Youth Residential Treatment in Thonotosassa.

### Housing

ACTS Housing Division provides evidence-based housing intervention programs that combines affordable housing assistance with wrap-around supportive services for individuals experiencing homelessness, as well as other individuals with disabilities. Programs include Community Support Services, Emergency Bridge Housing and the HEART program in both Hillsborough and Polk Counties.

### Justice Services

ACTS has two full-service Juvenile Assessments Centers in Tampa and Bartow, Early Offender Diversion Program for individuals diverted from prison and two jail diversion programs serving Hillsborough County.

All ACTS programs work closely together to provide the best continuum of care for the persons we serve.











Team members gathered to celebrate the holidays together. Programs were encouraged to decorate for the holidays.


