

Ordinance Number 647.

An ordinance appropriating certain money's.

Be it ordained by the Mayor and commissioners of the city of Garnett, Kansas,

Section One:- that the sum of *Three Hundred and Fifty Five and 06/100* Dollars be and the same is hereby appropriated out of the General Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 6th day of December 1915, a list of which may be found on page 251 of the Journal of the proceedings of the Board on said date,

Section Two:- that the sum of *Four Hundred and Eighty and 20/100* Dollars be and the same is hereby appropriated out of the Water Works Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 6th day of December 1915, a list of which may be found on page 251 of the Journal of the proceedings of the Board on said date.

Section Three:- that the sum of *Three Hundred and Ninety Six and 99/100* Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 6th day of December 1915, a list of which may be found on page 252 of the Journal of the proceedings of the Board on said date.

Section Four:- that the sum of *Three Hundred and Eighty Four and 47/100* Dollars be and the same is hereby appropriated out of the Electric Light Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 6th day of December 1915, a list of which may be found on page 252 of the Journal of the proceedings of the Board on said date.

Section Five:- that the sum of *Two Hundred and Twelve and 08/100* Dollars be and the same is hereby appropriated out of the Water Works Improvement Bond Fund 1915, in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 6th day of December 1915, a list of which may be found on page ²⁵²₂₅₃ of the Journal of the proceedings of the Board on said date.

Section Six:- that the sum of *One Hundred and Thirty Five and 00/100* Dollars be and the same is hereby appropriated out of the Cemetery Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 6th day of December 1915, a list of which may be found on page 250 of the Journal of the proceedings of the Board on said date.

Section Seven:- that the sum of *Two and 70/100* Dollars be and the same is hereby appropriated out of the Fund of Sewer District Number (1) in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 6th day of December 1915, a list of which may be found on page 250 of the journal of the proceedings of the Board on said date

~~Section Eight~~ that the Mayor and city clerk be and are hereby authorized and instructed to draw warrants on the city Treasurer to pay the Bills allowed in the forgoing sections of this ordinance.

Section *Nine* that this ordinance shall take effect and be in force from and after its passage by the Board of commissioners and its approval by the Mayor.
