OLD AND NEW BUSINESS

Pailroad Avenue Utility Pole Relocation. I have placed this item under NEW Business. Duke Energy has contacted us regarding their plans to relocate the utility pole and underground service that is presently encumbering the former B&B Mower site. The PUCO has determined that Duke Energy must relocate the overhead and underground services even though there is no project planned for the site as of yet. We met with Duke's engineers to discuss the work and it may be implemented. There are two phases/tasks to the project. The first is the relocation of the street curb and sidewalk for approximately 50 feet in front of the B&B Property. I have discussed this with the City Engineer and he has provided a cost estimate of \$8,000 to do this phase. We would engage a contractor such as Prus Construction, Adleta Construction or Ford Development to this work for us. I would solicit a quote from each to determine the best contractor for the work. The City Engineer has determined that there is still 20 ft. of pavement/roadway remaining which allows for 2 way traffic on Railroad Avenue between the relocated curb and the edge of the parking area for the Railroad Depot on the south side of the street. We may paint a centerline in this location to guide traffic through this area.

The second phase is the underground service to the transformer that serves the Hosbrook House and Muchmore House. Once the new pole is installed (after the curbs are installed), then the conduit to the base of the pole to a point in our parking lot (approximately 110 linear feet) needs to be installed to remove the short portion of underground conduit that is presently on the B&B site. This is work that our Service Department can easily perform. Service Department personnel met with the Duke engineer this past week to discuss. Duke would be on site to assist. Our out of pocket costs would be for the plastic conduit (~\$1000) and some asphalt restoration in the parking lot. Per one suggestion from City Council, I also asked about potentially connecting the electric service to the transformer from Miami Avenue. The Duke engineer indicated that may very well be possible. It would require us (probably a contractor) to install the plastic conduit from the pole at the Miami Avenue entrance to A Tavola along the property line. By rerouting the feed from Miami, we would open up the parking area of the two houses for potential future construction or development. I hope to have information for this re-routing in time for Monday's Council meeting. I would ask City Council for a motion to direct the City Manager to seek cost estimates for the curb and sidewalk work so we can move forward with the bid process.

Salt Update. To date, we have used approximately 450 tons. Unless we have any more storm events, we will need to take delivery of the remaining 550 tons to meet our contractual obligations with Compass Minerals. The Service Department personnel indicated we can fit the remaining salt volume in our dome with the use of a conveyor (which we have used in the past) to maximize our capacity. The employees are also considering fabricating a solid door to replace the existing chain link gate; the solid door will allow more salt to be loaded through the roof hatch.



It is my hope that you will direct this correspondence to the appropriate person or persons at the P.U.C.O. The purpose of my letter is to inform the P.U.C.O that the city that I reside in is attempting to transfer the cost of an expensive electric pole relocation from two property owners and a developer, unto the backs of Duke Energy ratepayers and Madeira tax payers. I have provided some, but not all pertinent facts for your consideration.

- 1) The Madeira City Manager, Thomas Moeller provided an official "manager's report" for members of Madeira City Council. This report (attached) dated February 26, 2018 emphatically suggested that the Ohio Public Utilities Commission "has determined that Duke Energy must relocate the overhead and underground services even though there is no project planned for the site as of yet. We met with Duke Engineers to discuss the work and it may be implemented". This statement from Mr. Moeller apparently was a lie.
- 2) When presented with a copy of Moeller's "report" Duke Energy Electrical Facilities Manager Michael Clark, responded that "I believe there was a mid-quote or misunderstanding in the meeting minutes. The Duke legal department decided that the best course of action was to relocate the pole in question". Mr. Clark does not understand the importance of the report from Mr. Moeller, there was no mid—quote, and there were no minutes. Mr. Clark's explanation does nothing to explain Mr. Moeller's statement that references the P.U.C.O. role in commanding that the Energy Company "MUST" relocate the electric pole in question. - E) Madeira City Managers report dated March 12, 2018, stating that city of Madeira has approval, pending final review from Duke Energy's right-of-way department. This report no longer states that the P.U.C.O has instructed Duke Energy that the must relocate the Railroad Avenue Electric pole at Dukes cost.
- F) Madeira City Managers report to Madeira City Council members dated February 26, 2018. In this report Mr. Moeller states that the P.U.C.O instructed Duke Energy as follows, "The P.UC.O has determined that Duke Energy "MUST" relocate the pole and underground services" Moeller goes on to say that "Our out of pocket cost would only be \$1,000.00". At the council meeting that same evening, (February 26) Moeller was instructed to go back to Duke Energy demanding that Duke Energy also assume responsibility for another \$8,000.00 of related project cost.

Police Trust Fund, SR-51 DUI Fund and the Police Department Capital Outlay/Equipment in the General Fund. Chief Schaefer is out of town and will not be in attendance; if additional information is needed from him, we do have the opportunity to table this legislation to the March 26th meeting. However, in order to take advantage of the 15% discount, Motorola has placed a deadline of March 31st to approve the contract. **Recommend Approval.**

OLD AND NEW BUSINESS

- Preliminary Goal Setting Report. I have placed this item under Old Business. We should plan to discuss the preliminary report provided to you last week and come to consensus as to the priorities/project rankings. A final report (if changes from the preliminary report are needed) will then be prepared and published.
- Public Works Committee. We have several topics pending for the committee. Please check your schedules for times/dates. The topics include: Municipal Building Plaza, Street Program Update, and Water Line Replacement Update. Regarding waterline replacements, we are taking a step back and doing further analysis of which waterlines should be replaced as a precursor to repaving the street. We are not as confident as we would like to be regarding the information we have received from Indian Hill Water Works. Based on discussions we have had with the Budget and Finance Committee, and the concerns about future funding for waterline work, we are re-evaluating our schedule for replacing mains ahead of pavement work. The City Engineer's office is assisting with this evaluation. We will be providing this information in the next 60 days to both the Public Works Committee and the Budget and Finance Committee.
- Comprehensive Plan Update. The Planning Commission met this week to finalize its recommendation for the consultant. Council Member Adrien will report on the discussions. As well, a copy of the DRAFT meeting summary is included in the council packet. The Commission asked that I reach out to several of the communities who used MKSK and Envision for planning work. Both consultants received very positive recommendations/references. One reference that came in late for Envision was from the former city administrator for Fairport Harbor, Ohio. Envision did a Downtown Plan. Rebecca Corrigan is now the Twp. Administrator for Olmstead Twp., Ohio. She intends to hire Envision for their Comp Plan because she was so pleased with their efforts in Fairport Harbor. She spoke very highly of their team.
- Railroad Avenue Pole Relocation Update. As noted in last week's report, it appears we have approval, pending final review from Duke Energy's right-of-way department, to serve the transformer in back of the Hosbrook and Muchmore Houses underground from Miami Avenue. This would replace the existing underground service to the transformer from Railroad Avenue. Once we receive final approval, we will be obtaining costs from several contractors to do the "direct bore" installation of the conduit so Duke Energy can pull the new wires from the street to the transformer.

Address to Madeira City Council March 12, 2018

While in attendance at the most recent City Council meeting, the meeting of February 26, 2018 our city manager, Mr. Moeller presented his city managers report. Mr. Moeller stated in that report that the Ohio Public Utilities Commission "has determined that Duke Energy "Must" relocate the overhead and underground services even though there is no project planned for the vacant B&B Mower site" Apparently Mr. Moeller was less than truthful when conveying this false information to City Council and the community at large. Is there an explanation for the erroneous report?

At that same meeting, my friend, Councilman Gehring stated that Electric lines were improperly located over the top of the B&B Mower structure, on Railroad Avenue, and Mr. Gehring stated further that the Electric Utility Company, Duke Energy should be financially responsible for the entire project proposed for Railroad Avenue including the relocation of the Electric pole, construction of required curbs, and the installation of new underground service. There is substantial and clear evidence that Mr. Gehring comments were incorrect, and in fact neither Duke Energy Rate payers nor Madeira Tax payers should be responsible for the cost of any part of the aforementioned work.

The facts are clear that the front showroom added to the B&B Mower structure, (formally a residence) was allowed by our city to be

constructed on the Madeira City Right of Way. The Utility pole and all electric lines supported by the pole in question were on and above the city of Madeira right of way. The B&B Mower showroom was constructed illegally according to applicable zoning and building codes that were in effect. Any underground conduits and services were approved under the current city managers watch, also apparently contrary to Madeira requirements in effect at the time of approvals. Madeira Tax payers and Duke Energy ratepayers should not be financially responsible for any part of the proposed work.
