\_\_\_ The student and members of the household have not been diagnosed with the Coronavirus (COVID-19).

\_\_\_ The Studio Atlanta Dance & Vinings School of Art cannot be held liable from any exposure to the Coronavirus (COVID-19) caused by misinformation on this form or the health history provided by each client.

\_\_\_ If I take any steps to make a claim for damages against The Studio Atlanta Dance, Vinings School of Art, their agents, employees or any other released parties, I shall be obligated to pay all attorney's fees and costs incurred as a result of such claim.

The Studio Atlanta Dance & Vinings School of Art are following these enhanced procedures to prevent the spread of Coronavirus (COVID-19).

- All camper will be dropped off with studio employee outside the studio. No parents or guests will be allowed in the building.
- All campers will receive a temperature check each day upon arrival.
- All teachers and staff will be wearing masks at all times. Masks are recommended for students.
- All students will be required to wash their hands on arrival and at scheduled times during the day.
- Social distancing spaces for each student in the classroom and all other areas of the studio.
- Only 1 art teacher and 1 dance teacher with the group each day.
- No sharing of supplies
- Frequent cleaning surfaces throughout the day and overnight.
- If a student becomes sick, they will be separated from the group and parents notified immediately.
- If any students or staff become sick, they will not return for camp and all families will be notified that someone has become sick.
