

Off-Season Preparation Tips for Umpires

For umpires, the offseason is more than just downtime, it's the perfect opportunity to sharpen skills, stay in shape, and return to the field confident and ready for the next season. Here are a few ways umpires can prepare during the off months:

1. Stay Physically Fit Umpiring requires stamina, agility, and focus. Offseason conditioning with cardio, strength training, and flexibility exercises helps maintain endurance and prevents injuries once games begin.

2. Review Rule Books and **Updates**

Rules often change from year to year. The off-

season is a great time to review the rule book, study any updates, and revisit tricky scenarios that caused challenges last season.

3. Attend Clinics or Training Sessions

Many organizations offer umpire clinics or workshops in the off-season. These sessions provide refreshers, new perspectives, and opportunities to learn from experienced officials.

4. Watch Games and **Analyze Situations**

Reviewing game footage or watching professional broadcasts can sharpen judgment. Observing positioning, mechanics, and how situations are managed helps reinforce proper techniques.

Take time to think about

strengths and weaknesses from the past season. Set goals on whether it is improving strike zone consistency, communication with coaches, or positioning.

Rules Lawyer by Joe Rosenberg, Rules Interpreter

For the 2026 high school season the following rule changes will apply. Please note that some of our tournament ball will use Federation rules with local modifications. Make sure you are versed on the rules as the "Rec Ball" coaches may not know them. When addressing rules, remember to use proper rule book terminology. Also, with more softball, I will email

those changes and Points of Emphasis shortly.

1-2-9, 2-5-1h, 2-16-1h, 8-2-1, 8-2-2(a)1-7, 8-2-7, 8-4-1g(1)

- Modified that the double first base will be mandatory effective January 1, 2027 and associated rule changes.
- 1-4-4 Clarified what is allowed on a school's official baseball uniform.
- 1-6-3 Clarified what is not allowed to be worn by a

player to record or transmit audio or video feeds.

2-10-3 - Clarified the definition of a player-toplayer defensive meeting.

3-4-6 - Clarified the difference from a player-toplayer meeting and a charged conference.

Stay Sharp (answers to the last page)

- 1. The visiting pitcher walks the first batter in the bottom of the sixth inning. There have been no previous trips/conferences. The pitching coach makes a trip to that pitcher. After the trip, the head coach of the home team puts in a pinch hitter. The visiting head coach comes out of the dugout to make a second trip and replace the pitcher:
- A. Warn the head coach that he cannot make a second trip. If he continues, he is ejected and the pitcher will be substituted for after he completes the at-bat.
- B. Allow the trip and the substitution.
- C. Allow the trip but not the substitution.

- D. Warn the head coach that he cannot make a second trip. If he continues, he is ejected but the pitcher may remain in the game with no penalty.
- 2. B1 hits a foul fly near a chalked dead-ball area. F5 steps across the line with both feet and leaps, making the catch with both feet in the air. F5 lands with one foot in liveball territory and one in the dead-ball area:
- A. Foul ball because B1 was last in dead-ball territory before jumping to catch the ball.
- B. Foul ball because B1 landed with one foot in dead-ball territory.

- C. B1 is out and the ball remains live.
- D. B1 is out and the ball is dead.
- 3. B1 strains his knee sliding into second base on a double. He is not able to continue and the team does not have a substitute available:
- A. The most recent team B batter not on base is allowed
- B. An out is declared and the inning continues. to run for B1.
- The game is declared a forfeit in favor of team A.
- The team A coach can choose who runs in place of B1.

Bases only umpires, I have made a commitment this year to get you more involved with tournament assignments. Lesson learned from last year, 8U games are coach pitched, so only need an umpire to make out/safe calls from near the pitcher's mound. With your assistance, this will

allow other umpires to cover other 2-man games for me and the association. All I ask is to wear a ball bag and have an indicator with you. If you need a ball bag, please don't spend money, let me know, and I will give you one of my extras.

I know that it may appear there are multiple changes from last year and there are. More things are computer generated (Arbiter is much different than Zebraweb) and along with you, I am learning to have to adapt to these changes. If there are questions, ask. Some of you have already done so and are aware that I won't stop helping you until the problem is resolved.

A crucial point in the transition will be to remember to used the SJUA account #114548.

When you first log into the Arbiter console, you may be presented with two SJUA accounts— #114548 and #101882. The latter is our old account. We may not be able to remove the old (101882) account from showing.

Make sure you log in to SJUA #114548 going forward.

On a second note—now is a great time to register for the 2026 season. You can register right in the Arbiter website. Log in to the site and go to Eligibility > Registration.
