SELECTMEN MEETING MINUTES
TUESDAY, JANUARY 29, 2019, 6:30 P.M.

Attendance: Selectmen: Jeffrey Sanborn, Dwight Warren and Jim Dolloff as well as members of the Public.

1. **Selectmen Meeting was called to order approximately at 6:30 PM by Jeffrey Sanborn.**

2. **Review/ Approve meeting minutes**

Jeff Sanborn requested making a motion to accept and approve January 15, 2019 meeting minutes. Jim Dolloff made a motion, Dwight Warren seconded the motion; Selectmen voted 3-0 to approve meeting minutes.

3. **Review/ Approve warrant**

Jeff Sanborn requested making a motion to accept and approve January 29, 2019 warrant. Jim Dolloff made a motion, Dwight Warren seconded the motion; Selectmen voted 3-0 to approve the warrant.

4. **New Business**

- John Leavitt – Bridges of Maine – John requested to use the facility for Bridges of Maine. It is a nonprofit organization that works with individuals and families with disabilities. He wants to use the gymnasium for a nerf group. The kids benefit by getting exercise and communicate. Selectmen wants to check with MMA insurance before granting usage of the building. The nerf group does not wear protective eye equipment and want to be sure the town is not liable if there is an injury. Selectmen office will check with MMA and get back to John.
- Selectmen voted 3-0 and signed the revised letter on GA case 2019-01.
- Fred Miner written resignation was received. Selectmen voted 3-0 to accept Fred's resignation and sign the letter.
- Planning Board – Alternate position open. Selectmen discussed nominating Sue Olafsen for the position. Will discuss further with planning board.
- Remembrance in Town Report. Will discuss more during workshop.
- Selectmen voted 3-0 to purchase a needed dolly and care for the community center.




Adjournment

A motion was made by Jeffrey Sanborn and Selectmen voted 3-0 to adjourn the meeting at approximately 7:30PM.


