Dear Beloveds in Christ,

"Now among those who went up to worship at the festival were some Greeks. They came to Philip, who was from Bethsaida in Galilee, and said to him, 'Sir, we wish to see Jesus.'" (John 12:20-21)

When I was in college, I sold books door to door in Alabama. One home that I approached was a trailer with no door - it had burned at some point and there was a smell of decay in the air. We were taught in Sales School that you knocked on every door. Since there wasn't a door, I knocked on the wall. A young mother with two small naked children came. I told her I was selling books. Her face lit up. She said, "Do you have any about Jesus?" And when I said yes, she came back with a jar full of coins that she emptied into my hands. "I want Jesus for my kids," she said.

I have thought about this young mother and her children for decades now. I still wrestle with my decision to take her coins rather than just giving her the book. I wonder how the children grew up. I hope that they soon moved out of that shack and into a place with at least a door.

But her question has stayed with me the most, "Do you have any about Jesus?" It is so much like the plea from the gospel of John quoted above, "Sir, we wish to see Jesus."

Are we not still asking this today? To see Jesus and to be seen by Jesus. To truly see and be seen in holy community.

In this time in history when there are so many things that are difficult – in our personal lives, in this nation, in this church – we are all longing for Jesus. The very world, in its beauty and in its brokenness, is longing for Jesus.

I encourage you, as you gather for your annual meeting – and as you discuss budgets and maintenance and worship attendance and the building and salaries and all of the things needed to keep the organization of church going – to also, perhaps mostly, think about the question this young woman was so eagerly asking, "Do you have any about Jesus?" The longing that goes back to some Greeks who ran into Philip one day 2000 years ago. "Sir, we wish to see Jesus."

I pray that as you gather, much of the conversation is about how Jesus sees you and how, through Jesus, you see each other and the world. What are some ways that this is made tangible in your community? Where are we falling short? Where is Jesus being shown to us outside of the church buildings and even outside of Christian community?

Above all things, I pray that as you gather, you experience the love and grace of Jesus. While we don't have the answer for all things that are happening or are coming in this next year, we do know this, Jesus is with us. The Spirit is journeying with us. We are held in God's hands. And when I see you, I see Jesus.

Thank you for the honor of being your Bishop. I am so thankful for you.

# **Standing Rules for Congregational Meetings**

1. Anyone may speak during the time that the Chair calls for comments or action from the floor. If you need to get the Chair's attention you can either wave your hand on the screen or use the Zoom command to raise your hand or write in the comments that you would like to speak. Comments will be limited to two minutes per speaker for each topic at the direction of the Chair. Comments must be directed to the Chair.

This meeting will be recorded for the accuracy of the minutes. When the Chair recognizes a speaker they should only direct their comments to the Chair and they shall only speak to the issue that is before the congregation. No personal comments may be directed to another member of the congregation. However, one may request that the Chair obtain clarification or information on the topic from someone else in the congregation.

2. The Chair is responsible for adherence to the agenda. Additional time may be given to a speaker if time permits. Decisions of the Chair can be overruled by a 2/3 majority of the congregation.

It is the task of the chair to accomplish the work of the agenda as voted on by the congregation at the beginning of the meeting in a reasonable amount of time. They are also to allow for the presentation of sufficient, relevant information for an informed action to be taken by the congregation. The chair may allow any person more than the two minutes of allotted time in consideration of these factors. A timekeeper may be appointed by the chair.

3. When a new main motion is presented, please present it in written form to the secretary in the comments section for inclusion in the minutes. It must be signed by a voting member.

The presentation of a written motion for action allows for an accurate reading of the motion and inclusion. The person presenting the motion will give the written motion to the secretary after the initial reading from the floor. Either a second signature, or presentation by a recognized committee, will fulfill the obligation of obtaining a second motion.



# Congregation Annual Meeting Minutes January 30, 2022

#### DRAFT

#### Meeting Room Open/Quorum Reached:

The meeting room opened at 11:30 so that members could check in prior to the 12 noon start time. For those who had more than one person sharing meeting access, instructions were given on how to modify the "participant" name on Zoom so that first and last names were shown. This allowed all persons at each location to be identified and counted. A quorum was reached by 11:50 a.m. Information was then provided on how to use the new closed-captioning. At its highest point, there were 88 members in attendance.

#### Call to Order:

President Holly Batstone called the meeting to order at 12:00 p.m.

#### **Devotions:**

Pastor Berg took the devotion from 1 Corinthians 2:1-5, where Paul wrote about what it means to bring the Word to the people. Pastor Berg asked how do we, in the modern world, deconstruct our faith? The word "deconstruction" isn't a negative thing, but helps us break out of our preconceptions and misconceptions of the world so that we can see it with clear eyes. He stated that at First Lutheran Church (FLC) we have been doing that for a while – asking who we are and how we can be better in the world. Much of that involves embracing change. We constantly need to call on ourselves to break down who we are so that we can build up a better body of Christ. Each time we receive new members we become a new church and a more diverse and more precious body of Christ.

#### **Introduction of Current Council Members:**

President Holly Batstone introduced the current church council: Roger Wolter, Vice-President; Ho Brown, Secretary; Stephanie Almeida; Karey Coble; Lloyd Condra; Christy Freriks; Craig Lichtenstein; Andrea Peoples; Johannes Skjonsby and Randall Wampler. Holly thanked the entire council for their work this year and gave special thanks to Roger, Karey, Lloyd and Andrea for all of their years of service and support on the council. These four members stepped off council this year because their terms have expired and/or because they have other commitments.

#### **Google Docs Voting Procedures:**

Holly explained how the voting would be accomplished. The process allowed multiple people sharing a single computer to vote independently. Christy Freriks took the one voice vote cast by a member who was on the phone.

#### **Standing Rules of Order:**

Holly reviewed the Standing Rules of Order for congregational meetings as specified in the 2021 Annual Report.

#### Initial Ballot

The first ballot included the following three questions: 1) approval of the meeting agenda; 2) approval of the January 31, 2021 annual meeting minutes and 3) approval of the Standing Rules of Order. The question was asked if there were any changes and/or corrections to the January 31, 2021 meeting minutes. None were identified and the voting proceeded, with Christy taking 1 voice vote. All 3 items on the first ballot were approved as follows:

Meeting Agenda: Total Responses – 75; Approved - 75; Opposed – 0; Abstained – 0 Annual Meeting Minutes for 1/31/21: Total Responses – 74; Approved - 73; Opposed – 0; Abstained – 1 Standing Rules of Order: Total Responses – 74; Approved - 73; Opposed – 0; Abstained – 1

#### Annual Report:

The question was asked if there were any changes to the annual report. Corrections to some items on page 17 of the report were requested. The 2021 Church Council Roster showed Johannes's term expires in <u>1/21</u>; it should be <u>1/24</u>. The note under nominees for the 2022 council stated <u>4</u> nominees will serve a 3-year term ending January <u>2024</u>. <u>Five</u> positions were actually open and any 3-year terms will end in January, <u>2025</u>.

#### President's Report:

President Holly Batstone reported that the council met monthly on Zoom and had one extended meeting during which time the council was able to do a deeper dive on some subjects. It's anticipated that multiple extended meetings will also occur in 2022. Holly shared that a council liaison was assigned to each member of the congregation, communicating with the congregation through various methods. The goal was to provide the congregation with a direct connection to the council to whom questions and issues could be referred. This also provided an opportunity for each

person to get to know the other. The council plans to continue this activity in 2022, although the liaison-to-members assignments may change.

Holly stated that COVID-19 was a constant topic of discussion during all of the council's meetings and commended the COVID-19 task force for doing an incredible job. The task force monitored the ever-changing situation throughout the year and continually updated and provided recommendations to the council.

Holly then congratulated the entire congregation for the amazing accomplishment of paying off the mortgage in 2021, commenting that this was probably the biggest highlight, financially, of the entire year. We now own our church! Holly thanked the congregation for their continued generosity and for the significance of such a celebratory achievement.

Last, Holly discussed how the council has revisited our Vision 2025 goals. She reminded the membership that those who created the vision had no idea that a pandemic would impact our world soon after the *Vision for Mission* – 2025 was published. Holly described how the council is determined to move forward with this work, in spite of a pandemic, by being creative, thinking outside of the box and praising the Lord and doing good work in His name.

#### Pastor's Report:

Pastor Berg reminded the congregation that his annual report is printed in FLC's *Annual Report*. It primarily focused on the pandemic, so he used the annual meeting as an opportunity to discuss other items. Pastor Berg noted that he will have been at FLC for 12 years as of June, 2022 and his sabbatical is coming up in 2 years.

Pastor Berg shared that he is just now realizing the scope of the struggle that he has had over these last 32 or so months. A lot of it has to do with the number of changes that have taken place, whether it's changes in worship or meeting habits, how we are connected and the biggest change - how we interact with our community, especially as clergy. He mentioned other events that impact the church, such as book bans and the rise of white fascism. We are a church that believes in freedom of self and freedom of communities. What is our reaction to this kind of authoritarian presence among us and how do we have a voice in this?

Pastor Berg stated he believes that revitalizing our effort on Vision 2025 will be a great propeller to move us into God's preferred future for us. He is looking forward to being more creative to find new ways to gather and to reconnect with each other as we come out of the pandemic. He then read the paraphrase from 1 Timothy 6:11-12 that he had written at the end of his annual report, asked that we continue to be the light in the world that it needs and thanked the congregation for allowing him to be its pastor.

#### **COVID-19 Report:**

Johannes Skjonsby reported that the task force continues to meet regularly, and provided an updated presentation from the task force's last report that was presented in April, 2021. Statistics included current data for King County and vaccine statuses for both King and Snohomish counties. The task force uses recommendations from the health departments, King County, the CDC and state and federal information as well. The current recommendation is that large groups can continue to meet, assuming that everyone is fully vaccinated, including a booster shot for those who quality. Masks are required for anyone 5 years of age and older, with proper coverage over the nose and mouth. The N95 and surgical-grade masks are more beneficial in lowering the transmission rate. If cloth masks are used, the recommendation is to wear two cloth masks.

Johannes then discussed the possibility of a new Omicron variant as well as some reporting that Omicron may be transitioning to an endemic stage. He ended the presentation by stating that if anyone has any questions or concerns, to please reach out to any member of the council or Pastor Berg or contact the task force directly. All questions do get passed to the task force. Christy Freriks provided the following link in chat for anyone who would like to order free athome tests from the federal government: https://www.covidtests.gov\

#### 2022 First Lutheran Church Budget:

Dan and Ann Bormann presented the proposed budget for the General Fund for 2022. Dan stated that although the mortgage was paid off in April 2021, we continue to collect funds for capital improvements to pay for existing building repairs such as the entryway beams, parking lot repairs, skylight repairs and to accumulate funding for a new roof in the future. Dan provided specifics on pledges for 2022 compared to 2021. He also mentioned that for those who give through an Individual Retirement Account (IRA) Required Minimum Distribution (RMD), it is a very tax-efficient way of giving to the church.

Dan noted that there is an updated copy of the budget; the data did not change but some dates shown were incorrect. The 2021 year ended with income exceeding expenses by \$4,867. Ending the year in the black was due to strong financial support from the membership; in-person Christmas Eve services; and because expenses ran significantly below the budgeted amount, primarily due to the cancellation of several programs and in-church activities. The \$4,867 will be transferred to the Reserve Fund.

The proposed 2022 budget has a negative ending balance of \$28,084. Dan explained that we are allowed to approve a deficit budget as long as the church has reserves to cover it. The Reserve Fund balance for the beginning of 2022 is \$121,543, which is more than adequate to cover the proposed budget deficit. To achieve the proposed budget, some committee expense requests had to be reduced. For example, Social Ministries has a fund account with a balance of \$11,000 that can be used to support some of their requests. These funds came from the profits of Scrip sales, which shows the value of the Scrip program.

Dan stated that flower expenses were also increased because we are worshipping in-person again. This expense could be reduced if members who have a special occasion would like to fund the flowers for that week. Pink forms are available on the bulletin board near the children's corner in the inner narthex for that purpose. The Building & Property section of the budget had the most significant change: the committee requested \$60,000 to repair the beams in the entryway and \$10,000 for parking lot repairs. These expenses will be covered by the Capital Improvement Fund, which has a current balance of \$70,710. Accruals for the Building & Property reserve fund and the van replacement fund have been suspended for 2022.

Regarding Personnel, the budget provides for a 4% increase in all salaries and a 3% increase in the pension and benefit expenses for full-time employees. A new line, account 5.9055, was added under Personnel for \$780.00 to support the mileage expenses associated with the Pacific Lutheran Theological Seminary seminarian who was placed with FLC. This increase in expense was offset by a reduction in the mileage budgeted for other personnel.

Dan clarified how fund accounting works for churches. The budget for the General Fund is for the operation of the church and is the only budget for which the congregation can vote. The church has about \$300,000 worth of other funds that are restricted and can only be used for certain purposes. He then provided examples of some of these restricted funds and their current values.

All inquiries were responded to and a vote was taken to approve the proposed General Fund budget. There was a total of 79 responses. The 2022 budget was unanimously approved.

#### Washington Poor People's Campaign:

Stephanie Almeida proposed a motion from the church council to support the Washington Poor People's Campaign (WAPPC), as follows:

"Whereas First Lutheran Church of Bothell identifies itself publicly as a welcoming congregation and we, as a congregation, have an established Vision for Mission - 2025 which guides our council's decisions and future planning, therefore the FLC Church Council moves to align and join with the Washington Poor People's Campaign in order to leverage and support their cause and endeavors while furthering our own vision to "be partners with our community to promote the well-being of our neighbors" and to "care for all of God's creation."

A discussion ensued, primarily around the church's financial obligations, if any. It was clarified that the motion is for FLC to show support and show that we are aligning ourselves with the WAPPC; there is no financial obligation. All questions that were asked were answered. A total of 81 votes were cast, including 1 voice vote. The motion was approved with results of the voting as follows: Approved -76; Opposed -3; Abstained -2.

#### **Council Elections:**

Kaaren Hatlen, chairperson of the Nominating Committee, stated that there are 5 open positions due to the departure of 4 members off of council plus 1 vacant seat that remained unfilled in 2021. Kaaren announced that Jean Peterson, Jess Faubion and Kristi Pyne have all agreed to run for council. Two additional members were needed and Kaaren asked for any self-nominations.

Holly explained that FLC's constitution requires a minimum of 12 members on the council (up to a maximum of 18). If all 3 of the current nominees were to be elected, the council would still not meet the minimum requirement. If the minimum requirement cannot be met, then the congregation would need to discuss going through the process to change and ratify the constitution to lower the minimum requirement.

Questions were addressed and Gary Curtis and Karen Johnson both volunteered from the floor. Pastor Berg asked Karen to fill Roger W.'s position, thereby serving a 1-year term as Roger had to leave council with 1 year remaining of his 3-year term. Karen agreed to do so. Including 1 voice vote, 82 responses were received. All proposed nominees were elected, as per the following results: Jess Faubion, Kristi Pyne, Jean Peterson and Gary Curtis each received 82 votes; Karen Johnson received 75 votes.

#### **Changes in Constitution Provisions:**

Holly declared that we do not need to pursue any immediate changes to the constitution because the minimum required number of council members was fulfilled. The council has discussed some minor changes and may decide to pursue

those this year. If council does move ahead with any recommendations, the congregation will be given at least 30 days' notice prior to presenting any changes to the congregation for a vote.

#### **Nominating Committee Elections:**

First Lutheran Church's constitution dictates that the Nominating Committee has six voting members, each serving a one -year term. Committee members may be elected for two consecutive terms. In addition, the constitution recommends that two members of the committee are outgoing council members. Lloyd Condra has agreed to serve on the committee. Pastor Berg nominated Andrea Peoples as the second outgoing council member. With self-nominations from the floor, the slate of nominees included: Lloyd Condra; Pat Daane (2<sup>nd</sup> year); Andrea Peoples; Tom Payne; Derrick StaRosa and Carsten Thode. There were 77 votes cast, including 1 voice vote, and all 6 nominees were unanimously elected with 77 votes for each.

#### NW Washington Synod Assembly Meeting Lay Voting Members:

Holly announced that the Synod Assembly meeting will be held on Saturday, June 4<sup>th</sup>, 2022, from 9:00 a.m. to 4:00 p.m., at Trinity Lutheran Church in Lynnwood. She requested 5 self-nominations, specifically: 1 woman; 2 men; 1 youth (under age 18) and 1 young adult (under age 30). These specifications were defined by the Synod so that the assembly has equal representation. Pastor Berg described the work of the assembly, including voting on the Senate budget; elections to leadership roles and working on resolutions that encourage the church to pursue certain areas, such as in areas of justice. Questions were answered and Jacky Schnarre and Paul Flatness volunteered. A total of 70 members, including 1 voice vote, cast their ballots in the NW Washington Synod Assembly Meeting lay voting members election. The two nominees were elected, with Paul Flatness receiving 69 votes and Jacky Schnarre receiving 70 votes. Pastor Berg stated that the remaining seats will be appointed by the council.

#### **Closing Prayer**:

Pastor Berg led the congregation in a closing prayer.

#### Adjournment:

Council President Holly Batstone adjourned the meeting at 1:53 p.m.

#### **BUILDNG AND PROPERTY COMMITTEE**

The Building & Property Committee is responsible for maintenance and minor repairs to the building and grounds. They also make recommendations to the Council for major projects to the property and grounds. They also approve building use requests.

In 2022, the parking lot was resealed and restriped; the Amazon Bot dispenser box remained on site (the program is scheduled to expire in 2023. The main entrance portico was refurbished (including primary beam replacement); one skylight was replaced and the remaining skylights were inspected and re-sealed. The committee managed air conditioning repairs, minor vermin infestation, appliance repairs and required infrastructure inspections.

Current building issues include: parking lot asphalt repairs and continued roof maintenance. On the first Tuesday of the month these servants meet via Zoom to discuss physical plant issues: Richard Keltner (chair), Jeff Almeida, David Osborne, Christy Freriks (council liaison), Audrey Fisher, Mark Schnarre, Jess Fabion, Roger Wolter, Roger Steinke & Pastor Berg.

#### CHRISTIAN EDUCATION COMMITTEE

Christian Education is a vital ministry of First Lutheran's mission of caring, growing, serving and proclaiming. From preschool through adult education, programs and activities are offered year -round for all of God's Children.

#### Sunday School (Preschool - Grade 6):

Sunday School begins in the Sanctuary at 9:45 AM with an Opening, which includes a message, music and singing. Bible Lessons are taught using animated videos, Bible reading, crafts, activities and storytelling. A combined class meets for 3-year-olds through 6<sup>th</sup> Grade. There are 8 students enrolled, with 9 different adult and high school youth leaders.

Middle School Confirmation Program (Grades 7 - 8): 4 students participated in this program during the Spring and 4 students were confirmed in 2022. 4 students are currently enrolled in the Fall and Winter session.

<u>Vacation Bible School:</u> "Masterpiece!" VBS was held July 11- 14. Preschool and Kindergarten students met from 9 AM to 12 PM/Noon. Students in Grades 1 - 6 met from 9 AM to 3 PM (included lunch). 50 students were registered and 25 staff served. A great VBS experience!

Adult Education / Journey Classes: Sunday Morning Adult Classes, Tuesday Morning Lectionary Classes and occasional Journey Classes continued to meet in-person and online.

Men's Saturday Breakfast and Bible Study: A group of 15 - 22 men attend this monthly gathering on the 3rd Saturday morning of each month, both online and in-person.

The First Lutheran Church Book Club and Movie Review Nights: These groups continue to meet monthly on Zoom. The Book Club discusses a variety of book titles with 12 - 18 participants per meeting. Movie Nights review a variety of films with 8 - 12 participants per meeting. We enjoy meaningful discussion and fellowship at these gatherings.

The Christian Education Committee is hopeful about the opportunities for growth in the children's, youth and adult education programs. We pray that God may continue to bless, guide and direct the education ministries of First Lutheran Church as we proclaim God's love to the people in the Bothell and Northshore area.

During the past year, Kristin Smith served as Office Manager/Bookkeeper, Bob Berg served as Treasurer and Melanie Veazey served as Financial Secretary. The Finance Committee met monthly on the second Tuesday.

As of 12/31/2022, expenses over income was (\$10,088). We will transfer \$10,088 from the Reserve Fund to the General Fund to cover this negative balance. A negative balance was budgeted in 2022 budget as we have done the past several years. This is the second time in ten years that we actually have a negative ending balance for the year.

Through the General Fund we shared 7.3% of our pledges and loose offerings with the ELCA in Mission Support. Through pledges and loose offerings, we shared 2.1% through Social Ministries. In addition, Social Ministries funding was generated through Thrivent Choice elections and the SCRIP program. The SCRIP program funded Lutheran World Relief school kit items and shipping for school kits, quilts and health kits.

We thank the offering counting crew for their dedicated service to counting our offerings. During the pandemic, our crew has been Gordy Phelps and Melanie Veazey.

We will continue to receive Capital Improvement Fund donations, which will be accrued for future roof repair/replacement and other building maintenance projects. The Capital Improvement Fund account balance is \$77,562.67. The Building

and Property Committee used funds in 2022 for the parking lot maintenance and restriping, and to repair the rotted wood beams in the entryway. The final bill for the entryway repair will be paid in 2023.

During the fall stewardship program, for fiscal year 2023 we received 78 General Fund pledges and 38 Capital Improvement Fund pledges. For fiscal year 2022, we received 84 General Fund pledges and 36 Capital Improvement Fund pledges. We base projected income on historical giving for the pledges not received.

The past year's receipts, detailed expenses, and current fund balances are reported elsewhere in the annual report.

#### LIBRARY COMMITTEE

Committee members include Ann Aagaard, Donna Gilbery, Marilyn Sides, Linda Siebert, Roger Steinke, and Katie Pyne..

The publication of our "Our Pandemic Story- 2020" is a reminder of how we found fun and meaningful ways to make it through the most difficult first year. In addition to making the book available in our library, an additional 31 copies were purchased by individuals.

The library continued to add new books to our collection. In addition to the monthly book club book, new acquisitions included a variety of children's books focusing on living together in community and an assortment of Advent devotional books to help us find quiet moments and discover new meaning in the busy holiday season.

We are sponsoring the "Share your Favorite Photo" contest and are initiating a new oral history project.

The monthly 4<sup>th</sup> Tuesday book club discussion group continues to be well attended (12-14) The 12 books of 2022 totaled 3506 pages (longest book being 404 pages and shortest 174). There were 6 different genres of biography, fiction, historical fiction, memoir, nonfiction, and a new genregraphic novel.

#### PERSONNEL COMMITTEE

Committee Members: Holly Batstone, Kaaren Hatlen, Dave Freriks and Pastor Berg.

Meetings are held on the third Tuesday of each month at 6:00 pm. The Personnel Committee focuses on issues related to our Church staff, such as setting and updating personnel policies; establishing and maintaining current job descriptions; reviewing performance; setting salary levels; and approving search task forces.

#### SOCIAL MINISTRIES COMMITTEE

Members: Alain Adjorlolo, Gary Curtis (Council Liaison), Kathy Konieczka (chairperson), Donella Robbins, Ray Thomas, and Roger Steinke (staff).

This committee oversees and coordinates activities that help people in our community and beyond. Each month, a different organization receives a financial gift, to support their work and ministries. During 2020 we continued to support frontline services helping those in need during the Pandemic, natural disasters and refugee support. These organizations include Compass Housing Alliance, Hopelink, Lutheran Community Services, Earth Ministries, ELCA World Hunger, Lutheran World Relief, Poor People's Campaign, Lutherwood Camp and Retreat, Lutheran Immigration and Refugee Services, Faith Action Network, and Lutheran Disaster Response. Our rent subsidy program with Compass Housing, with a client receiving \$1,000 over a six month period, was temporarily suspended for the second half of 2022 due to staffing issues at Hopelink. We plan to resume this program as new clients are identified.

We continued to conduct business through email and Zoom meetings this year. Many in our congregation helped to sew and stuff the much needed school bags and support our Quilter's ministry at two Quilt-A-Thons. All the fabric for the school kits and quilts was donated. We provided funds for materials and shipping for the 568 LWR School Kits, 409 Personal Care kits and 316 Quilts through the income earned on Scrip sales. Thanks to our congregation buying gift cards through our Scrip program, the \$8,500 costs of these and other special projects was covered. Thank you so much for your generosity.

In February, March, April, November and December, we held food drives and collected over 2700 food items for Northshore Nourishing Network to support local food pantries.

Through generous donations from our congregation, in October we collected 864 items for Compass Housing's "Socks and 5 Most Needed Items" campaign. We purchased 75 pies and whip cream for all of Compass Housing clients, that were delivered in time for Thanksgiving. Giving for our Christmas campaigns provided over \$2,200 in gift cards for Compass Housing families.

In January, after a period of discernment, the congregation approved becoming a Faith Partner with Washington Poor People's Campaign.

Social Ministries also supports the work of the Faith Action Network, which provides advocacy in Washington State. Members regularly attend Advocacy Day in Olympia.

The committee also works with the Christian Education Committee in providing educational and informative Journey Classes that support social ministries and organizations.

#### YOUTH COMMITTEE

Youth Ministries are a vital part of First Lutheran's mission of caring, growing, serving and proclaiming. Activities and programs are offered year-round for elementary, middle school, high school and college students. The ongoing Coronavirus Pandemic continued to interrupt, postpone and modify the congregation's Youth Ministries.

Monthly Zoom youth events, emails, greeting cards, phone calls and texting were a few of the ways we have continued to stay in touch with our young people during this pandemic.

We were so thankful that in-person events returned in June! Our group enjoyed an outdoor event at the Coble home with games, smores and a fire pit. Several young people enjoyed trips to Five Guys and Arby's for food and fellowship during the summer. A Mission Trip to Camp Lutherhaven took place in early August with 12 youth and adults attending. Our service activity was splitting and stacking several chords of firewood. We also enjoyed a variety of camp and water activities and a beautiful day at Silverwood Theme Park.

In-person activities continued in the fall with visits to Sparta's Pizza Restaurant and McDonald's. A highlight was visiting Swans Trail Farms in October where we explored the Corn Maze, Pumpkin Patch and enjoyed many other fall-related activities.

College Care Packages were assembled and sent out to 15 college students in November. Instead of preparing a Thanksgiving meal at the Church, our youth assembled over 50 turkey sandwich box lunches for pick up after worship services. This was a popular event! In December, we went bowling and visited the Lights of Christmas in Stanwood.

Our committee is very thankful for the congregation's ongoing help and support with our Youth Ministries! We are hopeful about the upcoming opportunities for growth and the congregation's ministries with young people. We pray that God may continue to bless, guide and direct the Youth Ministries of First Lutheran Church as we proclaim God's love to the people in the Bothell and the Northshore area.

#### Receive our prayer, O God.


Guide us to be a healthy congregation that learns from its failures as well as its successes and offers wisdom to others.
