

Ordinance Number 646,

An ordinance Appropriating Certain money's

Be it ordained by the Mayor and Board of Commissioners of the city of Garnett Kansas.

Section One:- that the sum of Seven Hundred and Seventy Four & 40/100 (\$774.40) Dollars be and the same is hereby appropriated out of the Funds in Sewer District Number ~~two~~<sup>one</sup> in the hands of the City treasurer to pay the Bill for Interest and principal due December 1st 1915. on the sewer Bonds of said District allowed by said Board at a regular meeting of said Board held on the 15th day of November 1915, a list of which may be found on page 249 of the journal of the proceedings of the Board on said date.

Section Two:- that the sum of (\$60.50) Sixty & 50/100 Dollars be and the same is hereby appropriated out of the funds of sewer district number three to pay the Bills allowed against said fund at a regular meeting of said Board held on the 15th day of November 1915. a list of which may be found on page 249 of the journal of the proceedings of the Board on said date.

Section Three:- that the sum of Six Hundred and 00/100 (\$600.00) be and the same is hereby appropriated out of the Main Sewer Interest Bond fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 15th day of November 1915. a list of which may be found on page 249 of the journal of the proceedings of the Board on said date.

Section Four:- that the sum of Three Thousand And 00/100 (\$3000.00) be and the same is hereby appropriated out of the Main Sewer Bond sinking fund in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 15th day of November 1915. a list of which may be found on page 249 of the journal of the proceedings of the Board on said date.

Section Five:- that the sum of (\$2000<sup>7.25</sup> Two Thousand and <sup>Seven and</sup> 25/100 dollars be and the same is hereby appropriated out of the Water works Improvement Bond fund in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 15th day of November 1915. a list of which may be found on page 249 of the journal of the proceedings of the Board on said date.

~~Section Six:- that the sum of \_\_\_\_\_ Dollars be and the same is hereby appropriated out of the Electric Light ~~fund~~ fund in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 15th day of November 1915. a list of which may be found on page \_\_\_\_\_ of the journal of the proceedings of the Board on said date.~~

Section ~~Six~~<sup>Seven</sup>:- that the mayor and city clerk be and are hereby authorized and instructed to draw warrants on the city treasurer to pay the Bills allowed in the forgoing sections of this ordinance.

Section ~~Eight~~<sup>Eight</sup>:- that this ordinance shall take effect and be in force from and after its passage by the Board of commissioners and its approval by the mayor.
