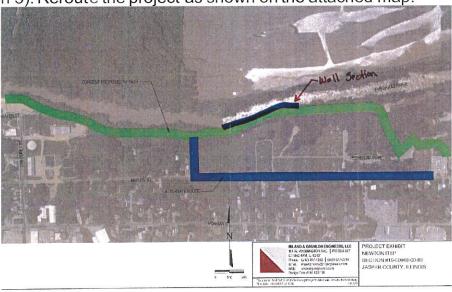
7. PUBLIC COMMENTS/COMMUNICATIONS: Lee Beckman: Riverwalk updates
