



INTRODUCTION

American Engineering Testing Inc. (AET) is pleased to provide this proposal for the drilling and installation of a replacement groundwater monitoring well in Summerset, South Dakota. This proposal is based on the information provided and defines the general scope, completion schedule, and estimated cost for our work.

PROJECT INFORMATION

We understand the project will consist of the replacement of the existing piezometer labelled Boring B-1 (AET Report No. 17-20531 dated July 9, 2019), with a new approximately 50 to 60-foot groundwater monitoring well at the same location, located west of Sun Valley Drive in Summerset, South Dakota. AET anticipates access to the soil boring will be possible for a truck or track-mounted drill rig and support vehicle.

SCOPE OF SERVICES

Field Exploration

Based on the information provided, we propose the following scope of services:

- Arrange clearance of underground public utilities through SD One Call.
- Perform one (1) SPT soil boring at the site to a depth of 50 to 60 feet below grade. The boring will be advanced with hollow stem auger (HSA) using a truck-mounted or track-mounted drill rig.
- The boring will be completed as a 2-inch diameter PVC groundwater monitoring well and consist of approximately 50 feet of slotted pipe and 10 feet of solid pipe.
 The well will be backfilled with sand, bentonite and auger cuttings in accordance to State guidelines. Any additional cuttings will be thin-spread on site near the

boring location unless directed otherwise. Additional work for soil disposal may be added as an additional fee.

Before we drill, we will contact One Call of South Dakota to locate public underground utilities. One Call of South Dakota does not currently charge for this service, but they will not locate private underground utilities or structures. Examples of private utilities include, but are not limited to, propane lines, sewer laterals, sprinkler systems, site lighting, and electric and data lines between buildings. The property owner is responsible for locating all private underground utilities and structures. Please provide us with any maps, plans and records showing the location of all private utilities and structures.

We can provide you with names and contact information for private utility locators. These companies usually charge a fee for their services. Also, please note that private locators cannot guarantee that all private utilities will be located. For the private locator to be accurate and effective, the property owner must provide maps, plans and records showing the location of all private utilities and structures. The property owner must also provide a knowledgeable site representative to meet with the private locator and AET personnel.

AET shall be entitled to rely upon the accuracy of all location information supplied by any source. We will not be responsible for any damages to underground utilities or structures not located or incorrectly identified by the property owner, any maps, plans or records, or public or private utility locator providers.

We will drill the boring using hollow stem or flite augers, and sampling by the split-barrel method (ASTM: D1586). Our crew will keep field logs noting the methods of drilling and sampling, the Standard Penetration Values (N-values, "blows per foot"), preliminary soil classification, and observed groundwater levels. We will collect samples at 5 and/or 10-foot intervals (determined by you in the field), to the planned termination depth. Representative portions of recovered samples will be sealed in jars to prevent moisture loss and be submitted to our laboratory for review and final classification.

We will backfill the boreholes to comply with State requirements. Even after backfilling, some sloughing of the backfill may occur, resulting in a potential tripping hazard. We assume that the property owner will backfill and repair any boreholes that may slough after our exploration is complete. AET cannot accept any liability associated with injury or loss after we leave the site. Accessing the boring locations may leave ruts in the ground. We assume that the property owner will perform any site restoration work. We have not included a fee for site restoration in our cost estimate.

REPORT

We will provide a brief letter report transmitting a drafted Subsurface Boring Log of the well.

Weather and site access permitting, AET anticipates our field work can be scheduled within 6 to 7 weeks from receiving an authorization to proceed.
