PARENTAL RELEASE AND WAIVER AGREEMENT

KVCT Concepts, Inc. ("KVCT") operates Trapped Toledo, an interactive theater. These activities and events can or could result in injuries to the participant. To be able to participate in these various events, the participant, by executing his or her signature (electronic or otherwise) to this release, does hereby release, waive and discharge KVCT, its officers, members, promoters, owners, employees, or business partners from any and all liability, injuries, or any and all other claims and damages as a result of participating in an event sponsored by KVCT, its officers, members, owners, employees, or business partners. Furthermore, the participant, on behalf of his personal representatives, assigns, heirs, and next of kin, does hereby release any and all claims, damages, injuries, incurred by the participant in regards to the participation in such events. Participant agrees to hereby release any and all claims, of whatever kind of nature, present and future, damages and injuries.

Participant assumes full responsibility for and risk of bodily injury, death or property damage due to negligence or non-negligence of KVCT, its officers, promoters, owners, employees, or business partners in any Trapped Toledo event, and/or while competing, officiating in, working or for any purpose participating in any Trapped Toledo event. The undersigned understands and acknowledges that he/she may not attend, participate in, or act as a spectator or bystander of Trapped Toledo unless he/she is eighteen (18) years of age or older or, if younger than eighteen (18) years of age, his/her parent or legal guardian has read and signed this Release And Waiver Agreement. The undersigned further acknowledges that he/she has inspected the facilities, equipment, and areas to be used for the Trapped Toledo event and is voluntarily participating despite the risk of falls, contact and/or crashes with other participants or actors, defective equipment, the condition of the room and any hazards that may be posed by spectators or volunteers.

Participant, in consideration of being permitted to participate in a Trapped Toledo event and any activities in connection with Trapped Toledo, acknowledges the risks and hazards involved in and arising from the attending, participating in, or as a spectator or bystander, of any event at Trapped Toledo including, but not limited to the additional risks of being hit by flying objects, falling, and does for himself or herself, his or her heirs, executors, administrators, and assigns, release and forever discharge KVCT their officers, members, promoters, sponsors, advertisers, owners, employees, associates, volunteers, paid staff or business partners, their heirs, administrators, and executors, of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident which may occur as a result of participation in a Trapped Toledo event or any activities in connection with a Trapped Toledo event, whether by negligence or non-negligence or from any and all other incidents of harm and / or ill-will.

I comprehend the risks involved with participating as a spectator or participant. I assume all risks associated with participating in the Trapped Toledo event including paralysis and death caused by course and contact with other participants or actors.

Participant further states that he or she has carefully read the above release and knows the contents of the release and signs this release as his or her own free act. Participant further releases, waives, discharges and covenants not to sue all professional services providers from any claim whatsoever on account of first aid, treatment or service rendered him or her during participation in Trapped Toledo or any activities in connection with Trapped Toledo, whether by negligence or not.

I agree by signing this document and participating in a Trapped Toledo Event that I lose my right to sue any and all parties involved with Trapped Toledo including and not limited to the property owners of the location. If any claim is submitted as a result of my conduct as a participant, spectator, or bystander at Trapped Toledo, I agree to defend and indemnify the Released Parties from any and all claims or causes of action by whomever or wherever made or presented as a result of my alleged misconduct as a participant, spectator, or bystander. Moreover, if such claims are made as a result of my conduct, I agree to pay for the legal fees, expenses and costs incurred by the Released Parties in defending such claims against them as a result of my alleged misconduct.
