

# Bloomfield Police Department

## Monthly Report for December 2017

This is the monthly report for the Month of December 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Friday, December 1<sup>st</sup> at approximately 6:45pm officers executed a traffic stop on Nippersink Road for a speeding violation. At the conclusion of the traffic stop a 45-year-old male was arrested for operating a motor vehicle while intoxicated 4<sup>th</sup> offense and confined in the Walworth County Jail. Charges of operating a motor vehicle while intoxicated 4<sup>th</sup> offense, operating after revocation and tampering/failure to install an ignition interlock device have been forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued a citation for the speeding violation.

On Saturday, December 2<sup>nd</sup> at approximately 8:39am officers responded to a residence on Circle Drive for a disorderly male complaint. At the conclusion of the investigation a 42-year-old male was arrested and confined in the Walworth County Jail. Charges of disorderly conduct and criminal damage to property were forwarded to the Walworth County District Attorney's office.

On Sunday, December 3<sup>rd</sup> at approximately 12:13am officers investigated a suspicious vehicle parked in the McKay Park parking lot. At the conclusion of the investigation a 22-year-old male was issued non-traffic citations for possession of marijuana and possession of drug paraphernalia.

On Saturday, December 16<sup>th</sup> at approximately 9:34pm officers executed a traffic stop on Lake Geneva Hwy for a speeding violation. At the conclusion of the traffic stop a 20-year old female was issued traffic citation for the speeding violation and a 20-year-old female passenger was issued a non-traffic citation for possession of drug paraphernalia.

On Wednesday, December 20<sup>th</sup> at approximately 11:00am officers responded to a theft of motor vehicle complaint on Clover Road. At the conclusion of the investigation a 41-year-old female was arrested and confined in the Walworth County Jail. The vehicle was recovered and returned to the owner. A charge of operating a motor vehicle without owner's consent was forwarded to the Walworth County District Attorney's officer.

On Friday, December 22<sup>nd</sup> at approximately 4:14pm officers responded to an address on Hwy U for an intoxicated male complaint. At the conclusion of the investigation a 68-year-old male subject was arrested for operating a motor vehicle while intoxicated 1<sup>st</sup> offense.

On Saturday, December 23<sup>rd</sup> at approximately 6:47pm officers executed a traffic stop on Daisy Drive for a speeding violation. At the conclusion of the traffic stop a 26-year-old female was issued traffic citations for the speeding violation and operating after suspension. Additionally, the female was arrested and confined in the Walworth County Jail for an outstanding body only warrant.

During the month of December 2017 officers from the Bloomfield Police Department affected 6 arrests for warrants issued by the Bloomfield Municipal Court satisfying approximately \$868.00 in outstanding forfeitures.

During the month of December 2017 the Bloomfield Police Department responded to 945 calls for service compared to 777 calls for service during the month of December 2016. During the month of December 2017 the police department affected 140 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 66 arrests during the month of December 2016.
