

Town of Baldwin, Maine SELECTMEN MEETING MINUTES TUESDAY, FEBRUARY 12, 2019, 6:30 P.M.

Attendance: Selectmen: Jeffrey Sanborn, Dwight Warren and Jim Dolloff as well as members of the Public.

1. Selectmen Meeting was called to order approximately at 6:30 PM by Jeffrey Sanborn.

2. Review/ Approve meeting minutes

Jeff Sanborn requested making a motion to accept and approve January 29, 2019 meeting minutes. Jim Dolloff made a motion, Dwight Warren seconded the motion; Selectmen voted 3-0 to approve meeting minutes.

3. Review/ Approve warrant

Jeff Sanborn requested making a motion to accept and approve February 12, 2019 warrant. Jim Dolloff made a motion, Dwight Warren seconded the motion; Selectmen voted 3-0 to approve the warrant.

4. New Business

- David Kane from Longroad Energy presented a proposal to the Selectmen regarding solar panels and leasing town-owned land for the propose of constructing and operating a solar farm. The Selectmen discussed and will forward the proposal to the Town's attorney for review and recommendation.
- The new fire truck that was ordered is delayed in delivery. It will arrive in July 2019.
- Town reports to be mailed out this year. Will post online when they are ready and getting mailed. Last year the Town spent \$2,139.77, this year every resident will get a town report in their mailbox for an estimated price of \$3,323.73. The Selectmen discussed the price increase was worth ensuring every resident got a copy. The Selectmen saved over \$20,000.00 in legal fees last year by utilizing MMA legal services, so a little extra was justified on spending on town reports.

Old Business

- Town report this year is dedicated to Larry Lord, recipient of the 2018 Spirit of America. Selectmen discussed if Larry should read the write-up, Selectmen decided not to so it would be a nice surprise.
- Town report remembrance recipients are Margaret Black, Gene Black and Paul Estes.
- Selectmen discussed and decided to publish a reserve account summary in the town report reporting the current balance of each reserve account.
- Selectmen voted 3-0 to appoint Suzzette Olafsen as an alternate member of the Planning Board.
- Selectmen voted 3-0 and signed the supplementals and certificates prepared by Cumberland County Assessing.
