In a gesture of consideration and community solidarity, we kindly ask that everyone conclude their firework displays by 10 PM (Please refer to the City of Albany's Municipal Code 7.08.050). This small adjustment in our celebrations can make a significant difference in ensuring that the 4th of July remains a joyous occasion for all members of our community. Thank you!

APD's Safe Return Program

The Albany Policy Department offers a voluntary photo-based program to aid officers during interactions with someone who may have difficulty communicating due to a disability. Through The Safe Return Program, caregivers can provide critical information such as descriptions, photographs, emergency contact numbers, and other important details that officer might require to ensure any encounters with vulnerable individuals is handled with sensitivity and understanding. https://albanyoregon.gov/police/programs/safereturn

Albany Fire Dept Defensible Space Project

The Albany Fire Dept's Defensible Space Project is designed reduce possible fuel for wildfires. This will help protect our homes and protect first responders if a fire were to start. A 100-foot barrier would be created by removing underbrush, dead trees, invasive bushes, and plants (ex. blackberries and poison oak). The City Forester will be working with the Calapooia Watershed to protect native plants, and they will not disturb nests or other wildlife habitats. This project is being funded by a state grant.

The project is expected to be completed in phases. The first phase, is planned to be the area to the west of the subdivision from about the end of Cougar going north to Moose Run. At this time, the east side of the neighborhood hasn't been scheduled.

Basketball Hoops

This is a reminder that basketball hoops should only be placed on your private property. Hoops that are in the street, or on the sidewalk, create hazards for drivers and pedestrians. They can create issues with the water not draining correctly from the street, along with complications during the City's leaf removal and street cleaning.

Tree Trimming

Many of us have trees that hang over a street or sidewalk. As part of keeping the sidewalks clear, the City also requires that trees should be trimmed periodically to ensure there is a clear path for pedestrians and prevent injuries. Below are the requirements provided by the City.

- Sidewalks: Trees should be trimmed 8 feet above the height of the sidewalk
- Streets: Trees should be trimmed 14 feet above the height of the street

Architectural Changes

Please remember that making visible changes to your home or property might require Board approval. This includes exterior paint, major structural changes to the interior, etc. If you're planning any projects, please take a moment to review the Architectural Change requirements detailed in the CC&Rs.
