Monthly Report for February 2019

This is the monthly report for the Month of February 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Saturday, February 2nd at approximately 1:33am officers executed a traffic stop on Hwy 50 for a traffic violation. At the conclusion of the traffic stop a 21-year-old male driver was issued traffic citations for a speed violation and operating a motor vehicle without insurance. Additionally, the driver was issued a non-traffic citation for possession of drug paraphernalia.

On Thursday, February 7th at approximately 7:17am officers responded to a single vehicle property damage only crash on Hwy 12 in the area of Pell Lake Drive. At the conclusion of the investigation a 31-year-old male was issued a traffic citation for driving too fast for conditions.

On Thursday, February 7th at approximately 5:15pm officers responded to an illegal dumping complaint at the Blue Top motel. At the conclusion of the investigation a 46-year-old male was issued a non-traffic citation for littering.

On Friday, February 8th at approximately 11:31pm officers executed a traffic stop in the area of Pell Lake Drive and Orchid for a traffic violation. At the conclusion of the traffic stop a 21-year-old female was issued traffic citations for disorderly conduct with a motor vehicle, operating without insurance and operating after suspension.

On Sunday, February 10th at approximately 12:39am officers executed a traffic stop in the area of Pell Lake Drive and Daisy Drive for a traffic violation. At the conclusion of the traffic stop a 40-year-old female was issued traffic citations for no tail lamp/defective tail lamp at night and operating a motor vehicle without insurance. Additionally, the female was issued a non-traffic citation for possession of marijuana.

On Tuesday, February 12th at approximately 7:07pm officers responded to the area of Hwy 120 and Bloomfield Road for a single property damage only crash. At the conclusion of the investigation a 32-year-old male driver was issued a traffic citation for driving too fast for conditions.

On Wednesday, February 13th at approximately 7:12am officers responded to the area of Hwy H and Schaitel Road for a two vehicle property damage only crash. At the conclusion of the investigation a 16-year-old female was issued traffic citations for automobile following too closely, driving too fast for conditions, motor vehicle windows not reasonably clean and operating a motor vehicle without insurance.

On Friday, February 15th at approximately 9:22am officers responded to a residence on Center Drive for a burglary complaint. The complainant reported an All-Terrain Vehicle (ATV) and miscellaneous tools were stolen from an unlocked pole barn type building. Additional information surrounding this incident has been intentionally withheld as the incident remains under investigation.

On Friday, February 15th at approximately 10:52pm officers responded to the area of Hwy U and Twin Lakes Road for a two vehicle property damage only crash. At the conclusion of the investigation a 17-year-old female was issued a traffic citation for failure/yield while making a left turn.

On Saturday, February 16th at approximately 12:40pm officers responded to the area of Chestnut Road and Hwy H for a vehicle stuck in the ditch. At the conclusion of the investigation a 20-year-old female was issued a citation for operating after suspension.

On Wednesday, February 20th at approximately 10:20am officers received a theft complaint which occurred in the 100 block of Rosewood Rd. at the conclusion of the investigation 45-year-old female was issued a non-traffic citation for theft-movable property.

During the month of February 2019, the Bloomfield Police Department responded to 721 calls for service compared to 866 calls for service during the month of February 2018. During the month of February 2019, the police department affected 91 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 144 arrests during the month of February 2018.
