Life Patterns Lowdown

Post-COVID Exceptions

Once the State has ended their COVID Exceptions, our policies and procedures will return to normal. A few things to keep in mind, once the exceptions have ended:

- All workers combined will have to stay within 12 hours per day.
- Parents of TA Waiver individuals will no longer be eligible to be workers.
- Anyone living in the same home as a PD or TA Waiver individual will no longer be eligible to be workers.
- Parents of IDD Waiver individuals that are under the age of 18 will no longer be eligible to be workers.
- Siblings under the age of 18, of individuals on the IDD Waiver, will no longer be eligible to be workers.
- Workers will need to clear all background checks prior to being eligible to work.

These are few things to keep in mind, as you may need to hire more workers. We will do our best to keep everyone updated on when the COVID exceptions will end, through our website and our newsletter.

HCBS IDD Waiver July Rate Increase

As mentioned in May's newsletter, the State of Kansas has granted a rate increase for HCBS IDD waiver services. As the employer, you have the choice to increase your worker's rate of pay. If you would like to increase your employees' pay, you **MUST** complete a new Employment Agreement form. If you did the June increase, you will need to complete another agreement for the July increase.

July Pay Ranges:

- IDD PCS (no family relationship): \$7.25-\$10.90
- IDD PCS (natural or adoptive parents): \$7.25-\$11.75
- IDD ECS & Overnight Respite: \$43.50-\$80.50

ISP CHANGES FOR SCHOOL YEAR!!

With school starting soon, it is likely that the amount of authorized hours may be decreasing. Please review the ISP/Plan of Care from your Managed Care Organization (MCO) to see how many hours are authorized. If you have any questions about the ISP or how many hours are authorized, please call your Life Patterns office and we can help you as well.

**Reminder: Workers cannot be clocked in while the participant is in school. "Personal Care Services (PCS) cannot be provided in a school setting and cannot be used for education, as a substitute for educationally related services, or for transition services as outline in the participant's ISP."
