Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). ## 7. HANDLING AND STORAGE

**PRECAUTIONS FOR SAFE HANDLING:** Put on appropriate personal protective equipment (see Section 8). Avoid exposure - obtain special instructions before use. 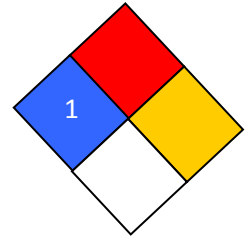
