Coming to Hope as I did, I never knew who was a visitor, or who was a member. I don't really know who came back after a time away, and who never left. I now know that Hope, like churches all over the world, saw church attendance fall off because of Covid. And there is a struggle to get back.

If you are only able to attend via the radio or tv, or the internet, I understand. It can be hard to get ready and get to church. Some need a

long runway in the morning to be ready and come. And for some that is not going to happen. We love you and we understand.

For some, the habit of, what? Four or five years plus? That habit is hard to break. Know, as well, that we love you and we understand that new habits are hard to establish. But give it a try. Come for a Sunday. Say hi to me, the new pastor. We would love to see you there. We need to be together. In church. In the Word. At the Lord's table (on the 2nd and 3rd Sundays of the month).

And if you know someone who hasn't made it back yet, extend to them an invitation to come. Shoot them a text. Give them a call. DM them on FaceTok or TikBook. (I have NO idea what any of that means...) Give them a ride. Go out for brunch together afterward. We need each other, and your's could be the invitation someone needs to get back to church, or to get to Hope for the first time. It's a Jesus thing you can do.

Thanks to all for your support of Hope Lutheran Church. And thank you for the kind welcome extended to me. I look forward to what this year will bring, and I am glad we are in this life together.

I wish to thank all of those who are currently on the Call Committee for their time and perseverance - God has a plan for our congregation, and with patience and prayer that plan will be revealed. We are very fortunate to have found Pastor Peter Lurvey to act as our Interim Pastor. He travels from Winnipeg each week to minister to us. He brings a lot of enthusiasm to our worship. Pastor Peter has agreed to pastor us for another year, thanks be to God. Pastor Peter holds office hours weekdays Wednesday-Friday between 9 and 3, and also by appointment. I am very thankful for our church council members. Many plans were carried out by the council members to benefit the congregation including: Valentine's Dinner for widows and widower's, Sunday School, confirmation, VBS, and Lenten services with soup and sandwich. We also increased the number of Sundays we serve communion. In addition, this past year we have finished much of the outdoor work on the church and parsonage buildings. The cement retaining wall was completed with a nice stone facade and the water flow from the roof diverted so that we will hopefully have less ice and washouts. A wonderful donation allowed us to replace the landscape rock, and plantings will be done in the spring. All of the work to preserve our buildings was done by volunteers, or using funds from designated funds, not our general fund.

We have tried hard to economize, given the increased costs of just about everything. In an effort to economize more, the Trustees have decided to reduce the amount of paid employee hours and replace them with volunteers. We are grateful for the time and energy that Steve, our custodian, and Tammie, our office manager have committed over the past several years. However, in an effort to economize, they will be working only half time in 2025. Tammie will most likely be in the office on Mondays and Wednesdays. Volunteers will be needed for office work and some of the building and grounds maintenance. Start thinking about how YOU can help to cover some of their duties. 2024 Trustees Report

The duties of the board of Trustees include supervising the incoming and outgoing monies of the church and overseeing the maintenance of Hope church properties.

Total income for the 2024 financial year was \$195,269.90, with total expenses at \$206,053.33 for the year—showing a deficit of \$10,783.43. Total income for the year was up approximately \$10,800.00 over last year, with expenses also showing an increase of roughly \$42,000.00 from 2023. The main driver of the increase in spending was the addition of the pastor salary, which we did not have as an expense for most of 2023.

Some overdue and needed improvements to the outside of the church were completed this year. The retaining wall was completed with the installation of decorative stone facing on the front of the wall with new railings on the steps. New carpet was also installed on the steps leading up to the main church entrance.

The sidewalk, step and corner area by the entrance to the church office was also in need of some work. New cement was poured to repair the bottom step, and also the corner of that entrance which had some drainage issues. Part of the sidewalk was also repaired during this project. New carpet was purchased for the steps and will be installed in the spring. A generous donation of landscape rock from Olson sand and gravel was installed in this area, and also on the South side of the main entrance to the church.

This fall the bushes between the church and parsonage along the parking lot were removed and leveled out. The parsonage also had some heating and appliance issues this year but most were able to be resolved.

With our church and parsonage aging, it is an ongoing battle to keep up on maintenance and repairs. We undoubtably will have more maintenance costs in the upcoming year—including the likely replacement of the church's furnaces. We pray that our congregation will continue their generous giving to keep our church and parsonage maintained and looking their best.

The Trustees would also like to offer sincere thanks to all the staff at Hope. Tammie for her work in the office, Chuck for handling the financials, and Steve for all the work he does in and around the church—and to the countless others who donate their time and talents whenever asked--Thanks to you all!

Finally, we would like to thank the Hope Church council and all of the committees for their hard work throughout the year. We are very lucky to have the dedicated volunteers we have here at Hope. Also, a sincere thank you to all the board of Trustee members for everything they do, and for all the extra hours put in behind the scenes that often goes unnoticed.
