**Product Availability/Pricing Guarantee:** Spring Brochures retire 06/30/16 and require payment by 06/30/16. Fall Brochures retire 12/31/16 and require payment by 12/31/16.

**Samples, Late Orders:** No product minimum required. Regular pricing applies for samples and late orders, \$12.00 shipping fee applies.

**Shipping:** Shipping is free on all orders with 25 or more items. If an order has less than 25 items a \$12 shipping fee is added. Shipping rates are subject to change. All orders are shipped UPS. There are no additional fees for pack by seller. Pack-by-seller is eligible when selling 300 or more items.

**Payments:** Customer checks are made payable to your organization. A single payment by Money Order, Business, or School Check will be accepted for your purchase. Personal checks, temporary checks, checks with hand-written group/business names can't be accepted. Credit cards and purchase orders are not accepted.

**Delivery:** Products are generally delivered within 2 weeks. Pack-by-seller orders may require a few additional days to process. Orders will be processed upon receipt of payment.

**Check-In Forms:** Replacements for missing or broken items will be shipped only when a fully completed Check-In Form has been submitted within 72 hours. Phone calls or emails alone WILL NOT be accepted. No exceptions. Organization will be responsible for the accuracy of the total number of items sold and ordered.

**Sales Agreement:** MUST be returned to Deb Murray prior to distributing your brochures. I have read, understand and agree with the terms and conditions listed above and have received approval from my organization (school principal, board members etc.) to sign on behalf of my organization.
