- Robert's Rules Zoom Workshop hosted by Area 59 Chairperson, monthly on Sunday nights
- Monthly GSR forum beginning hosted by our Alternate Delegate Alex N.
- EPGSA
  - Needs volunteers
  - Lowered cost by \$20 this year to foster convention participation
  - We will be visited as soon as next month by a member of the Convention Committee
- Treatment & Accessibilities
  - 2026 Bilingual Share-A-Day
  - Voted to give \$100 to the All-Access Committee
  - Working to merge the Treatment portion of our subcommittee with Corrections
- Archives
  - Submitting District Meeting Minutes to Area 59 Officers and the Archivist.
- Delegate Report
  - Email sent to the District with the results of the 75th General Service
     Conference

### DCM Actions:

- District 63 (Olivia A.)
  - Wanted feedback regarding how much/little control GSR's have over their district meeting's agenda. Feedback received:
    - GSRs generally do not contribute to the agenda, other than in "new business".
    - One DCM created an open document that all GSRs have access to for submitting new ideas/new business
  - Received feedback from a homegroup member that including PENNSCYPAA in the DCM report was inappropriate, as PENNSCYPAA is not part of the general service structure. Wanted to check in with other DCM's/Area Officers to see what their thoughts were on this. Feedback received:
    - Resounding answer of "no, it is not inappropriate to have this on the agenda/announcements".

### Andrew Douventzidis

- Wanted feedback regarding whether other groups have financed their
   GSRs EPGSA registration tickets. Feedback received:
  - A few strongly against
  - Previously scholarshipped day passes (the \$20 ticket) as opposed to the entire stay.
  - Previously scholarshipped at a flat rate (\$100, \$150, etc).
  - Previously scholarshipped day passes if the GSR was in their seat and voting.

### Tom Wetzel

- Wanted feedback regarding concerns raised by a women's group a transgender woman was either attending or wanted to join their homegroup.
- Feedback:
  - All alcoholics are welcome.

- Their district has received calls from Bridging the Gap to connect recently released inmates/treatment goers, but they are addicts with no alcohol problem. Feedback received:
  - Speak with the facility referring them to re-review what the BTG program is and who it is for.
  - Go to an open NA meeting and get a few people's numbers who are willing to serve as a contact in case this happens again.
- Inocencio Cruz (D68)
  - Wanted feedback regarding what to do about La Viña subscribers not receiving their magazines in over a year. Feedback:
    - La Viña Committee Chair has reached out twice once with no response, currently waiting on a response from the second contact.
    - Delegate will reach out to his contacts to see if they are able to provide any insights.

### **New Business**

- Guest observer at EPGSA will be Judge Robert Pepard.
- T&A Font Recommendation passed unanimously
  - Bring this back to the District to vote on. Because it is a structure change, we need the groups' approval. A final vote will happen at the next quarterly meeting.
